## Re: Support for the "Every Student Succeeds Act"

Dear Speaker Ryan and Democratic Leader Pelosi:

The National School Boards Association (NSBA), representing more than 90,000 local school board members across the nation, working with and through our state associations, supports passage of the "Every Student Succeeds Act," and applauds the work of the Conference Committee for its bipartisan effort to modernize the *Elementary and Secondary Education Act* (ESEA). Chairman John Kline and Senior Democratic Member Bobby Scott have led the process in the House to develop legislation that will positively affect the educational outcomes of

our nation's 50 million public school students, the performance of our more than 13,000 public school districts, and the success of both our communities and our nation. We urge your support for the passage of the "Every Student Succeeds Act."

School board members are encouraged by the diligence of House and Senate education committee leaders to achieve a complete modernization for ESEA that will supersede the current waiver system, which was administered in lieu of reauthorization. The legislation addresses key concerns for school boards: local governance and flexibility that support innovative programs and effectiveness for continued gains in student achievement among all students.

These provisions strengthen all levels of support for our nation's students and public school districts-a welcome change from the current law and its unintended consequences and uncertainty for school districts. Moreover, provisions for local governance, Title I grants for disadvantaged students, maintenance of effort (MOE), and authorization of appropriations that reflect the budgetary allocations of the recent *Bipartisan Budget Act of 2015* address several of the policy positions adopted by NSBA's Delegate Assembly.

We are now closer than we have ever been in the last eight years to producing a new law that addresses both equity and excellence to help our school boards provide the high-quality public education that all our children deserve and need to be successful adults and citizens.

Thank you, as well as Chairman Kline and Senior Democratic Member Scott, for leading this historic reauthorization for a modernized *Elementary and Secondary Education Act*.
