

**AMENDMENT TO THE AMENDMENT IN THE  
NATURE OF A SUBSTITUTE TO H.R. 4508  
OFFERED BY MS. FUDGE OF OHIO**

In section 488(f)(1), insert before subparagraph (A) the following:

- 1                   (A) in paragraph (1)(F)—
- 2                   (i) in clause (i), by striking “and” at
- 3                   the end;
- 4                   (ii) in clause (ii), by striking “and” at
- 5                   the end;
- 6                   (iii) in clause (iii), by striking the pe-
- 7                   riod at the end and inserting “; and”; and
- 8                   (iv) by adding at the end the fol-
- 9                   lowing:
- 10                  “(iv) of hazing incidents that were re-
- 11                  ported to campus security authorities or local
- 12                  police agencies.”;

In section 488(f)(1), insert before subparagraph (B) the following:

- 13                   (B) in paragraph (6)(A), by adding at the
- 14                   end the following:

1           “(vi) The term ‘hazing’ means any inten-  
2           tional, knowing, or reckless act committed by a  
3           student, or a former student, of an institution  
4           of higher education, whether individually or in  
5           concert with other persons, against another stu-  
6           dent, that—

7                   “(I) was committed in connection with  
8                   an initiation into, an affiliation with, or  
9                   the maintenance of membership in, any or-  
10                  ganization that is affiliated with such insti-  
11                  tution of higher education; and

12                   “(II) contributes to a substantial risk  
13                   of physical injury, mental harm, or deg-  
14                   radation or causes physical injury, mental  
15                   harm or personal degradation.”;

16                  (C) in paragraph (7), by inserting after the  
17                  second sentence the following: “For hazing inci-  
18                  dents, such statistics shall be compiled in ac-  
19                  cordance with the definition of that term in  
20                  paragraph (6)(A)(vi).”

Section 491 is amended by inserting after subsection  
(j) the following:

21                  (k) EDUCATIONAL PROGRAM ON HAZING.—Section  
22                  487(a) of the Higher Education Act of 1965 (20 U.S.C.  
23                  1094(a)) is amended by adding at the end the following:

1           “(30) The institution will provide students with  
2           an educational program on hazing (as that term is  
3           defined in section 485(f)(6)(A)(vi)), which shall in-  
4           clude information on hazing awareness, hazing pre-  
5           vention, and institution’s policies on hazing.”.

Section 491(m)(1)(C) is amended by striking “para-  
graphs (25) through (29) as paragraphs (22) through  
(26)” and inserting “paragraphs (25) through (30) as  
paragraphs (22) through (27)”.
