Dear Commissioner Jett:

On April 24, 2024, the first trial began for seven defendants associated with the Minnesota-based nonprofit Feeding Our Future (FOF) for their part in defrauding the U.S. Department of Agriculture's (USDA) Federal Child Nutrition Program (FCNP) of over \$250 million in taxpayer money. As of today, the U.S. Attorney has charged 70 individuals with federal crimes for benefiting personally from an illegal scheme that diverted \$250 million of FCNP funds away from feeding hungry children. Of the 70 individuals charged, 18 have pleaded guilty, one has fled the country and one has died.

We write today to request additional information as we continue our oversight of the USDA's and the Minnesota Department of Education's (MDE) administration of the FCNP and oversight of FOF. Your January 5, 2024, document production to Minnesota's Office of the Legislative Auditor has led to additional inquiries regarding the USDA's and the MDE's involvement in the "largest COVID-19 fraud scheme in the nation."

The Committees on Agriculture, Education and the Workforce, and Oversight and Accountability have jurisdiction under Rule X of the Rules of the House of Representatives to conduct oversight of these matters.⁵

To gain a better understanding of the MDE's actions surrounding the fraud scheme, we request that the MDE produce the following documents **from February 1, 2020, to December 3, 2023,** and provide sufficient responses to the following requests (instructions attached) no later than June 26, 2024 (two weeks from the date of this letter):

- 1. All communications between the MDE staff regarding FOF and/or FOF sites.
- 2. All communications between the MDE staff regarding Partners in Nutrition (PIN) and/or PIN sites.
- 3. All communications between the MDE staff regarding Partners in Quality Care (PIQC) and/or PIQC sites.
- 4. All communications between the MDE staff and the Federal Bureau of Investigation (FBI) regarding FOF and/or FOF sites.
- 5. All communications between the MDE staff and the FBI regarding PIN and/or PIN sites.
- 6. All communications between the MDE staff and the FBI regarding PIQC and/or PIQC sites.
- 7. All documents the MDE provided to the FBI regarding FOF and/or FOF sites.
