15	Section 1111 (20 U.S.C. 6311) is amended to read
16	as follows:
17	"SEC. 1111. STATE PLANS.
18	"(a) Plans Required.—
19	"(1) In General.—For any State desiring to
20	receive a grant under this subpart, the State edu-
21	cational agency shall submit to the Secretary a plan,
22	developed by the State educational agency, in con-
23	sultation with local educational agencies, teachers,
24	school leaders, public charter school representatives,
25	specialized instructional support personnel, other ap-
26	propriate school personnel, parents, private sector

1	employers, and entrepreneurs, that satisfies the re-	
2	quirements of this section and that is coordinated	
3	with other programs under this Act, the Individuals	
4	with Disabilities Education Act, the Carl D. Perkins	
5	Career and Technical Education Act of 2006, the	
6	Head Start Act, the Adult Education and Family	
7	Literacy Act, and the McKinney-Vento Homeless	
8	Assistance Act.	
9	"(2) Consolidated Plan.—A State plan sub-	
10	mitted under paragraph (1) may be submitted as	
11	part of a consolidated plan under section 6302.	
12	"(b) Academic Standards, Academic Assess-	
13	MENTS, AND STATE ACCOUNTABILITY.—	
14	"(1) Academic standards.—	
15	"(A) IN GENERAL.—Each State plan shall	
16	demonstrate that the State has adopted aca-	
17	demic content standards and academic achieve-	
18	ment standards aligned with such content	
19	standards that comply with the requirements of	
20	this paragraph.	
21	"(B) Subjects.—The State shall have	
22	such academic standards for mathematics, read-	
23	ing or language arts, and science, and may have	
24	such standards for any other subject deter-	
25	mined by the State.	

1	"(C) REQUIREMENTS.—The standards de-
2	scribed in subparagraph (A) shall—
3	"(i) apply to all public schools and
4	public school students in the State; and
5	"(ii) with respect to academic achieve-
6	ment standards, include the same knowl-
7	edge, skills, and levels of achievement ex-
8	pected of all public school students in the
9	State.
10	"(D) ALTERNATE ACADEMIC ACHIEVE-
11	MENT STANDARDS.—Notwithstanding any other
12	provision of this paragraph, a State may,
13	through a documented and validated standards-
14	setting process, adopt alternate academic
15	achievement standards for students with the
16	most significant cognitive disabilities, if—
17	"(i) the determination about whether
18	the achievement of an individual student
19	should be measured against such standards
20	is made separately for each student; and
21	"(ii) such standards—
22	"(I) are aligned with the State
23	academic standards required under
24	subparagraph (A);

1	"(II) promote access to the gen-
2	eral curriculum; and
3	"(III) reflect professional judg-
4	ment as to the highest possible stand-
5	ards achievable by such students.
6	"(E) ENGLISH LANGUAGE PROFICIENCY
7	STANDARDS.—Each State plan shall describe
8	how the State educational agency will establish
9	English language proficiency standards that
10	are—
11	"(i) derived from the four recognized
12	domains of speaking, listening, reading,
13	and writing; and
14	"(ii) aligned with the State's academic
15	content standards in reading or language
16	arts under subparagraph (A).
17	"(2) Academic assessments.—
18	"(A) IN GENERAL.—Each State plan shall
19	demonstrate that the State educational agency,
20	in consultation with local educational agencies,
21	has implemented a set of high-quality student
22	academic assessments in mathematics, reading
23	or language arts, and science. At the State's
24	discretion, the State plan may also demonstrate

1	that the State has implemented such assess-
2	ments in any other subject chosen by the State.
3	"(B) Requirements.—Such assessments
4	shall—
5	"(i) in the case of mathematics and
6	reading or language arts, be used in deter-
7	mining the performance of each local edu-
8	cational agency and public school in the
9	State in accordance with the State's ac-
10	countability system under paragraph (3);
11	"(ii) be the same academic assess-
12	ments used to measure the academic
13	achievement of all public school students in
14	the State;
15	"(iii) be aligned with the State's aca-
16	demic standards and provide coherent and
17	timely information about student attain-
18	ment of such standards;
19	"(iv) be used for purposes for which
20	such assessments are valid and reliable, be
21	of adequate technical quality for each pur-
22	pose required under this Act, and be con-
23	sistent with relevant, nationally recognized
24	professional and technical standards;

1	``(v)(I) in the case of mathematics
2	and reading or language arts, be adminis-
3	tered in each of grades 3 through 8 and at
4	least once in grades 9 through 12;
5	"(II) in the case of science, be admin-
6	istered not less than one time during—
7	"(aa) grades 3 through 5;
8	"(bb) grades 6 through 9; and
9	"(cc) grades 10 through 12; and
10	"(III) in the case of any other subject
11	chosen by the State, be administered at the
12	discretion of the State;
13	"(vi) measure individual student aca-
14	demic proficiency and, at the State's dis-
15	cretion, growth;
16	"(vii) at the State's discretion—
17	"(I) be administered through a
18	single annual summative assessment;
19	or
20	"(II) be administered through
21	multiple assessments during the
22	course of the academic year that re-
23	sult in a single summative score that
24	provides valid, reliable, and trans-

1	parent information on student
2	achievement;
3	"(viii) include measures that assess
4	higher-order thinking skills and under-
5	standing;
6	"(ix) provide for—
7	"(I) the participation in such as-
8	sessments of all students;
9	"(II) the reasonable adaptations
10	and accommodations for students with
11	disabilities necessary to measure the
12	academic achievement of such stu-
13	dents relative to the State's academic
14	standards; and
15	"(III) the inclusion of English
16	learners, who shall be assessed in a
17	valid and reliable manner and pro-
18	vided reasonable accommodations, in-
19	cluding, to the extent practicable, as-
20	sessments in the language and form
21	most likely to yield accurate and reli-
22	able information on what such stu-
23	dents know and can do in academic
24	content areas, until such students
25	have achieved English language pro-

1	ficiency, as assessed by the State
2	under subparagraph (D);
3	"(x) notwithstanding clause (ix)(III),
4	provide for the assessment of reading or
5	language arts in English for English learn-
6	ers who have attended school in the United
7	States (not including Puerto Rico) for 3 or
8	more consecutive school years, except that
9	a local educational agency may, on a case-
10	by-case basis, provide for the assessment of
11	reading or language arts for each such stu-
12	dent in a language other than English for
13	a period not to exceed 2 additional con-
14	secutive years if the assessment would be
15	more likely to yield accurate and reliable
16	information on what such student knows
17	and can do, provided that such student has
18	not yet reached a level of English language
19	proficiency sufficient to yield valid and reli-
20	able information on what such student
21	knows and can do on reading or language
22	arts assessments written in English;
23	"(xi) produce individual student inter-
24	pretive, descriptive, and diagnostic reports
25	regarding achievement on such assess-

1	ments that allow parents, teachers, and
2	school leaders to understand and address
3	the specific academic needs of students,
4	and that are provided to parents, teachers
5	and school leaders, as soon as is prac-
6	ticable after the assessment is given, in an
7	understandable and uniform format, and
8	to the extent practicable, in a language
9	that parents can understand;
10	"(xii) enable results to be
11	disaggregated within each State, local edu-
12	cational agency, and school by gender, by
13	each major racial and ethnic group, by
14	English language proficiency status, by mi-
15	grant status, by status as a student with
16	a disability, and by economically disadvan-
17	taged status, except that, in the case of a
18	local educational agency or a school, such
19	disaggregation shall not be required in a
20	case in which the number of students in a
21	category is insufficient to yield statistically
22	reliable information or the results would
23	reveal personally identifiable information
24	about an individual student;

1	"(xiii) be administered to not less
2	than 95 percent of all students, and not
3	less than 95 percent of each subgroup of
4	students described in paragraph
5	(3)(B)(ii)(II); and
6	"(xiv) where practicable, be developed
7	using the principles of universal design for
8	learning as defined in section 103(24) of
9	the Higher Education Act of 1965 (20
10	U.S.C. 1003(24)).
11	"(C) ALTERNATE ASSESSMENTS.—A State
12	may provide for alternate assessments aligned
13	with the alternate academic standards adopted
14	in accordance with paragraph (1)(D), for stu-
15	dents with the most significant cognitive dis-
16	abilities, if the State—
17	"(i) establishes and monitors imple-
18	mentation of clear and appropriate guide-
19	lines for individualized education program
20	teams (as defined in section $614(d)(1)(B)$
21	of the Individuals with Disabilities Edu-
22	cation Act) to apply when determining
23	when a child's significant cognitive dis-
24	ability justifies assessment based on alter-
25	nate achievement standards;

1	"(ii) ensures that the parents of such
2	students are informed that—
3	"(I) their child's academic
4	achievement will be measured against
5	such alternate standards; and
6	"(II) whether participation in
7	such assessments precludes the stu-
8	dent from completing the require-
9	ments for a regular high school di-
10	ploma;
11	"(iii) demonstrates that such students
12	are, to the extent practicable, included in
13	the general curriculum and that such alter-
14	nate assessments are aligned with such
15	curriculum;
16	"(iv) develops, disseminates informa-
17	tion about, and promotes the use of appro-
18	priate accommodations to increase the
19	number of students with disabilities who
20	are tested against academic achievement
21	standards for the grade in which a student
22	is enrolled; and
23	"(v) ensures that regular and special
24	education teachers and other appropriate
25	staff know how to administer the alternate

1	assessments, including making appropriate
2	use of accommodations for students with
3	disabilities.
4	"(D) Assessments of english lan-
5	GUAGE PROFICIENCY.—
6	"(i) In general.—Each State plan
7	shall demonstrate that local educational
8	agencies in the State will provide for an
9	annual assessment of English proficiency
10	of all English learners in the schools
11	served by the State educational agency.
12	"(ii) Alignment.—The assessments
13	described in clause (i) shall be aligned with
14	the State's English language proficiency
15	standards described in paragraph $(1)(E)$.
16	"(E) LANGUAGE ASSESSMENTS.—Each
17	State plan shall identify the languages other
18	than English that are present in the partici-
19	pating student population and indicate the lan-
20	guages for which yearly student academic as-
21	sessments are not available and are needed.
22	The State shall make every effort to develop
23	such assessments and may request assistance
24	from the Secretary if linguistically accessible
25	academic assessment measures are needed

1	Upon request, the Secretary shall assist with
2	the identification of appropriate academic as-
3	sessment measures in the needed languages, but
4	shall not mandate a specific academic assess-
5	ment or mode of instruction.
6	"(F) Adaptive assessments.—A State
7	may develop and administer computer adaptive
8	assessments as the assessments required under
9	subparagraph (A). If a State develops and ad-
10	ministers a computer adaptive assessment for
11	such purposes, the assessment shall meet the
12	requirements of this paragraph, except as fol-
13	lows:
14	"(i) Notwithstanding subparagraph
15	(B)(iii), the assessment—
16	"(I) shall measure, at a min-
17	imum, each student's academic pro-
18	ficiency against the State's academic
19	standards for the student's grade level
20	and growth toward such standards;
21	and
22	"(II) if the State chooses, may be
23	used to measure the student's level of
24	academic proficiency and growth
25	using assessment items above or below

1	the student's grade level, including for
2	use as part of a State's accountability
3	system under paragraph (3).
4	"(ii) Subparagraph (B)(ii) shall not
5	be interpreted to require that all students
6	taking the computer adaptive assessment
7	be administered the same assessment
8	items.
9	"(3) State accountability systems.—
10	"(A) IN GENERAL.—Each State plan shall
11	demonstrate that the State has developed and is
12	implementing a single, statewide accountability
13	system to ensure that all public school students
14	graduate from high school prepared for postsec-
15	ondary education or the workforce without the
16	need for remediation.
17	"(B) Elements.—Each State account-
18	ability system described in subparagraph (A)
19	shall at a minimum—
20	"(i) annually measure the academic
21	achievement of all public school students in
22	the State against the State's mathematics
23	and reading or language arts academic
24	standards adopted under paragraph (1),
25	which may include measures of student

1	growth toward such standards, using the
2	mathematics and reading or language arts
3	assessments described in paragraph (2)(B)
4	and other valid and reliable academic indi-
5	cators related to student achievement as
6	identified by the State;
7	"(ii) annually evaluate and identify
8	the academic performance of each public
9	school in the State based on—
10	"(I) student academic achieve-
11	ment as measured in accordance with
12	clause (i);
13	$``(\Pi)$ the overall performance,
14	and achievement gaps as compared to
15	all students in the school, for eco-
16	nomically disadvantaged students, stu-
17	dents from major racial and ethnic
18	groups, students with disabilities, and
19	English learners, except that
20	disaggregation of data under this sub-
21	clause shall not be required in a case
22	in which the number of students in a
23	category is insufficient to yield statis-
24	tically reliable information or the re-
25	sults would reveal personally identifi-

1	able information about an individual
2	student; and
3	"(III) other measures of school
4	success; and
5	"(iii) include a system for school im-
6	provement for low-performing public
7	schools receiving funds under this subpart
8	that—
9	"(I) implements interventions in
10	such schools that are designed to ad-
11	dress such schools' weaknesses; and
12	"(II) is implemented by local
13	educational agencies serving such
14	schools.
15	"(C) Prohibition.—Nothing in this sec-
16	tion shall be construed to permit the Secretary
17	to establish any criteria that specifies, defines,
18	or prescribes any aspect of a State's account-
19	ability system developed and implemented in ac-
20	cordance with this paragraph.
21	"(D) Accountability for charter
22	SCHOOLS.—The accountability provisions under
23	this Act shall be overseen for charter schools in
24	accordance with State charter school law.

1	"(4) Requirements.—Each State plan shall
2	describe—
3	"(A) how the State educational agency will
4	assist each local educational agency and each
5	public school affected by the State plan to com-
6	ply with the requirements of this subpart, in-
7	cluding how the State educational agency will
8	work with local educational agencies to provide
9	technical assistance; and
10	"(B) how the State educational agency will
11	ensure that the results of the State assessments
12	described in paragraph (2), the other indicators
13	selected by the State under paragraph
14	(3)(B)(i), and the school evaluations described
15	in paragraph (3)(B)(ii), will be promptly pro-
16	vided to local educational agencies, schools,
17	teachers, and parents in a manner that is clear
18	and easy to understand, but not later than be-
19	fore the beginning of the school year following
20	the school year in which such assessments,
21	other indicators, or evaluations are taken or
22	completed.
23	"(5) Timeline for implementation.—Each
24	State plan shall describe the process by which the
25	State will adopt and implement the State academic

1	standards, assessments, and accountability system
2	required under this section within 2 years of enact-
3	ment of the Student Success Act.
4	"(6) Existing standards.—Nothing in this
5	subpart shall prohibit a State from revising, con-
6	sistent with this section, any standard adopted
7	under this section before or after the date of enact-
8	ment of the Student Success Act.
9	"(7) Existing state law.—Nothing in this
10	section shall be construed to alter any State law or
11	regulation granting parents authority over schools
12	that repeatedly failed to make adequate yearly
13	progress under this section, as in effect on the day
14	before the date of the enactment of the Student Suc-
15	cess Act.
16	"(c) Other Provisions To Support Teaching
17	AND LEARNING.—Each State plan shall contain assur-
18	ances that—
19	"(1) the State will notify local educational
20	agencies, schools, teachers, parents, and the public
21	of the academic standards, academic assessments,
22	and State accountability system developed and im-
23	plemented under this section;
24	"(2) the State will participate in biennial State
25	academic assessments of 4th and 8th grade reading

1	and mathematics under the National Assessment of
2	Educational Progress carried out under section
3	303(b)(2) of the National Assessment of Edu-
4	cational Progress Authorization Act if the Secretary
5	pays the costs of administering such assessments;
6	"(3) the State educational agency will notify
7	local educational agencies and the public of the au-
8	thority to operate schoolwide programs;
9	"(4) the State educational agency will provide
10	the least restrictive and burdensome regulations for
11	local educational agencies and individual schools par-
12	ticipating in a program assisted under this subpart;
13	"(5) the State educational agency will encour-
14	age schools to consolidate funds from other Federal,
15	State, and local sources for schoolwide reform in
16	schoolwide programs under section 1114;
17	"(6) the State educational agency will modify or
18	eliminate State fiscal and accounting barriers so
19	that schools can easily consolidate funds from other
20	Federal, State, and local sources for schoolwide pro-
21	grams under section 1114; and
22	"(7) the State educational agency will inform
23	local educational agencies in the State of the local
24	educational agency's authority to transfer funds

1	under section 1002 and to obtain waivers under sec-
2	tion 6401.
3	"(d) Parental Involvement.—Each State plan
4	shall describe how the State educational agency will sup-
5	port the collection and dissemination to local educational
6	agencies and schools of effective parental involvement
7	practices. Such practices shall—
8	"(1) be based on the most current research that
9	meets the highest professional and technical stand-
10	ards on effective parental involvement that fosters
11	achievement to high standards for all children;
12	"(2) be geared toward lowering barriers to
13	greater participation by parents in school planning,
14	review, and improvement; and
15	"(3) be coordinated with programs funded
16	under subpart 3 of part A of title III.
17	"(e) Peer Review and Secretarial Approval.—
18	"(1) Establishment.—Notwithstanding sec-
19	tion 6543, the Secretary shall—
20	"(A) establish a peer-review process to as-
21	sist in the review of State plans; and
22	"(B) appoint individuals to the peer-review
23	process who are representative of parents,
24	teachers, State educational agencies, local edu-
25	cational agencies, and private sector employers

1	(including representatives of entrepreneurial
2	ventures), and who are familiar with edu-
3	cational standards, assessments, accountability,
4	the needs of low-performing schools, and other
5	educational needs of students, and ensure that
6	65 percent of such appointees are practitioners
7	and 10 percent are representatives of private
8	sector employers.
9	"(2) APPROVAL.—The Secretary shall—
10	"(A) approve a State plan within 120 days
11	of its submission;
12	"(B) disapprove of the State plan only if
13	the Secretary demonstrates how the State plan
14	fails to meet the requirements of this section
15	and immediately notifies the State of such de-
16	termination and the reasons for such deter-
17	mination;
18	"(C) not decline to approve a State's plan
19	before—
20	"(i) offering the State an opportunity
21	to revise its plan;
22	"(ii) providing technical assistance in
23	order to assist the State to meet the re-
24	quirements of this section; and
25	"(iii) providing a hearing; and

1	"(D) have the authority to disapprove a
2	State plan for not meeting the requirements of
3	this subpart, but shall not have the authority to
4	require a State, as a condition of approval of
5	the State plan, to include in, or delete from,
6	such plan one or more specific elements of the
7	State's academic standards or State account-
8	ability system, or to use specific academic as-
9	sessments or other indicators.
10	"(3) STATE REVISIONS.—A State plan shall be
11	revised by the State educational agency if it is nec-
12	essary to satisfy the requirements of this section.
13	"(4) Public Review.—All communications,
14	feedback, and notifications under this subsection
15	shall be conducted in a manner that is immediately
16	made available to the public through the website of
17	the Department, including—
18	"(A) peer review guidance;
19	"(B) the names of the peer reviewers;
20	"(C) State plans submitted or resubmitted
21	by a State, including the current approved
22	plans;
23	"(D) peer review notes;
24	"(E) State plan determinations by the Sec-
25	retary, including approvals or disapprovals, and

1	any deviations from the peer reviewers' rec-
2	ommendations with an explanation of the devi-
3	ation; and
4	"(F) hearings.
5	"(5) Prohibition.—The Secretary, and the
6	Secretary's staff, may not attempt to participate in,
7	or influence, the peer review process. No Federal
8	employee may participate in, or attempt to influence
9	the peer review process, except to respond to ques-
10	tions of a technical nature, which shall be publicly
11	reported.
12	"(f) Duration of the Plan.—
13	"(1) IN GENERAL.—Each State plan shall—
14	"(A) remain in effect for the duration of
15	the State's participation under this subpart;
16	and
17	"(B) be periodically reviewed and revised
18	as necessary by the State educational agency to
19	reflect changes in the State's strategies and
20	programs under this subpart.
21	"(2) Additional information.—If a State
22	makes significant changes to its State plan, such as
23	the adoption of new State academic standards or
24	new academic assessments, or adopts a new State
25	accountability system, such information shall be sub-

1	mitted to the Secretary under subsection (e)(2) for
2	approval.
3	"(g) Failure To Meet Requirements.—If a
4	State fails to meet any of the requirements of this section
5	then the Secretary shall withhold funds for State adminis-
6	tration under this subpart until the Secretary determines
7	that the State has fulfilled those requirements.
8	"(h) Reports.—
9	"(1) Annual state report card.—
10	"(A) In general.—A State that receives
11	assistance under this subpart shall prepare and
12	disseminate an annual State report card. Such
13	dissemination shall include, at a minimum, pub-
14	licly posting the report card on the home page
15	of the State educational agency's website.
16	"(B) Implementation.—The State report
17	card shall be—
18	"(i) concise; and
19	"(ii) presented in an understandable
20	and uniform format that is developed in
21	consultation with parents and, to the ex-
22	tent practicable, provided in a language
23	that parents can understand.

1	"(C) REQUIRED INFORMATION.—The
2	State shall include in its annual State report
3	card information on—
4	"(i) the performance of students, in
5	the aggregate and disaggregated by the
6	categories of students described in sub-
7	section (b)(2)(B)(xii) (except that such
8	disaggregation shall not be required in a
9	case in which the number of students in a
10	category is insufficient to yield statistically
11	reliable information or the results would
12	reveal personally identifiable information
13	about an individual student), on the State
14	academic assessments described in sub-
15	section $(b)(2)$;
16	"(ii) the participation rate on such as-
17	sessments, in the aggregate and
18	disaggregated in accordance with clause
19	(i);
20	"(iii) the performance of students, in
21	the aggregate and disaggregated in accord-
22	ance with clause (i), on other academic in-
23	dicators described in subsection
24	(b)(3)(B)(i);

1	"(iv) for each public high school in
2	the State, in the aggregate and
3	disaggregated in accordance with clause
4	(i)—
5	"(I) the four-year adjusted co-
6	hort graduation rate, and
7	"(II) if applicable, the extended-
8	year adjusted cohort graduation rate,
9	reported separately for students grad-
10	uating in 5 years or less, students
11	graduating in 6 years or less, and stu-
12	dents graduating in 7 or more years;
13	"(v) each public school's evaluation
14	results as determined in accordance with
15	subsection (b)(3)(B)(ii);
16	"(vi) the acquisition of English pro-
17	ficiency by English learners;
18	"(vii) if appropriate, as determined by
19	the State, the number and percentage of
20	teachers in each category established under
21	section 2123(1), except that such informa-
22	tion shall not reveal personally identifiable
23	information about an individual teacher;
24	and

1	"(viii) the results of the assessments
2	described in subsection $(c)(2)$.
3	"(D) OPTIONAL INFORMATION.—The State
4	may include in its annual State report card
5	such other information as the State believes will
6	best provide parents, students, and other mem-
7	bers of the public with information regarding
8	the progress of each of the State's public ele-
9	mentary schools and public secondary schools,
10	such as the number of students enrolled in each
11	public secondary school in the State attaining
12	career and technical proficiencies, as defined in
13	section 113(b)(2)(A) of the Carl D. Perkins Ca-
14	reer and Technical Education Act of 2006, and
15	reported by the State in a manner consistent
16	with section 113(c) of such Act.
17	"(2) Annual Local Educational Agency
18	REPORT CARDS.—
19	"(A) In General.—A local educational
20	agency that receives assistance under this sub-
21	part shall prepare and disseminate an annual
22	local educational agency report card.
23	"(B) MINIMUM REQUIREMENTS.—The
24	State educational agency shall ensure that each
25	local educational agency collects appropriate

1	data and includes in the local educational agen-
2	cy's annual report the information described in
3	paragraph (1)(C) as applied to the local edu-
4	cational agency and each school served by the
5	local educational agency, and—
6	"(i) in the case of a local educational
7	agency, information that shows how stu-
8	dents served by the local educational agen-
9	cy achieved on the statewide academic as-
10	sessment and other academic indicators
11	adopted in accordance with subsection
12	(b)(3)(B)(i) compared to students in the
13	State as a whole; and
14	"(ii) in the case of a school, the
15	school's evaluation under subsection
16	(b)(3)(B)(ii).
17	"(C) OTHER INFORMATION.—A local edu-
18	cational agency may include in its annual local

13	the information widely available through public
14	means, such as posting on the Internet, dis-
15	tribution to the media, and distribution through

17	cational agency issues a report card for all stu-

21	"(3) Preexisting report cards.—A State
22	educational agency or local educational agency may

10	"(2) 32 percent of the average per-pupil ex-
11	penditure in the United States.
12	"(d) Ratable Reductions; RealLocations.—
13	"(1) In General.—
14	"(A) RATABLE REDUCTIONS.—If, after the
15	Secretary reserves funds under section 1138(c),
16	the amount appropriated to carry out this sub-
17	part for any fiscal year is insufficient to pay in
18	full the amounts for which all States are eligi-
19	ble, the Secretary shall ratably reduce each
20	such amount.
21	"(B) Reallocation.—If additional funds
22	become available for making such payments for
23	any fiscal year, the Secretary shall allocate such
24	funds to States in amounts that the Secretary

1	determines will best carry out the purpose of
2	this subpart.
3	"(2) Special rule.—
4	"(A) Further reductions.—The Sec-
5	retary shall further reduce the amount of any
6	grant to a State under this subpart for any fis-

13	"(B) REALLOCATION.—The Secretary shall
14	reallocate such excess funds to other States

17	level of services to migratory children, in such
18	amounts as the Secretary determines are appro-
19	priate.
20	"(e) Consortium Arrangements.—
21	"(1) IN GENERAL.—In the case of a State that
22	receives a grant of \$1,000,000 or less under this
23	section, the Secretary shall consult with the State
24	educational agency to determine whether consortium
25	arrangements with another State or other appro-

1	priate entity would result in delivery of services in
2	a more effective and efficient manner.
3	"(2) Proposals.—Any State, regardless of the
4	amount of such State's allocation, may submit a
5	consortium arrangement to the Secretary for ap-
6	proval.
7	"(3) APPROVAL.—The Secretary shall approve
8	a consortium arrangement under paragraph (1) or
9	(2) if the proposal demonstrates that the arrange-
10	ment will—
11	"(A) reduce administrative costs or pro-
12	gram function costs for State programs; and
13	"(B) make more funds available for direct
14	services to add substantially to the educational
15	achievement of children to be served under this

17	"(f) Determining Numbers of Eligible Chil-
18	DREN.—In order to determine the identified number of
19	migratory children residing in each State for purposes of
20	this section, the Secretary shall—
21	"(1) use the most recent information that most
22	accurately reflects the actual number of migratory
23	children;
24	"(2) develop and implement a procedure for
25	monitoring the accuracy of such information;

1	"(3) develop and implement a procedure for
2	more accurately reflecting cost factors for different
3	types of summer and intersession program designs;
4	"(4) adjust the full-time equivalent number of
5	migratory children who reside in each State to take
6	into account—
7	"(A) the unique needs of those children
8	participating in evidence-based or other effec-
9	tive special programs provided under this sub-
10	part that operate during the summer and inter-
11	session periods; and
12	"(B) the additional costs of operating such
13	programs; and
14	"(5) conduct an analysis of the options for ad-
15	justing the formula so as to better direct services to
16	migratory children, including the most at-risk migra-
17	tory children.
18	"(g) Nonparticipating States.—In the case of a
19	State desiring to receive an allocation under this subpart
20	for a fiscal year that did not receive an allocation for the
21	previous fiscal year or that has been participating for less
22	than 3 consecutive years, the Secretary shall calculate the
23	State's number of identified migratory children aged 3
24	through 21 for purposes of subsection $(a)(1)(A)$ by using
25	the most recent data available that identifies the migra-

1	tory children residing in the State until data is available
2	to calculate the 3-year average number of such children
3	in accordance with such subsection.
4	"SEC. 1134. STATE APPLICATIONS; SERVICES.
5	"(a) Application Required.—Any State desiring
6	to receive a grant under this subpart for any fiscal year
7	shall submit an application to the Secretary at such time
8	and in such manner as the Secretary may require.
9	"(b) Program Information.—Each such applica-
10	tion shall include—
11	"(1) a description of how, in planning, imple-
12	menting, and evaluating programs and projects as-
13	sisted under this subpart, the State and its local op-
14	erating agencies will ensure that the unique edu-
15	cational needs of migratory children, including pre-
16	school migratory children, are identified and ad-
17	dressed through—
18	"(A) the full range of services that are
19	available for migratory children from appro-
20	priate local, State, and Federal educational pro-
21	grams;
22	"(B) joint planning among local, State,
23	and Federal educational programs serving mi-
24	gratory children, including language instruction

1	educational programs under chapter A of sub-
2	part 4; and
3	"(C) the integration of services available
4	under this subpart with services provided by
5	those other programs;
6	"(2) a description of the steps the State is tak-
7	ing to provide all migratory students with the oppor-
8	tunity to meet the same State academic standards
9	that all children are expected to meet;
10	"(3) a description of how the State will use
11	funds received under this subpart to promote inter-
12	state and intrastate coordination of services for mi-
13	gratory children, including how the State will pro-
14	vide for educational continuity through the timely
15	transfer of pertinent school records, including infor-
16	mation on health, when children move from one
17	school to another, whether or not such a move oc-
18	curs during the regular school year;
19	"(4) a description of the State's priorities for
20	the use of funds received under this subpart, and
21	how such priorities relate to the State's assessment
22	of needs for services in the State;
23	"(5) a description of how the State will deter-
24	mine the amount of any subgrants the State will
25	award to local operating agencies, taking into ac-

1	count the numbers and needs of migratory children,
2	the requirements of subsection (d), and the avail-
3	ability of funds from other Federal, State, and local
4	programs; and
5	"(6) a description of how the State will encour-
6	age programs and projects assisted under this sub-
7	part to offer family literacy services if the programs
8	and projects serve a substantial number of migra-
9	tory children whose parents do not have a regular
10	high school diploma or its recognized equivalent or
11	who have low levels of literacy.
12	"(c) Assurances.—Each such application shall also
13	include assurances that—
14	(1) funds received under this subpart will be
15	used only—
16	"(A) for programs and projects, including
17	the acquisition of equipment, in accordance
18	with section 1136; and
19	"(B) to coordinate such programs and
20	projects with similar programs and projects
21	within the State and in other States, as well as
22	with other Federal programs that can benefit
23	migratory children and their families;
24	"(2) such programs and projects will be carried
25	out in a manner consistent with the objectives of

1	section 1114, subsections (b) and (d) of section
2	1115, subsections (b) and (c) of section 1120A, and
3	part C;
4	"(3) in the planning and operation of programs
5	and projects at both the State and local agency op-
6	erating level, there is consultation with parents of
7	migratory children for programs of not less than one
8	school year in duration, and that all such programs
9	and projects are carried out—
10	"(A) in a manner that provides for the
11	same parental involvement as is required for
12	programs and projects under section 1118, un-
13	less extraordinary circumstances make such
14	provision impractical; and

3	"(A) advocacy and outreach activities for
4	migratory children and their families, including
5	informing such children and families of, or
6	helping such children and families gain access
7	to, other education, health, nutrition, and social
8	services;
9	"(B) professional development programs,
10	including mentoring, for teachers and other
11	program personnel;
12	"(C) high-quality, evidence-based family
13	literacy programs;
14	"(D) the integration of information tech-
15	nology into educational and related programs;
16	and
17	"(E) programs to facilitate the transition
18	of secondary school students to postsecondary
19	education or employment without the need for
20	remediation; and
21	"(7) the State will assist the Secretary in deter-
22	mining the number of migratory children under
23	paragraph (1) of section 1133(a).
24	"(d) Priority for Services.—In providing services
25	with funds received under this subpart, each recipient of

1	such funds shall give priority to migratory children who
2	are failing, or most at risk of failing, to meet the State's
3	academic standards under section $1111(b)(1)$.
4	"(e) Continuation of Services.—Notwith-
5	standing any other provision of this subpart—
6	"(1) a child who ceases to be a migratory child
7	during a school term shall be eligible for services
8	until the end of such term;
9	"(2) a child who is no longer a migratory child
10	may continue to receive services for one additional
11	school year, but only if comparable services are not
12	available through other programs; and
13	"(3) secondary school students who were eligi-
14	ble for services in secondary school may continue to
15	be served through credit accrual programs until

1	"(D) specifies measurable program goals
2	and outcomes;
3	"(E) encompasses the full range of services
4	that are available for migratory children from
5	appropriate local, State, and Federal edu-
6	cational programs;
7	"(F) is the product of joint planning
8	among such local, State, and Federal programs,
9	including programs under subpart 1, early
10	childhood programs, and language instruction
11	educational programs under chapter A of sub-
12	part 4; and
13	"(G) provides for the integration of serv-
14	ices available under this subpart with services
15	provided by such other programs.
16	"(2) Duration of the plan.—Each such
17	comprehensive State plan shall—
18	"(A) remain in effect for the duration of
19	the State's participation under this subpart;
20	and
21	"(B) be periodically reviewed and revised
22	by the State, as necessary, to reflect changes in
23	the State's strategies and programs under this
24	subpart.
25	"(b) Authorized Activities.—

1	"(1) Flexibility.—In implementing the com-
2	prehensive plan described in subsection (a), each
3	State educational agency, where applicable through
4	its local educational agencies, shall have the flexi-
5	bility to determine the activities to be provided with
6	funds made available under this subpart, except that
7	such funds first shall be used to meet the identified
8	needs of migratory children that result from their
9	migratory lifestyle, and to permit these children to
10	participate effectively in school.
11	"(2) Unaddressed needs.—Funds provided
12	under this subpart shall be used to address the
13	needs of migratory children that are not addressed
14	by services available from other Federal or non-Fed-
15	eral programs, except that migratory children who
16	are eligible to receive services under subpart 1 may
17	receive those services through funds provided under
18	that subpart, or through funds under this subpart
19	that remain after the agency addresses the needs de-
20	scribed in paragraph (1).
21	"(3) Construction.—Nothing in this subpart
22	shall be construed to prohibit a local educational
23	agency from serving migratory children simulta-
24	neously with students with similar educational needs
25	in the same educational settings, where appropriate.

1	"SEC. 1137. BYPASS.
2	"The Secretary may use all or part of any State's
3	allocation under this subpart to make arrangements with
4	any public or private agency to carry out the purpose of
5	this subpart in such State if the Secretary determines
6	that—
7	"(1) the State is unable or unwilling to conduct
8	educational programs for migratory children;
9	"(2) such arrangements would result in more
10	efficient and economic administration of such pro-
11	grams; or
12	"(3) such arrangements would add substantially
13	to the educational achievement of such children.
14	"SEC. 1138. COORDINATION OF MIGRATORY EDUCATION
15	ACTIVITIES.
16	"(a) Improvement of Coordination.—

20	agencies to establish or improve programs of education for
21	neglected, delinquent, or at-risk children and youth.
22	"SEC. 1142. PAYMENTS FOR PROGRAMS UNDER THIS SUB-
23	PART.
24	"(a) Agency Subgrants.—Based on the allocation
25	amount computed under section 1152, the Secretary shall

1	allocate to each State educational agency an amount nec-
2	essary to make subgrants to State agencies under chapter
3	A.
4	"(b) Local Subgrants.—Each State shall retain,
5	for the purpose of carrying out chapter B, funds generated
6	throughout the State under subpart 1 of this part based
7	on children and youth residing in local correctional facili-

24	or delinquent children and youth determined under
25	paragraph (1) shall—

2	a deadline set by the Secretary, except that no
3	State agency shall be required to determine the
4	number of such children and youth on a specific
5	date set by the Secretary; and
6	"(B) be adjusted, as the Secretary deter-
7	mines is appropriate, to reflect the relative
8	length of such agency's annual programs.
9	"(b) Subgrants to State Agencies in Puerto
10	Rico.—
11	"(1) In general.—For each fiscal year, the
12	amount of the subgrant which a State agency in the
13	Commonwealth of Puerto Rico shall be eligible to re-
14	ceive under this chapter shall be the amount deter-
15	mined by multiplying the number of children count-
16	ed under subsection (a)(1)(A) for the Common-
17	wealth of Puerto Rico by the product of—

10	"SEC. 1153. STATE REALLOCATION OF FUNDS.
11	"If a State educational agency determines that a
12	State agency does not need the full amount of the

15	may reallocate the amount that will not be needed to other
16	eligible State agencies that need additional funds to carry

19	"SEC. 1154. STATE PLAN AND STATE AGENCY APPLICA-

21	"(a) State Plan.—

24	chapter shall submit, for approval by the Secretary,

1	"(A) for meeting the educational needs of

20	"(C) describe how the State will place a

23	"(D) contain an assurance that the State

20	"(b) Secretarial Approval and Peer Review.—
21	"(1) Secretarial Approval.—The Secretary
22	shall approve each State plan that meets the re-
23	quirements of this chapter.

1	"(2) Peer Review.—The Secretary may review
2	any State plan with the assistance and advice of in-
3	dividuals with relevant expertise.
4	"(c) State Agency Applications.—Any State
5	agency that desires to receive funds to carry out a pro-
6	gram under this chapter shall submit an application to
7	the State educational agency that—
8	"(1) describes the procedures to be used, con-
9	sistent with the State plan under section 1111, to
10	assess the educational needs of the children to be
11	served under this chapter;
12	"(2) provide an assurance that in making serv-
13	ices available to children and youth in adult correc-
14	tional institutions, priority will be given to such chil-
15	dren and youth who are likely to complete incarcer-
16	ation within a 2-year period;
17	"(3) describes the program, including a budget
18	for the first year of the program, with annual up-
19	dates to be provided to the State educational agency;
20	"(4) describes how the program will meet the
21	goals and objectives of the State plan;
22	"(5) describes how the State agency will consult
23	with experts and provide the necessary training for
24	appropriate staff, to ensure that the planning and

1	operation of institution-wide projects under section
2	1156 are of high quality;
3	"(6) describes how the programs will be coordi-
4	nated with other appropriate State and Federal pro-
5	grams, such as programs under title I of Public Law
6	105–220, career and technical education programs,
7	State and local dropout prevention programs, and
8	special education programs;
9	"(7) describes how the State agency will en-
10	courage correctional facilities receiving funds under
11	this chapter to coordinate with local educational
12	agencies or alternative education programs attended
13	by incarcerated children and youth prior to and after
14	their incarceration to ensure that student assess-
15	ments and appropriate academic records are shared
16	jointly between the correctional facility and the local
17	educational agency or alternative education program;
18	"(8) describes how appropriate professional de-
19	velopment will be provided to teachers and other
20	staff;
21	"(9) designates an individual in each affected
22	correctional facility or institution for neglected or
23	delinquent children and youth to be responsible for
24	issues relating to the transition of such children and

1	youth from such facility or institution to locally op-
2	erated programs;
3	"(10) describes how the State agency will en-
4	deavor to coordinate with businesses for training and
5	mentoring for participating children and youth;
6	"(11) provides an assurance that the State
7	agency will assist in locating alternative programs
8	through which students can continue their education
9	if the students are not returning to school after leav-
10	ing the correctional facility or institution for ne-
11	glected or delinquent children and youth;
12	"(12) provides assurances that the State agency
13	will work with parents to secure parents' assistance
14	in improving the educational achievement of their
15	children and youth, and preventing their children's
16	and youth's further involvement in delinquent activi-
17	ties;
18	"(13) provides an assurance that the State
19	agency will work with children and youth with dis-
20	abilities in order to meet an existing individualized
21	education program and an assurance that the agen-
22	cy will notify the child's or youth's local school if the
23	child or youth—
24	"(A) is identified as in need of special edu-
25	cation services while the child or youth is in the

1	correctional facility or institution for neglected
2	or delinquent children and youth; and
3	"(B) intends to return to the local school;
4	"(14) provides an assurance that the State
5	agency will work with children and youth who
6	dropped out of school before entering the correc-
7	tional facility or institution for neglected or delin-
8	quent children and youth to encourage the children
9	and youth to reenter school and obtain a regular
10	high school diploma once the term of the incarcer-
11	ation is completed, or provide the child or youth with
12	the skills necessary to gain employment, continue
13	the education of the child or youth, or obtain a reg-
14	ular high school diploma or its recognized equivalent
15	if the child or youth does not intend to return to
16	school;
17	"(15) provides an assurance that effective
18	teachers and other qualified staff are trained to
19	work with children and youth with disabilities and
20	other students with special needs taking into consid-
21	eration the unique needs of such students;
22	"(16) describes any additional services to be
23	provided to children and youth, such as career coun-
24	seling, distance education, and assistance in securing
25	student loans and grants; and

1	"(17) provides an assurance that the program
2	under this chapter will be coordinated with any pro-
3	grams operated under the Juvenile Justice and De-
4	linquency Prevention Act of 1974 (42 U.S.C. 5601
5	et seq.) or other comparable programs, if applicable.
6	"SEC. 1155. USE OF FUNDS.
7	"(a) USES.—
8	"(1) IN GENERAL.—A State agency shall use
9	funds received under this chapter only for programs
10	and projects that—
11	"(A) are consistent with the State plan
12	under section 1154(a); and
13	"(B) concentrate on providing participants
14	with the knowledge and skills needed to make
15	a successful transition to secondary school com-
16	pletion, career and technical education, further
17	education, or employment without the need for
18	remediation.
19	"(2) Programs and Projects.—Such pro-
20	grams and projects—
21	"(A) may include the acquisition of equip-
22	ment;
23	"(B) shall be designed to support edu-
24	cational services that—

1	"(i) except for institution-wide
2	projects under section 1156, are provided
3	to children and youth identified by the
4	State agency as failing, or most at-risk of
5	failing, to meet the State's academic stand-
6	ards;
7	"(ii) supplement and improve the
8	quality of the educational services provided
9	to such children and youth by the State
10	agency; and
11	"(iii) afford such children and youth
12	an opportunity to meet State academic
13	standards; and
14	"(C) shall be carried out in a manner con-
15	sistent with section 1120A and part C (as ap-
16	plied to programs and projects under this chap-
17	ter).
18	"(b) Supplement, Not Supplant.—A program
19	under this chapter that supplements the number of hours
20	of instruction students receive from State and local
21	sources shall be considered to comply with the supplement,
22	not supplant requirement of section 1120A (as applied to
23	this chapter) without regard to the subject areas in which
24	instruction is given during those hours.

1 "SEC. 1156. INSTITUTION-WIDE PROJECTS.

2	"A State agency that provides free public education
3	for children and youth in an institution for neglected or
4	delinquent children and youth (other than an adult correc-
5	tional institution) or attending a community day program
6	for such children and youth may use funds received under
7	this chapter to serve all children in, and upgrade the entire

26	after leaving the institution;

1	"(4) describes the instructional program, spe-
2	cialized instructional support services, and proce-
3	dures that will be used to meet the needs described
4	in paragraph (1), including, to the extent feasible,
5	the provision of mentors for the children and youth
6	described in paragraph (1);
7	"(5) specifically describes how such funds will
8	be used;
9	"(6) describes the measures and procedures
10	that will be used to assess and improve student
11	achievement;
12	"(7) describes how the agency has planned, and
13	will implement and evaluate, the institution-wide or
14	program-wide project in consultation with personnel
15	providing direct instructional services and support
16	services in institutions or community day programs
17	for neglected or delinquent children and youth, and
18	with personnel from the State educational agency;
19	and
20	"(8) includes an assurance that the State agen-
21	cy has provided for appropriate training for teachers
22	and other instructional and administrative personnel
23	to enable such teachers and personnel to carry out
24	the project effectively.

1 "SEC. 1157. THREE-YEAR PROGRAMS OR PROJECTS.

2	"If a State agency operates a program or project
3	under this chapter in which individual children or youth
4	are likely to participate for more than one year, the State
5	educational agency may approve the State agency's appli-
6	cation for a subgrant under this chapter for a period of
7	not more than 3 years.
8	"SEC. 1158. TRANSITION SERVICES.
9	"(a) Transition Services.—Each State agency
10	shall reserve not less than 15 percent and not more than
11	30 percent of the amount such agency receives under this

19	"(v) job placement services.
20	"(b) CONDUCT OF PROJECTS.—A project supported
21	under this section may be conducted directly by the State
22	agency, or through a contract or other arrangement with
23	one or more local educational agencies, other public agen-
24	cies, or private organizations.

1	"(c) Rule of Construction.—Nothing in this sec-
2	tion shall be construed to prohibit a school that receives
3	funds under subsection (a) from serving neglected and de-
4	linquent children and youth simultaneously with students
5	with similar educational needs, in the same educational
6	settings where appropriate.
7	"SEC. 1159. TECHNICAL ASSISTANCE.
8	"The Secretary shall reserve not more than 1 percent
9	of the amount reserved under section 1141 to provide
10	technical assistance to and support State agency programs
11	assisted under this chapter.
12	"CHAPTER B—LOCAL AGENCY PROGRAMS
13	"SEC. 1161. PURPOSE.
14	"The purpose of this chapter is to support the oper-
15	ation of local educational agency programs that involve
16	collaboration with locally operated correctional facilities—
17	"(1) to carry out high quality education pro-
18	grams to prepare children and youth for secondary
19	school completion, training, employment, or further
20	education;
21	"(2) to provide activities to facilitate the transi-
22	tion of such children and youth from the correctional
23	program to further education or employment; and
24	"(3) to operate programs in local schools for
25	children and youth returning from correctional facili-

3	"SEC. 1162. PROGRAMS OPERATED BY LOCAL EDU-
4	CATIONAL AGENCIES.
5	"(a) Local Subgrants.—With funds made avail-

7	shall award subgrants to local educational agencies with
8	high numbers or percentages of children and youth resid-
9	ing in locally operated (including county operated) correc-
10	tional facilities for children and youth (including facilities
11	involved in community day programs).

14	not required to operate a program of support for children

7	Services to students at-risk of dropping out of school shall

19	how the school will coordinate existing educational
20	programs to meet the unique educational needs of
21	such children and youth;
22	"(6) as appropriate, a description of how
23	schools will coordinate with existing social, health,
24	and other services to meet the needs of students re-
25	turning from correctional facilities and at-risk chil-

1	dren or youth, including prenatal health care and
2	nutrition services related to the health of the parent
3	and the child or youth, parenting and child develop-
4	ment classes, child care, targeted reentry and out-
5	reach programs, referrals to community resources,
6	and scheduling flexibility;
7	"(7) as appropriate, a description of any part-
8	nerships with local businesses to develop training,
9	curriculum-based youth entrepreneurship education,
10	and mentoring services for participating students;
11	"(8) as appropriate, a description of how the
12	program will involve parents in efforts to improve
13	the educational achievement of their children, assist
14	in dropout prevention activities, and prevent the in-
15	volvement of their children in delinquent activities;
16	"(9) a description of how the program under
17	this chapter will be coordinated with other Federal,
18	State, and local programs, such as programs under
19	title I of Public Law 105–220 and career and tech-
20	nical education programs serving at-risk children
21	and youth;
22	"(10) a description of how the program will be
23	coordinated with programs operated under the Juve-
24	nile Justice and Delinquency Prevention Act of 1974
25	and other comparable programs, if applicable;

1	"(11) as appropriate, a description of how
2	schools will work with probation officers to assist in
3	meeting the needs of children and youth returning
4	from correctional facilities;
5	"(12) a description of the efforts participating
6	schools will make to ensure correctional facilities
7	working with children and youth are aware of a
8	child's or youth's existing individualized education
9	program; and
10	"(13) as appropriate, a description of the steps
11	participating schools will take to find alternative
12	placements for children and youth interested in con-
13	tinuing their education but unable to participate in
14	a traditional public school program.
15	"SEC. 1164. USES OF FUNDS.
16	"(a) In General.—Funds provided to local edu-
17	cational agencies under this chapter may be used, as ap-
18	propriate, for—
19	"(1) programs that serve children and youth re-
20	turning to local schools from correctional facilities,
21	to assist in the transition of such children and youth
22	to the school environment and help them remain in
23	school in order to complete their education;
24	"(2) dropout prevention programs which serve
25	at-risk children and youth;

1	"(3) the coordination of health and social serv-
2	ices for such individuals if there is a likelihood that

3	"(5) work to ensure that the correctional facil-
4	ity is staffed with effective teachers and other quali-
5	fied staff who are trained to work with children and
6	youth with disabilities taking into consideration the
7	unique needs of such children and youth;
8	"(6) ensure that educational programs in the
9	correctional facility are related to assisting students
10	to meet the States's academic standards;
11	"(7) to the extent possible, use technology to
12	assist in coordinating educational programs between
13	the correctional facility and the community school;
14	"(8) where feasible, involve parents in efforts to
15	improve the educational achievement of their chil-
16	dren and prevent the further involvement of such
17	children in delinquent activities;
18	"(9) coordinate funds received under this chap-
19	ter with other local, State, and Federal funds avail-
20	able to provide services to participating children and
21	youth, such as funds made available under title I of
22	Public Law 105–220, and career and technical edu-
23	cation funds;
24	"(10) coordinate programs operated under this
25	chapter with activities funded under the Juvenile

1	"SEC. 1192. STATE EDUCATIONAL AGENCY PLANS.
2	"(a) Plan Required.—Each State educational
3	agency desiring a grant under this chapter shall submit
4	a plan to the Secretary at such time and in such manner
5	as the Secretary may require.
6	"(b) Contents.—Each plan submitted under sub-
7	section (a) shall—
8	"(1) describe the process that the agency will
9	use in awarding subgrants to eligible entities under
10	section $1193(d)(1)$;
11	"(2) provide an assurance that—
12	"(A) the agency will ensure that eligible
13	entities receiving a subgrant under this chapter
14	comply with the requirement in section
15	1111(b)(2)(B)(x) to annually assess in English
16	learners who have been in the United States for
17	3 or more consecutive years;
18	"(B) the agency will ensure that eligible
19	entities receiving a subgrant under this chapter
20	annually assess the English proficiency of all
21	English learners participating in a program
22	funded under this chapter, consistent with sec-
23	tion $1111(b)(2)(D)$;
24	"(C) in awarding subgrants under section
25	1193, the agency will address the needs of
26	school systems of all sizes and in all geographic

1	areas, including school systems with rural and
2	urban schools;
3	"(D) subgrants to eligible entities under
4	section 1193(d)(1) will be of sufficient size and
5	scope to allow such entities to carry out high-
6	quality, evidence-based language instruction
7	educational programs for English learners;
8	"(E) the agency will require an eligible en-
9	tity receiving a subgrant under this chapter to
10	use the subgrant in ways that will build such
11	recipient's capacity to continue to offer high-
12	quality evidence-based language instruction edu-
13	cational programs that assist English learners
14	in meeting State academic standards;
15	"(F) the agency will monitor the eligible
16	entity receiving a subgrant under this chapter
17	for compliance with applicable Federal fiscal re-
18	quirements; and
19	"(G) the plan has been developed in con-
20	sultation with local educational agencies, teach-
21	ers, administrators of programs implemented
22	under this chapter, parents, and other relevant
23	stakeholders;
24	"(3) describe how the agency will coordinate its
25	programs and activities under this chapter with

1	other programs and activities under this Act and
2	other Acts, as appropriate;
3	"(4) describe how eligible entities in the State
4	will be given the flexibility to teach English learn-
5	ers—
6	"(A) using a high-quality, evidence-based
7	language instruction curriculum for teaching
8	English learners; and
9	"(B) in the manner the eligible entities de-
10	termine to be the most effective; and
11	"(5) describe how the agency will assist eligible
12	entities in increasing the number of English learners
13	who acquire English proficiency.
14	"(c) Approval.—The Secretary, after using a peer
15	review process, shall approve a plan submitted under sub-
16	section (a) if the plan meets the requirements of this sec-
17	tion.
18	"(d) Duration of Plan.—
19	"(1) In general.—Each plan submitted by a
20	State educational agency and approved under sub-
21	section (c) shall—
22	"(A) remain in effect for the duration of
23	the agency's participation under this chapter;
24	and

1	"(B) be periodically reviewed and revised
2	by the agency, as necessary, to reflect changes
3	to the agency's strategies and programs carried
4	out under this subpart.
5	"(2) Additional information.—
6	"(A) Amendments.—If the State edu-
7	cational agency amends the plan, the agency
8	shall submit such amendment to the Secretary.
9	"(B) Approval.—The Secretary shall ap-
10	prove such amendment to an approved plan,
11	unless the Secretary determines that the
12	amendment will result in the agency not meet-
13	ing the requirements, or fulfilling the purposes,
14	of this subpart.
15	"(e) Consolidated Plan.—A plan submitted under
16	subsection (a) may be submitted as part of a consolidated
17	plan under section 6302.
18	"(f) Secretary Assistance.—The Secretary shall
19	provide technical assistance, if requested, in the develop-
20	ment of English proficiency standards and assessments.
21	"SEC. 1193. WITHIN-STATE ALLOCATIONS.
22	"(a) In General.—After making the reservation re-
23	quired under subsection $(d)(1)$, each State educational
24	agency receiving a grant under section 1191(c)(2) shall
25	award subgrants for a fiscal year by allocating in a timely

- 1 manner to each eligible entity in the State having a plan
- 2 approved under section 1195 an amount that bears the
- 3 same relationship to the amount received under the grant
- 4 and remaining after making such reservation as the popu-

20	"SEC. 1194. SUBGRANTS TO ELIGIBLE ENTITIES.
21	"(a) Purposes of Subgrants.—A State edu-
22	cational agency may make a subgrant to an eligible entity
23	from funds received by the agency under this chapter only
24	if the entity agrees to expend the funds to improve the
25	education of English learners, by assisting the children to

1	learn English and meet State academic standards. In car-
2	rying out activities with such funds, the eligible entity
3	shall use evidence-based approaches and methodologies for
4	teaching English learners and immigrant children and
5	youth for the following purposes:
6	"(1) Developing and implementing new lan-
7	guage instruction educational programs and aca-
8	demic content instruction programs for English
9	learners and immigrant children and youth, includ-
10	ing programs of early childhood education, elemen-
11	tary school programs, and secondary school pro-
12	grams.
13	"(2) Carrying out highly focused, innovative, lo-
14	cally designed, evidence-based activities to expand or
15	enhance existing language instruction educational
16	programs and academic content instruction pro-
17	grams for English learners and immigrant children
18	and youth.
19	"(3) Implementing, within an individual school,
20	schoolwide programs for restructuring, reforming,
21	and upgrading all relevant programs, activities, and
22	operations relating to language instruction edu-
23	cational programs and academic content instruction
24	for English learners and immigrant children and
25	youth.

1	"(4) Implementing, within the entire jurisdic-
2	tion of a local educational agency, agencywide pro-
3	grams for restructuring, reforming, and upgrading
4	all relevant programs, activities, and operations re-
5	lating to language instruction educational programs
6	and academic content instruction for English learn-
7	ers and immigrant children and youth.
8	"(b) Administrative Expenses.—Each eligible en-
9	tity receiving funds under section 1193(a) for a fiscal year
10	shall use not more than 2 percent of such funds for the
11	cost of administering this chapter.
12	"(c) Required Subgrantee Activities.—An eligi-
13	ble entity receiving funds under section 1193(a) shall use
14	the funds—
15	"(1) to increase the English language pro-
16	ficiency of English learners by providing high-qual-
17	ity, evidence-based language instruction educational
18	programs that meet the needs of English learners
19	and have demonstrated success in increasing—
20	"(A) English language proficiency; and
21	"(B) student academic achievement in the
22	core academic subjects;
23	"(2) to provide high-quality, evidence-based
24	professional development to classroom teachers (in-
25	cluding teachers in classroom settings that are not

1	the settings of language instruction educational pro-
2	grams), school leaders, administrators, and other
3	school or community-based organization personnel,
4	that is—
5	"(A) designed to improve the instruction
6	and assessment of English learners;
7	"(B) designed to enhance the ability of
8	teachers and school leaders to understand and
9	implement curricula, assessment practices and
10	measures, and instruction strategies for English
11	learners;
12	"(C) evidence-based in increasing chil-
13	dren's English language proficiency or substan-
14	tially increasing the subject matter knowledge,
15	teaching knowledge, and teaching skills of
16	teachers; and
17	"(D) of sufficient intensity and duration
18	(which shall not include activities such as one-
19	day or short-term workshops and conferences)
20	to have a positive and lasting impact on the
21	teachers' performance in the classroom, except
22	that this subparagraph shall not apply to an ac-
23	tivity that is one component of a long-term,
24	comprehensive professional development plan
25	established by a teacher and the teacher's su-

1	pervisor based on an assessment of the needs of
2	the teacher, the supervisor, the students of the
3	teacher, and any local educational agency em-
4	ploying the teacher, as appropriate; and
5	"(3) to provide and implement other evidence-
6	based activities and strategies that enhance or sup-
7	plement language instruction educational programs
8	for English learners, including parental and commu-
9	nity engagement activities and strategies that serve
10	to coordinate and align related programs.
11	"(d) Authorized Subgrantee Activities.—Sub-
12	ject to subsection (c), an eligible entity receiving funds
13	under section 1193(a) may use the funds to achieve one
14	of the purposes described in subsection (a) by undertaking
15	one or more of the following activities:
16	"(1) Upgrading program objectives and effec-
17	tive instruction strategies.
18	"(2) Improving the instruction program for
19	English learners by identifying, acquiring, and up-
20	grading curricula, instruction materials, educational
21	software, and assessment procedures.
22	"(3) Providing to English learners—
23	"(A) tutorials and academic or career edu-
24	cation for English learners; and
25	"(B) intensified instruction.

1	"(4) Developing and implementing elementary
2	school or secondary school language instruction edu-
3	cational programs that are coordinated with other
4	relevant programs and services.
5	"(5) Improving the English language pro-
6	ficiency and academic achievement of English learn-
7	ers.
8	"(6) Providing community participation pro-
9	grams, family literacy services, and parent outreach
10	and training activities to English learners and their
11	families—
12	"(A) to improve the English language
13	skills of English learners; and
14	"(B) to assist parents in helping their chil-
15	dren to improve their academic achievement
16	and becoming active participants in the edu-
17	cation of their children.
18	"(7) Improving the instruction of English learn-
19	ers by providing for—
20	"(A) the acquisition or development of
21	educational technology or instructional mate-
22	rials;
23	"(B) access to, and participation in, elec-
24	tronic networks for materials, training, and
25	communication; and

1	"(C) incorporation of the resources de-
2	scribed in subparagraphs (A) and (B) into cur-
3	ricula and programs, such as those funded
4	under this chapter.
5	"(8) Carrying out other activities that are con-
6	sistent with the purposes of this section.
7	"(e) Activities by Agencies Experiencing Sub-
8	STANTIAL INCREASES IN IMMIGRANT CHILDREN AND
9	Youth.—
10	"(1) In general.—An eligible entity receiving
11	funds under section 1193(d)(1) shall use the funds
12	to pay for activities that provide enhanced instruc-
13	tional opportunities for immigrant children and
14	youth, which may include—
15	"(A) family literacy, parent outreach, and
16	training activities designed to assist parents to
17	become active participants in the education of
18	their children;
19	"(B) support for personnel, including para-
20	professionals who have been specifically trained,
21	or are being trained, to provide services to im-
22	migrant children and youth;
23	"(C) provision of tutorials, mentoring, and
24	academic or career counseling for immigrant
25	children and youth;

1	"(D) identification, development, and ac-
2	quisition of curricular materials, educational
3	software, and technologies to be used in the
4	program carried out with awarded funds;
5	"(E) basic instruction services that are di-
6	rectly attributable to the presence in the local
7	educational agency involved of immigrant chil-
8	dren and youth, including the payment of costs
9	of providing additional classroom supplies, costs
10	of transportation, or such other costs as are di-
11	rectly attributable to such additional basic in-
12	struction services;
13	"(F) other instruction services that are de-
14	signed to assist immigrant children and youth
15	to achieve in elementary schools and secondary
16	schools in the United States, such as programs
17	of introduction to the educational system and
18	civics education; and
19	"(G) activities, coordinated with commu-
20	nity-based organizations, institutions of higher
21	education, private sector entities, or other enti-
22	ties with expertise in working with immigrants,
23	to assist parents of immigrant children and
24	youth by offering comprehensive community
25	services.

1	"(2) Duration of Subgrants.—The duration
2	of a subgrant made by a State educational agency
3	under section 1193(d)(1) shall be determined by the
4	agency in its discretion.
5	"(f) Selection of Method of Instruction.—
6	"(1) IN GENERAL.—To receive a subgrant from
7	a State educational agency under this chapter, an el-
8	igible entity shall select one or more methods or
9	forms of instruction to be used in the programs and
10	activities undertaken by the entity to assist English
11	learners to attain English language proficiency and
12	meet State academic standards.
13	"(2) Consistency.—Such selection shall be
14	consistent with sections 1204 through 1206.
15	"(g) Supplement, Not Supplant.—Federal funds
16	made available under this chapter shall be used so as to
17	supplement the level of Federal, State, and local public
18	funds that, in the absence of such availability, would have
19	been expended for programs for English learners and im-
20	migrant children and youth and in no case to supplant
21	such Federal, State, and local public funds.
22	"SEC. 1195. LOCAL PLANS.
23	"(a) Plan Required.—Each eligible entity desiring
24	a subgrant from the State educational agency under sec-
25	tion 1193 shall submit a plan to the State educational

1	agency at such time, in such manner, and containing such
2	information as the State educational agency may require.
3	"(b) Contents.—Each plan submitted under sub-
4	section (a) shall—
5	"(1) describe the evidence-based programs and
6	activities proposed to be developed, implemented,
7	and administered under the subgrant that will help
8	English learners increase their English language
9	proficiency and meet the State academic standards;
10	"(2) describe how the eligible entity will hold el-
11	ementary schools and secondary schools receiving
12	funds under this chapter accountable for annually
13	assessing the English language proficiency of all
14	children participating under this subpart, consistent
15	with section 1111(b);
16	"(3) describe how the eligible entity will pro-
17	mote parent and community engagement in the edu-
18	cation of English learners;
19	"(4) contain an assurance that the eligible enti-
20	ty consulted with teachers, researchers, school ad-
21	ministrators, parents and community members, pub-
22	lic or private organizations, and institutions of high-
23	er education, in developing and implementing such
24	plan;

1	"(5) describe how language instruction edu-
2	cational programs carried out under the subgrant
3	will ensure that English learners being served by the
4	programs develop English language proficiency; and
5	"(6) contain assurances that—
6	"(A) each local educational agency that is
7	included in the eligible entity is complying with
8	section 1112(g) prior to, and throughout, each
9	school year; and
10	"(B) the eligible entity is not in violation
11	of any State law, including State constitutional
12	law, regarding the education of English learn-
13	ers, consistent with sections 1205 and 1206.
14	"(c) Teacher English Fluency.—Each eligible
15	entity receiving a subgrant under section 1193 shall in-
16	clude in its plan a certification that all teachers in any
17	language instruction educational program for English
18	learners that is, or will be, funded under this subpart are
19	fluent in English and any other language used for instruc-
20	tion, including having written and oral communications
21	skills.
22	"CHAPTER B—ADMINISTRATION
23	"SEC. 1201. REPORTING.
24	"(a) In General.—Each eligible entity that receives
25	a subgrant from a State educational agency under chapter

1	A shall provide such agency, at the conclusion of every
2	second fiscal year during which the subgrant is received,
3	with a report, in a form prescribed by the agency, on the
4	activities conducted and students served under this sub-
5	part that includes—
6	"(1) a description of the programs and activi-
7	ties conducted by the entity with funds received
8	under chapter A during the two immediately pre-
9	ceding fiscal years, including how such programs
10	and activities supplemented programs funded pri-
11	marily with State or local funds;
12	"(2) a description of the progress made by
13	English learners in learning the English language
14	and in meeting State academic standards;
15	"(3) the number and percentage of English
16	learners in the programs and activities attaining
17	English language proficiency based on the State
18	English language proficiency standards established
19	under section $1111(b)(1)(E)$ by the end of each
20	school year, as determined by the State's English
21	language proficiency assessment under section
22	1111(b)(2)(D);
23	"(4) the number of English learners who exit

4	"SEC. 1202. ANNUAL REPORT.
5	"(a) States.—Based upon the reports provided to
6	a State educational agency under section 1201, each such
7	agency that receives a grant under this subpart shall pre-
8	pare and submit annually to the Secretary a report on pro-
9	grams and activities carried out by the State educational
10	agency under this subpart and the effectiveness of such
11	programs and activities in improving the education pro-
12	vided to English learners.
13	"(b) Secretary.—Annually, the Secretary shall pre-
14	pare and submit to the Committee on Education and the
15	Workforce of the House of Representatives and the Com-

7	ance and other assistance provided by State edu-
8	cational agencies under section 1191(b)(2)(C);
9	"(5) containing an estimate of the number of
10	effective teachers working in language instruction
11	educational programs and educating English learn-
12	ers, and an estimate of the number of such teachers
13	that will be needed for the succeeding 5 fiscal years;
14	"(6) containing the number of programs or ac-
15	tivities, if any, that were terminated because the en-
16	tities carrying out the programs or activities were
17	not able to reach program goals;
18	"(7) containing the number of English learners
19	served by eligible entities receiving funding under
20	this subpart who were transitioned out of language
21	instruction educational programs funded under this

2	from other reports submitted to the Secretary under
3	this subpart when applicable.
4	"SEC. 1203. COORDINATION WITH RELATED PROGRAMS.
5	"In order to maximize Federal efforts aimed at serv-
6	ing the educational needs of English learners, the Sec-
7	retary shall coordinate and ensure close cooperation with
8	other entities carrying out programs serving language-mi-
9	nority and English learners that are administered by the
10	Department and other agencies.

- 4 "SEC. 1206. CIVIL RIGHTS.
- 5 "Nothing in this subpart shall be construed in a man-
- 6 ner inconsistent with any Federal law guaranteeing a civil

- 8 "SEC. 1207. PROHIBITION.
- 9 "In carrying out this subpart, the Secretary shall nei-
- 10 ther mandate nor preclude the use of a particular cur-
- 11 ricular or pedagogical approach to educating English
- 12 learners.
- 13 "SEC. 1208. PROGRAMS FOR NATIVE AMERICANS AND
- 14 PUERTO RICO.
- 15 "Notwithstanding any other provision of this subpart,
- 16 programs authorized under this subpart that serve Native
- 17 American (including Native American Pacific Islander)
- 18 children and children in the Commonwealth of Puerto Rico
- 19 may include programs of instruction, teacher training,
- 20 curriculum development, evaluation, and assessment de-
- 21 signed for Native American children learning and studying
- 22 Native American languages and children of limited Span-
- 23 ish proficiency, except that an outcome of programs serv-

9	"(B) were not born in any State; and
10	"(C) have not been attending one or more
11	schools in any one or more States for more
12	than 3 full academic years.
13	"(5) Indian tribe.—The term 'Indian tribe'
14	means any Indian tribe, band, nation, or other orga-
15	nized group or community, including any Native vil-
16	lage or Regional Corporation or Village Corporation
17	as defined in or established pursuant to the Alaska
18	Native Claims Settlement Act, that is recognized as
19	eligible for the special programs and services pro-
20	vided by the United States to Indians because of
21	their status as Indians.
22	"(6) Language instruction educational
23	PROGRAM.—The term 'language instruction edu-
24	cational program' means an instruction course—

1	"(A) in which an English learner is placed
2	for the purpose of developing and attaining
3	English language proficiency, while meeting
4	State academic standards, as required by sec-
5	tion $1111(b)(1)$; and
6	"(B) that may make instructional use of
7	both English and a child's native language to
8	enable the child to develop and attain English
9	language proficiency, and may include the par-
10	ticipation of English language proficient chil-
11	dren if such course is designed to enable all
12	participating children to become proficient in
13	English and a second language.
14	"(7) Native language.—The term 'native
15	language', when used with reference to English
16	learner, means—
17	"(A) the language normally used by such
18	individual; or
19	"(B) in the case of a child or youth, the
20	language normally used by the parents of the
21	child or youth.
22	"(8) Paraprofessional.—The term 'para-
23	professional' means an individual who is employed in
24	a preschool, elementary school, or secondary school
25	under the supervision of a certified or licensed teach-

1	er, including individuals employed in language in-
2	struction educational programs, special education,
3	and migratory education.
4	"(9) State.—The term 'State' means each of
5	the 50 States, the District of Columbia, and the
6	Commonwealth of Puerto Rico.
7	"SEC. 1222. NATIONAL CLEARINGHOUSE.
8	"The Secretary shall establish and support the oper-
9	ation of a National Clearinghouse for English Language
10	Acquisition and Language Instruction Educational Pro-
11	grams, which shall collect, analyze, synthesize, and dis-
12	seminate information about language instruction edu-
13	cational programs for English learners, and related pro-
14	grams. The National Clearinghouse shall—
15	"(1) be administered as an adjunct clearing-
16	house of the Educational Resources Information
17	Center Clearinghouses system supported by the In-
18	stitute of Education Sciences;
19	"(2) coordinate activities with Federal data and
20	information clearinghouses and entities operating
21	Federal dissemination networks and systems;
22	"(3) develop a system for improving the oper-

4	"(B) accountability systems that monitor

7	cluding information on academic content and
8	English language proficiency assessments for
9	language instruction educational programs; and
10	"(5) publish, on an annual basis, a list of grant
11	recipients under this subpart.
12	"SEC. 1223. REGULATIONS.
13	"In developing regulations under this subpart, the
14	Secretary shall consult with State educational agencies
15	and local educational agencies, organizations representing
16	English learners, and organizations representing teachers
17	and other personnel involved in the education of English
18	learners.
19	"Subpart 5—Rural Education Achievement Program
20	"SEC. 1230. PURPOSE.
21	"It is the purpose of this subpart to address the
22	unique needs of rural school districts that frequently—
23	"(1) lack the personnel and resources needed to
24	compete effectively for Federal competitive grants;
25	and

1	"(2) receive formula grant allocations in
2	amounts too small to be effective in meeting their in-
3	tended purposes.
4	"CHAPTER A—SMALL, RURAL SCHOOL
5	ACHIEVEMENT PROGRAM
6	"SEC. 1231. GRANT PROGRAM AUTHORIZED.
7	"(a) In General.—From amounts appropriated
8	under section 3(a)(1) for a fiscal year, the Secretary shall
9	reserve 0.6 of one percent to award grants to eligible local
10	educational agencies to enable the local educational agen-
11	cies to carry out activities authorized under any of the
12	following provisions:
13	"(1) Part A of title I.
14	"(2) Title II.
15	"(3) Title III.
16	"(b) Allocation.—
17	"(1) In general.—Except as provided in para-
18	graph (3), the Secretary shall award a grant under
19	subsection (a) to a local educational agency eligible
20	under subsection (d) for a fiscal year in an amount
21	equal to the initial amount determined under para-
22	graph (2) for the fiscal year minus the total amount
23	received by the agency in subpart 2 of part A of title
24	II for the preceding fiscal year.

1	"(2) Determination of initial amount.—
2	The initial amount referred to in paragraph (1) is
3	equal to \$100 multiplied by the total number of stu-
4	dents in excess of 50 students, in average daily at-

6	cational agency, plus \$20,000, except that the initial
7	amount may not exceed \$60,000.
8	"(3) Ratable adjustment.—
9	"(A) IN GENERAL.—If the amount made

14	Secretary shall ratably reduce such amounts for

16	"(B) Additional amounts.—If addi-
17	tional funds become available for making pay-
18	ments under paragraph (1) for such fiscal year,

20	graph (A) shall be increased on the same basis
21	as such payments were reduced.
22	"(c) DISBURSEMENT.—The Secretary shall disburse
23	the funds awarded to a local educational agency under this
24	section for a fiscal year not later than July 1 of that fiscal
25	year.

1	"(d) Eligibility.—
2	"(1) In general.—A local educational agency
3	shall be eligible to use the applicable funding in ac-
4	cordance with subsection (a) if—
5	"(A)(i)(I) the total number of students in
6	average daily attendance at all of the schools
7	served by the local educational agency is fewer
8	than 600; or
9	"(II) each county in which a school served
10	by the local educational agency is located has a
11	total population density of fewer than 10 per-
12	sons per square mile; and
13	"(ii) all of the schools served by the local
14	educational agency are designated with a school
15	locale code of 41, 42, or 43, as determined by
16	the Secretary; or
17	"(B) the agency meets the criteria estab-
18	lished in subparagraph (A)(i) and the Sec-
19	retary, in accordance with paragraph (2),
20	grants the local educational agency's request to
21	waive the criteria described in subparagraph
22	(A)(ii).
23	"(2) CERTIFICATION.—The Secretary shall de-
24	termine whether to waive the criteria described in
25	paragraph (1)(A)(ii) based on a demonstration by

1	the local educational agency, and concurrence by the
2	State educational agency, that the local educational
3	agency is located in an area defined as rural by a
4	governmental agency of the State.
5	"(3) Hold harmless.—For a local edu-
6	cational agency that is not eligible under this chap-
7	ter but met the eligibility requirements under this
8	subsection as it was in effect prior to the date of the
9	enactment of the Student Success Act, the agency
10	shall receive—
11	"(A) for fiscal year 2016, 75 percent of
12	the amount such agency received for fiscal year
13	2013;
14	"(B) for fiscal year 2017, 50 percent of
15	the amount such agency received for fiscal year
16	2013; and
17	"(C) for fiscal year 2018, 25 percent of
18	the amount such agency received for fiscal year
19	2013.
20	"(e) Special Eligibility Rule.—A local edu-
21	cational agency that receives a grant under this chapter
22	for a fiscal year is not eligible to receive funds for such
23	fiscal year under chapter B.

1 "CHAPTER B—RURAL AND LOW-INCOME

2 SCHOOL PROGRAM

3 "SEC. 1235. PROGRAM AUTHORIZED.

4 "(a) Grants to States.—

"(1) IN GENERAL.—From amounts appropriated under section 3(a)(1) for a fiscal year, the Secretary shall reserve 0.6 of one percent for this chapter for a fiscal year that are not reserved under subsection (c) to award grants (from allotments made under paragraph (2)) for the fiscal year to State educational agencies that have applications submitted under section 1237 approved to enable the State educational agencies to award grants to eligible local educational agencies for local authorized activities described in section 1236(a).

11	"(B) DIRECT AWARDS.—The Secretary
12	may award, on a competitive basis or by for-
13	mula, the amount the State educational agency

15	rectly to a specially qualified agency in the
16	State that has submitted an application in ac-
17	cordance with subparagraph (A) and obtained
18	approval of the application.
19	"(C) Specially qualified agency de-
20	FINED.—In this subpart, the term 'specially
21	qualified agency' means an eligible local edu-
22	cational agency served by a State educational
23	agency that does not participate in a program
24	under this subpart in a fiscal year, that may

1	apply directly to the Secretary for a grant in
2	such year under this subsection.
3	"(b) Local Awards.—
4	"(1) Eligibility.—A local educational agency
5	shall be eligible to receive a grant under this subpart
6	if—
7	"(A) 20 percent or more of the children
8	ages 5 through 17 years served by the local
9	educational agency are from families with in-
10	comes below the poverty line; and
11	"(B) all of the schools served by the agen-
12	cy are designated with a school locale code of
13	32, 33, 41, 42, 43, as determined by the Sec-
14	retary.
15	"(2) AWARD BASIS.—A State educational agen-
16	cy shall award grants to eligible local educational
17	agencies—
18	"(A) on a competitive basis;
19	"(B) according to a formula based on the
20	number of students in average daily attendance
21	served by the eligible local educational agencies
22	or schools in the State; or
23	"(C) according to an alternative formula,
24	if, prior to awarding the grants, the State edu-
25	cational agency demonstrates, to the satisfac-

1	tion of the Secretary, that the alternative for-
2	mula enables the State educational agency to
3	allot the grant funds in a manner that serves
4	equal or greater concentrations of children from
5	families with incomes below the poverty line,
6	relative to the concentrations that would be
7	served if the State educational agency used the
8	formula described in subparagraph (B).
9	"(c) Reservations.—From amounts reserved under
10	section 1235(a)(1) for this chapter for a fiscal year, the
11	Secretary shall reserve—
12	"(1) one-half of 1 percent to make awards to el-
13	ementary schools or secondary schools operated or
14	supported by the Bureau of Indian Education, to
15	carry out the activities authorized under this chap-
16	ter; and
17	"(2) one-half of 1 percent to make awards to
18	the outlying areas in accordance with their respec-
19	tive needs, to carry out the activities authorized
20	under this chapter.
21	"SEC. 1236. USES OF FUNDS.
22	"(a) Local Awards.—Grant funds awarded to local
23	educational agencies under this chapter shall be used for
24	activities authorized under any of the following:
25	"(1) Part A of title I.

1	"(2) Title II.
2	"(3) Title III.
3	"(b) Administrative Costs.—A State educational
4	agency receiving a grant under this chapter may not use
5	more than 5 percent of the amount of the grant for State
6	administrative costs and to provide technical assistance to
7	eligible local educational agencies.
8	"SEC. 1237. APPLICATIONS.
9	"(a) In General.—Each State educational agency
10	or specially qualified agency desiring to receive a grant
11	under this chapter shall submit an application to the Sec-
12	retary at such time and in such manner as the Secretary
13	may require.
14	"(b) Contents.—Each application submitted under
15	subsection (a) shall include—
16	"(1) a description of how the State educational
17	agency or specially qualified agency will ensure eligi-
18	ble local educational agencies receiving a grant
19	under this chapter will use such funds to help stu-
20	dents meet the State academic standards under sec-
21	tion $1111(b)(1)$;
22	"(2) if the State educational agency or specially
23	qualified agency will competitively award grants to
24	eligible local educational agencies, as described in

3	"(A) the methods and criteria the State
4	educational agency or specially qualified agency
5	will use for reviewing applications and awarding
6	funds to local educational agencies on a com-
7	petitive basis; and
8	"(B) how the State educational agency or
9	specially qualified agency will notify eligible
10	local educational agencies of the grant competi-
11	tion; and
12	"(3) a description of how the State educational
13	agency or specially qualified agency will provide
14	technical assistance to eligible local educational
15	agencies to help such agencies implement the activi-
16	ties described in section 1236(a).
17	"SEC. 1238. ACCOUNTABILITY.
18	"Each State educational agency or specially qualified
19	agency that receives a grant under this chapter shall pre-
20	pare and submit an annual report to the Secretary. The
21	report shall describe—
22	"(1) the methods and criteria the State edu-
23	cational agency or specially qualified agency used to
24	award grants to eligible local educational agencies,

1	and to provide assistance to schools, under this
2	chapter;
3	"(2) how local educational agencies and schools
4	used funds provided under this chapter; and
5	"(3) the degree to which progress has been
6	made toward having all students meet the State aca-
7	demic standards under section $1111(b)(1)$.
8	"SEC. 1239. CHOICE OF PARTICIPATION.
9	"(a) In General.—If a local educational agency is
10	eligible for funding under chapters A and B of this sub-
11	part, such local educational agency may receive funds
12	under either chapter A or chapter B for a fiscal year, but
13	may not receive funds under both chapters.
14	"(b) Notification.—A local educational agency eli-
15	gible for both chapters A and B of this subpart shall notify

5	in the areas of student achievement, stu-
6	dent safety, financial management, and
7	compliance with all applicable statutes and
8	regulations;
9	"(xiv) in the case of a State entity de-
10	fined in subsection (i)(4), will work with
11	the State to provide assistance to and over-
12	sight of authorized public chartering agen-
13	cies for authorizing activity described in
14	clause (xiii); and
15	"(xv) will work with eligible applicants
16	receiving a subgrant under the State enti-
17	ty's program to support the opening of
18	charter schools or charter school models
19	described in clause (i) that are secondary
20	schools;
21	"(B) of the extent to which the State enti-
22	ty—
23	"(i) is able to meet and carry out the
24	priorities listed in subsection (f)(2); and

1	"(ii) is working to develop or
2	strengthen a cohesive statewide system to
3	support the opening of new charter
4	schools, replicated, high-quality charter
5	school models, or expanded, high-quality
6	charter schools;
7	"(C) of how the State entity will carry out
8	the subgrant competition, including—
9	"(i) a description of the application
10	each eligible applicant desiring to receive a
11	subgrant will submit, including—
12	"(I) a description of the roles
13	and responsibilities of the eligible ap-
14	plicant, partner organizations, and
15	management organizations, including
16	the administrative and contractual
17	roles and responsibilities;
18	"(II) a description of the quality
19	controls agreed to between the eligible
20	applicant and the authorized public
21	chartering agency involved, such as a
22	contract or performance agreement,
23	how a school's performance in the
24	State's academic accountability sys-
25	tem will be a primary factor for re-

1	newal or revocation of the school's
2	charter, and how the State entity and
3	the authorized public chartering agen-
4	cy involved will reserve the right to re-
5	voke or not renew a school's charter
6	based on financial, structural, or oper-
7	ational factors involving the manage-
8	ment of the school;
9	"(III) a description of how the el-
10	igible applicant will solicit and con-
11	sider input from parents and other
12	members of the community on the im-
13	plementation and operation of each
14	charter school that will receive funds
15	under the State entity's program; and
16	"(IV) a description of the
17	planned activities and expenditures
18	for the subgrant funds for purposes of
19	opening and preparing to operate a
20	new charter school, a replicated, high-
21	quality charter school model, or an ex-
22	panded, high-quality charter school,
23	and how the school or model will
24	maintain financial sustainability after
25	the end of the subgrant period; and

1	"(ii) a description of how the State
2	entity will review applications;
3	"(D) in the case of a State entity that
4	partners with an outside organization to carry
5	out the State entity's quality charter school
6	program, in whole or in part, of the roles and
7	responsibilities of this partner;
8	"(E) of how the State entity will help the
9	charter schools receiving funds under the State
10	entity's program consider the transportation
11	needs of the schools' students; and
12	"(F) of how the State entity will support
13	diverse charter school models, including models
14	that serve rural communities.
15	"(2) Assurances.—Assurances, including a
16	description of how the assurances will be met,
17	that—
18	"(A) each charter school receiving funds
19	under the State entity's program will have a
20	high degree of autonomy over budget and oper-
21	ations;
22	"(B) the State entity will support charter
23	schools in meeting the educational needs of
24	their students as described in paragraph
25	(1)(A)(xi);

1	"(C) the State entity will ensure that the
2	authorized public chartering agency of any
3	charter school that receives funds under the
4	State entity's program—
5	"(i) adequately monitors each such
6	charter school in recruiting, enrolling, and
7	meeting the needs of all students, includ-
8	ing students with disabilities and English
9	learners; and
10	"(ii) ensures that each such charter
11	school solicits and considers input from
12	parents and other members of the commu-
13	nity on the implementation and operation
14	of the school;
15	"(D) the State entity will provide adequate
16	technical assistance to eligible applicants to—
17	"(i) meet the objectives described in
18	clauses (viii) and (ix) of paragraph (1)(A)
19	and subparagraph (B) of this paragraph;
20	and
21	"(ii) recruit, enroll, and retain tradi-
22	tionally underserved students, including
23	students with disabilities and English
24	learners, at rates similar to traditional
25	public schools;

1	"(E) the State entity will promote quality
2	authorizing, such as through providing technical
3	assistance and supporting all authorized public
4	chartering agencies in the State to improve the
5	oversight of their charter schools, including
6	by—
7	"(i) assessing annual performance
8	data of the schools, including, as appro-
9	priate, graduation rates, student academic
10	growth, and rates of student attrition;
11	"(ii) reviewing the schools' inde-
12	pendent, annual audits of financial state-
13	ments conducted in accordance with gen-
14	erally accepted accounting principles, and
15	ensuring any such audits are publically re-
16	ported; and
17	"(iii) holding charter schools account-
18	able to the academic, financial, and oper-
19	ational quality controls agreed to between
20	the charter school and the authorized pub-
21	lic chartering agency involved, such as
22	through renewal, non-renewal, or revoca-
23	tion of the school's charter;
24	"(F) the State entity will work to ensure
25	that charter schools are included with the tradi-

1	tional public schools in decision-making about
2	the public school system in the State; and
3	"(G) The State entity will ensure that each
4	charter school receiving funds under the State
5	entity's program makes publicly available, con-
6	sistent with the dissemination requirements of
7	the annual State report card, information to
8	help parents make informed decisions about the
9	education options available to their children, in-
10	cluding information for each school on—
11	"(i) the educational program;
12	"(ii) student support services;
13	"(iii) annual performance and enroll-
14	ment data, disaggregated by the groups of
15	students described in section
16	1111(b)(3)(B)(ii)(II), except that such
17	dissaggregation shall not be required in a
18	case in which the number of students in a
19	group is insufficient to yield statistically
20	reliable information or the results would
21	reveal personally identifiable information
22	about an individual student; and
23	"(iv) any other information the State
24	requires all other public schools to report
25	for purposes of section 1111(h)(1)(D).

1	"(3) Requests for waivers.—A request and
2	justification for waivers of any Federal statutory or
3	regulatory provisions that the State entity believes
4	are necessary for the successful operation of the
5	charter schools that will receive funds under the
6	State entity's program under this section or, in the
7	case of a State entity defined in subsection (i)(4), a
8	description of how the State entity will work with
9	the State to request such necessary waivers, where
10	applicable, and a description of any State or local
11	rules, generally applicable to public schools, that will
12	be waived, or otherwise not apply to such schools.
13	"(f) Selection Criteria; Priority.—
14	"(1) Selection criteria.—The Secretary
15	shall award grants to State entities under this sec-
16	tion on the basis of the quality of the applications
17	submitted under subsection (e), after taking into
18	consideration—
19	"(A) the degree of flexibility afforded by
20	the State's public charter school law and how
21	the State entity will work to maximize the flexi-
22	bility provided to charter schools under the law;
23	"(B) the ambitiousness of the State enti-
24	ty's objectives for the quality charter school
25	program carried out under this section;

1	"(C) the quality of the strategy for assess-
2	ing achievement of those objectives;
3	"(D) the likelihood that the eligible appli-
4	cants receiving subgrants under the program
5	will meet those objectives and improve edu-
6	cational results for students;
7	"(E) the State entity's plan to—
8	"(i) adequately monitor the eligible
9	applicants receiving subgrants under the
10	State entity's program;
11	"(ii) work with the authorized public
12	chartering agencies involved to avoid dupli-
13	cation of work for the charter schools and
14	authorized public chartering agencies; and
15	"(iii) provide adequate technical as-
16	sistance and support for—
17	"(I) the charter schools receiving
18	funds under the State entity's pro-
19	gram; and
20	"(II) quality authorizing efforts
21	in the State; and
22	"(F) the State entity's plan to solicit and
23	consider input from parents and other members
24	of the community on the implementation and
25	operation of the charter schools in the State.

1	"(2) Priority.—In awarding grants under this
2	section, the Secretary shall give priority to State en-
3	tities to the extent that they meet the following cri-
4	teria:
5	"(A) In the case of a State entity located
6	in a State that allows an entity other than a
7	local educational agency to be an authorized
8	public chartering agency, the State has a qual-
9	ity authorized public chartering agency that is
10	an entity other than a local educational agency.
11	"(B) The State entity is located in a State
12	that does not impose any limitation on the
13	number or percentage of charter schools that
14	may exist or the number or percentage of stu-
15	dents that may attend charter schools in the
16	State.
17	"(C) The State entity is located in a State
18	that ensures equitable financing, as compared
19	to traditional public schools, for charter schools
20	and students in a prompt manner.
21	"(D) The State entity is located in a State
22	that uses charter schools and best practices
23	from charter schools to help improve struggling
24	schools and local educational agencies.

1	"(E) The State entity partners with an or-
2	ganization that has a demonstrated record of
3	success in developing management organiza-
4	tions to support the development of charter
5	schools in the State.
6	"(F) The State entity supports charter
7	schools that support at-risk students through
8	activities such as dropout prevention, dropout
9	recovery, or comprehensive career counseling
10	practices.
11	"(G) The State entity authorizes all char-
12	ter schools in the State to serve as school food
13	authorities.
14	"(H) The State entity has taken steps to
15	ensure that all authorizing public chartering
16	agencies implement best practices for charter
17	school authorizing.
18	"(g) Local Uses of Funds.—An eligible applicant
19	receiving a subgrant under this section shall use such
20	funds to carry out activities related to opening and pre-
21	paring to operate a new charter school, a replicated, high-
22	quality charter school model, or an expanded, high-quality
23	charter school, such as—
24	"(1) preparing teachers and school leaders, in-
25	cluding through professional development;

1	"(2) acquiring equipment, educational mate-
2	rials, and supplies; and
3	"(3) carrying out necessary renovations and
4	minor facilities repairs (excluding construction).
5	"(h) Reporting Requirements.—Each State enti-
6	ty receiving a grant under this section shall submit to the
7	Secretary, at the end of the third year of the 5-year grant
8	period and at the end of such grant period, a report on—
9	"(1) the number of students served by each
10	subgrant awarded under this section and, if applica-
11	ble, how many new students were served during each
12	year of the subgrant period;
13	"(2) the progress the State entity made toward
14	meeting the priorities described in subsection $(f)(2)$,
15	as applicable;
16	"(3) how the State entity met the objectives of
17	the quality charter school program described in the
18	State entity's application under subsection (e), in-
19	cluding how the State entity met the objective of
20	sharing best and promising practices described in
21	subsection $(e)(1)(A)(x)$ in areas such as instruction,
22	professional development, curricula development, and
23	operations between charter schools and other public
24	schools, and the extent to which, if known, such

1	practices were adopted and implemented by such
2	other public schools;
3	"(4) how the State entity complied with, and
4	ensured that eligible applicants complied with, the
5	assurances described in the State entity's applica-
6	tion;
7	"(5) how the State entity worked with author-
8	ized public chartering agencies, including how the
9	agencies worked with the management company or
10	leadership of the schools that received subgrants
11	under this section;
12	"(6) the number of subgrants awarded under
13	this section to carry out each of the following:
14	"(A) the opening of new charter schools;
15	"(B) the opening of replicated, high-quality
16	charter school models;
17	"(C) the opening of expanded, high-quality
18	charter schools; and
19	"(7) how the State entity has worked with char-
20	ter schools receiving funds under the State entity's
21	program to foster community involvement in the
22	planning for and opening of such schools.
23	"(i) STATE ENTITY DEFINED.—For purposes of this
24	section, the term 'State entity' means—
25	"(1) a State educational agency;

1	"(2) a State charter school board;
2	"(3) a Governor of a State; or
3	"(4) a charter school support organization.
4	"SEC. 3104. FACILITIES FINANCING ASSISTANCE.
5	"(a) Grants to Eligible Entities.—
6	"(1) IN GENERAL.—From the amount reserved
7	under section 3102(b)(1), the Secretary shall not
8	use less than 50 percent to award grants to eligible
9	entities that have the highest-quality applications
10	approved under subsection (d), after considering the
11	diversity of such applications, to demonstrate inno-
12	vative methods of assisting charter schools to ad-
13	dress the cost of acquiring, constructing, and ren-
14	ovating facilities by enhancing the availability of
15	loans or bond financing.

23	and the design of the proposed activities;
24	"(C) a description of the eligible entity's
25	expertise in capital market financing;

1	"(D) a description of how the proposed ac-
2	tivities will leverage the maximum amount of
3	private-sector financing capital relative to the
4	amount of public funding used and otherwise
5	enhance credit available to charter schools, in-
6	cluding how the eligible entity will offer a com-
7	bination of rates and terms more favorable than
8	the rates and terms that a charter school could
9	receive without assistance from the eligible enti-
10	ty under subsection (a);
11	"(E) a description of how the eligible enti-
12	ty possesses sufficient expertise in education to
13	evaluate the likelihood of success of a charter
14	school program for which facilities financing is
15	sought; and
16	"(F) in the case of an application sub-
17	mitted by a State governmental entity, a de-
18	scription of the actions that the entity has
19	taken, or will take, to ensure that charter
20	schools within the State receive the funding the
21	charter schools need to have adequate facilities.
22	"(e) Charter School Objectives.—An eligible
23	entity receiving a grant under subsection (a) shall use the
24	funds deposited in the reserve account established under
2.5	subsection (f) to assist one or more charter schools to ac-

1	cess private sector capital to accomplish one or more of
2	the following objectives:
3	"(1) The acquisition (by purchase, lease, dona-
4	tion, or otherwise) of an interest (including an inter-
5	est held by a third party for the benefit of a charter
6	school) in improved or unimproved real property
7	that is necessary to commence or continue the oper-
8	ation of a charter school.
9	"(2) The construction of new facilities, or the
10	renovation, repair, or alteration of existing facilities,
11	necessary to commence or continue the operation of
12	a charter school.
13	"(3) The predevelopment costs required to as-
14	sess sites for purposes of paragraph (1) or (2) and
15	which are necessary to commence or continue the
16	operation of a charter school.
17	"(f) Reserve Account.—
18	"(1) Use of funds.—To assist charter schools
19	to accomplish the objectives described in subsection
20	(e), an eligible entity receiving a grant under sub-
21	section (a) shall, in accordance with State and local
22	law, directly or indirectly, alone or in collaboration
23	with others, deposit the funds received under sub-
24	section (a) (other than funds used for administrative
25	costs in accordance with subsection (g)) in a reserve

1	account established and maintained by the eligible
2	entity for this purpose. Amounts deposited in such
3	account shall be used by the eligible entity for one
4	or more of the following purposes:
5	"(A) Guaranteeing, insuring, and rein-

22	assistance (including the recruitment of bond
23	counsel, underwriters, and potential investors
24	and the consolidation of multiple charter school
25	projects within a single bond issue).

1	"(2) Investment.—Funds received under sub-
2	section (a) and deposited in the reserve account es-
3	tablished under paragraph (1) shall be invested in
4	obligations issued or guaranteed by the United
5	States or a State, or in other similarly low-risk secu-
6	rities.
7	"(3) Reinvestment of Earnings.—Any earn-
8	ings on funds received under subsection (a) shall be
9	deposited in the reserve account established under
10	paragraph (1) and used in accordance with such
11	paragraph.
12	"(g) Limitation on Administrative Costs.—An
13	eligible entity may use not more than 2.5 percent of the
14	funds received under subsection (a) for the administrative
15	costs of carrying out its responsibilities under this section

20	"(i) No Full Faith and Credit for Grantee
21	Obligation.—No financial obligation of an eligible entity

25	spect by, the United States. The full faith and credit of

5	451, 452, and 458 of the General Education Provi-
6	sions Act (20 U.S.C. 124, 1234a, 1234g) shall apply
7	to the recovery of funds under paragraph (1).

10	the Secretary to recover funds under part D of the

14	"(i) 90 percent of the cost, for the
15	first fiscal year for which the program re-

17	"(ii) 80 percent in the second such
18	year;
19	"(iii) 60 percent in the third such
20	year;
21	"(iv) 40 percent in the fourth such
22	year; and
23	"(v) 20 percent in the fifth such year.
24	"(D) State share.—A State receiving a
25	grant under this subsection may partner with 1

1	or more organizations to provide up to 50 per-
2	cent of the State share of the cost of estab-
3	lishing or enhancing, and administering the per-
4	pupil facilities aid program.
5	"(E) Multiple grants.—A State may
6	receive more than 1 grant under this sub-
7	section, so long as the amount of such funds
8	provided to charter schools increases with each
9	successive grant.
10	"(3) Use of funds.—
11	"(A) In general.—A State that receives
12	a grant under this subsection shall use the
13	funds made available through the grant to es-
14	tablish or enhance, and administer, a per-pupil
15	facilities aid program for charter schools in the
16	State of the applicant.
17	"(B) EVALUATIONS; TECHNICAL ASSIST-
18	ANCE; DISSEMINATION.—From the amount
19	made available to a State through a grant
20	under this subsection for a fiscal year, the State
21	may reserve not more than 5 percent to carry
22	out evaluations, to provide technical assistance,
23	and to disseminate information.
24	"(C) Supplement, not supplant.—
25	Funds made available under this subsection

1	shall be used to supplement, and not supplant,
2	State and local public funds expended to pro-
3	vide per pupil facilities aid programs, oper-
4	ations financing programs, or other programs,

- 20 "(b) Contents.—Each application submitted under
- 21 subsection (a) shall include, at a minimum, the following:
- "(1) A description of the applicant's approach

- 24 "(2) A description of the support that the
- 25 Statewide Family Engagement Center that will be

1	operated by the applicant will have from the State

18	English learners, minorities, parents of students

21	dents, including evaluation results, reporting, or
22	other data exhibiting such demonstrated experience.
23	"(5) A description of the steps the applicant
24	will take to target services to low-income students
25	and parents.

1	"(6) An assurance that the applicant will—
2	"(A) establish a special advisory com-
3	mittee, the membership of which includes—
4	"(i) parents, who shall constitute a
5	majority of the members of the special ad-
6	visory committee;
7	"(ii) representatives of education pro-
8	fessionals with expertise in improving serv-
9	ices for disadvantaged children;
10	"(iii) representatives of local elemen-
11	tary schools and secondary schools, includ-
12	ing students;
13	"(iv) representatives of the business
14	community; and
15	"(v) representatives of State edu-
16	cational agencies and local educational
17	agencies;
18	"(B) use not less than 65 percent of the
19	funds received under this subpart in each fiscal
20	year to serve local educational agencies, schools,
21	and community-based organizations that serve
22	high concentrations of disadvantaged students,
23	including English learners, minorities, parents
24	of students with disabilities, parents of home-

1	less students, foster parents and students, and
2	parents of migratory students;
3	"(C) operate a Statewide Family Engage-
4	ment Center of sufficient size, scope, and qual-
5	ity to ensure that the Center is adequate to
6	serve the State educational agency, local edu-
7	cational agencies, and community-based organi-
8	zations;
9	"(D) ensure that the Center will retain
10	staff with the requisite training and experience
11	to serve parents in the State;
12	"(E) serve urban, suburban, and rural
13	local educational agencies and schools;
14	"(F) work with—
15	"(i) other Statewide Family Engage-
16	ment Centers assisted under this subpart;
17	and
18	"(ii) parent training and information
19	centers and community parent resource
20	centers assisted under sections 671 and
21	672 of the Individuals with Disabilities
22	Education Act;
23	"(G) use not less than 30 percent of the
24	funds received under this subpart for each fiscal

1	year to establish or expand technical assistance
2	for evidence-based parent education programs;
3	"(H) provide assistance to State edu-
4	cational agencies and local educational agencies
5	and community-based organizations that sup-
6	port family members in supporting student aca-
7	demic achievement;
8	"(I) work with State educational agencies,
9	local educational agencies, schools, educators,
10	and parents to determine parental needs and
11	the best means for delivery of services to ad-
12	dress such needs;
13	"(J) conduct sufficient outreach to assist
14	parents, including parents who the applicant
15	may have a difficult time engaging with a
16	school or local educational agency; and
17	"(K) conduct outreach to low-income stu-
18	dents and parents, including low-income stu-
19	dents and parents who are not proficient in
20	English.
21	"SEC. 3144. USES OF FUNDS.
22	"(a) In General.—Grantees shall use grant funds
23	received under this subpart, based on the needs deter-
24	mined under section 3143(b)(6)(I), to provide training
25	and technical assistance to State educational agencies,

1	local educational agencies, and organizations that support
2	family-school partnerships, and activities, services, and
3	training for local educational agencies, school leaders, edu-
4	cators, and parents—
5	"(1) to assist parents in participating effectively
6	in their children's education and to help their chil-
7	dren meet State standards, such as assisting par-

4	"(G) to help the parents learn and use

6	"(2) to develop and implement, in partnership
7	with the State educational agency, statewide family
8	engagement in education policy and systemic initia-
9	tives that will provide for a continuum of services to
10	remove barriers for family engagement in education
11	and support school reform efforts; and
12	"(3) to develop and implement parental involve-
13	ment policies under this Act.
14	"(b) Matching Funds for Grant Renewal.—
15	For each fiscal year after the first fiscal year for which
16	an organization or consortium receives assistance under
17	this section, the organization or consortium shall dem-
18	onstrate in the application that a portion of the services
19	provided by the organization or consortium is supported
20	through non-Federal contributions, which may be in cash
21	or in-kind.
22	"(c) TECHNICAL ASSISTANCE.—The Secretary shall
23	reserve not more than 2 percent of the funds appropriated
24	under section 3(c)(1)(C) to carry out this subpart to pro-
25	vide technical assistance, by competitive grant or contract,

1	for the establishment, development, and coordination of
2	Statewide Family Engagement Centers.
3	"(d) Rule of Construction.—Nothing in this sec-
4	tion shall be construed to prohibit a Statewide Family En-

7	a parent at a site that is not on school grounds; or

10	"(e) Parental Rights.—Notwithstanding any

22	"The Secretary of the Interior, in consultation with
23	the Secretary of Education, shall establish, or enter into
24	contracts and cooperative agreements with local Indian

2	Family Engagement Centers.
3	"PART B—LOCAL ACADEMIC FLEXIBLE GRANT
4	"SEC. 3201. PURPOSE.
5	"The purpose of this part is to—
6	"(1) provide local educational agencies with the
7	opportunity to access funds to support the initiatives
8	important to their schools and students to improve
9	academic achievement, including protecting student
10	safety; and
11	"(2) provide nonprofit and for-profit entities

8	under subsection (a), the Secretary shall allot to
9	each State for the fiscal year an amount that bears
10	the same relationship to the remainder as the
11	amount the State received under chapter B of sub-
12	part 1 of part A of title I for the preceding fiscal
13	year bears to the amount all States received under
14	that chapter for the preceding fiscal year, except
15	that no State shall receive less than an amount
16	equal to one-half of 1 percent of the total amount
17	made available to all States under this subsection.
18	"(2) Reallotment of unused funds.—If a
19	State does not receive an allotment under this part
20	for a fiscal year, the Secretary shall reallot the
21	amount of the State's allotment to the remaining
22	States in accordance with this section.
23	"(c) State Use of Funds.—
24	"(1) In general.—Each State that receives an
25	allotment under this part shall reserve not less than

1	75 percent of the amount allotted to the State under
2	subsection (b) for each fiscal year for awards to eli-
3	gible entities under section 3204.
4	"(2) Awards to nongovernmental enti-
5	TIES TO IMPROVE STUDENT ACADEMIC ACHIEVE-
6	MENT.—Each State that receives an allotment under
7	subsection (b) for each fiscal year shall reserve not
8	less than 10 percent of the amount allotted to the
9	State for awards to nongovernmental entities under
10	section 3205.
11	"(3) State activities and state adminis-
12	TRATION.—A State educational agency may reserve
13	not more than 15 percent of the amount allotted to
14	the State under subsection (b) for each fiscal year
15	for the following:
16	"(A) Enabling the State educational agen-
17	cy—
18	"(i) to pay the costs of developing the
19	State assessments and standards required
20	under section 1111(b), which may include
21	the costs of working, at the sole discretion
22	of the State, in voluntary partnerships
23	with other States to develop such assess-
24	ments and standards; or

1	"(ii) if the State has developed the as-
2	sessments and standards required under
3	section 1111(b), to administer those as-
4	sessments or carry out other activities re-
5	lated to ensuring that the State's schools
6	and local educational agencies are helping
7	students meet the State's academic stand-
8	ards under such section.
9	"(B) The administrative costs of carrying
10	out its responsibilities under this part, except
11	that not more than 5 percent of the reserved
12	amount may be used for this purpose.
13	"(C) Monitoring and evaluation of pro-
14	grams and activities assisted under this part.
15	"(D) Providing training and technical as-
16	sistance under this part.
17	"(E) Statewide academic focused pro-
18	grams.
19	"(F) Sharing evidence-based and other ef-
20	fective strategies with eligible entities.
21	"SEC. 3203. STATE APPLICATION.
22	"(a) In General.—In order to receive an allotment
23	under section 3202 for any fiscal year, a State educational
24	agency shall submit to the Secretary, at such time as the
25	Secretary may require, an application that—

1	"(1) describes how the State educational agency
2	will use funds reserved for State-level activities, in-
3	cluding how, if any, of the funds will be used to sup-
4	port student safety;
5	"(2) describes the procedures and criteria the
6	State educational agency will use for reviewing appli-
7	cations and awarding funds to eligible entities on a
8	competitive basis, which shall include reviewing how
9	the proposed project will help increase student aca-
10	demic achievement;
11	"(3) describes how the State educational agency
12	will ensure that awards made under this part are—
13	"(A) of sufficient size and scope to support
14	high-quality, effective programs that are con-
15	sistent with the purpose of this part; and
16	"(B) in amounts that are consistent with
17	section 3204(f);
18	"(4) describes the steps the State educational
19	agency will take to ensure that programs implement
20	effective strategies, including providing ongoing
21	technical assistance and training, and dissemination
22	of evidence-based and other effective strategies;
23	"(5) describes how the State educational agency
24	will consider students across all grades when making
25	these awards;

1	"(6) an assurance that, other than providing
2	technical and advisory assistance and monitoring
3	compliance with this part, the State educational
4	agency has not exercised and will not exercise any
5	influence in the decision-making process of eligible
6	entities as to the expenditure of funds received by
7	the eligible entities under this part;
8	"(7) describes how programs under this part
9	will be coordinated with programs under this Act,
10	and other programs as appropriate;
11	"(8) contains an assurance that the State edu-
12	cational agency—
13	"(A) will make awards for programs for a
14	period of not more than 5 years; and
15	"(B) will require each eligible entity seek-
16	ing such an award to submit a plan describing
17	how the project to be funded through the award
18	will continue after funding under this part
19	ends, if applicable;
20	"(9) contains an assurance that funds appro-
21	priated to carry out this part will be used to supple-
22	ment, and not supplant, State and local public funds
23	expended to provide programs and activities author-
24	ized under this part and other similar programs; and

1	"(10) an assurance that the State will support
2	projects from each of the categories listed in section
3	3204(b)(1)(D) in awarding subgrants to local edu-
4	cational agencies.
5	"(b) DEEMED APPROVAL.—An application submitted
6	by a State educational agency pursuant to subsection (a)
7	shall be deemed to be approved by the Secretary unless
8	the Secretary makes a written determination, prior to the
9	expiration of the 120-day period beginning on the date on
10	which the Secretary received the application, that the ap-
11	plication is not in compliance with this part.
12	"(c) DISAPPROVAL.—The Secretary shall not finally
13	disapprove the application, except after giving the State
14	educational agency notice and an opportunity for a hear-
15	ing.
16	"(d) NOTIFICATION.—If the Secretary finds that the
17	application is not in compliance, in whole or in part, with
18	this part, the Secretary shall—
19	"(1) give the State educational agency notice
20	and an opportunity for a hearing; and
21	"(2) notify the State educational agency of the
22	finding of noncompliance, and, in such notification,
23	shall—
24	"(A) cite the specific provisions in the ap-
25	plication that are not in compliance; and

1	"(B) request additional information, only
2	as to the noncompliant provisions, needed to
3	make the application compliant.
4	"(e) Response.—If the State educational agency re-
5	sponds to the Secretary's notification described in sub-
6	section (d)(2) during the 45-day period beginning on the
7	date on which the agency received the notification, and
8	resubmits the application with the requested information
9	described in subsection (d)(2)(B), the Secretary shall ap-
10	prove or disapprove such application prior to the later of—
11	"(1) the expiration of the 45-day period begin-
12	ning on the date on which the application is resub-
13	mitted; or
14	"(2) the expiration of the 120-day period de-
15	scribed in subsection (b).
16	"(f) Failure To Respond.—If the State edu-
17	cational agency does not respond to the Secretary's notifi-
18	cation described in subsection (d)(2) during the 45-day pe-
19	riod beginning on the date on which the agency received
20	the notification, such application shall be deemed to be
21	disapproved.
22	"(g) Rule of Construction.—An application sub-
23	mitted by a State educational agency pursuant to sub-
24	section (a) shall not be approved or disapproved based
25	upon the activities for which the agency may make funds

1	available to eligible entities under section 3204 if the agen-
2	cy's use of funds is consistent with section 3204(b).
3	"SEC. 3204. LOCAL COMPETITIVE GRANT PROGRAM.
4	"(a) In General.—A State that receives funds
5	under this part for a fiscal year shall provide the amount
6	made available under section 3202(c)(1) to eligible entities
7	in accordance with this section.
8	"(b) Use of Funds.—
9	"(1) In general.—An eligible entity that re-
10	ceives an award under this part shall use the funds
11	for activities that—
12	"(A) are evidence-based;
13	"(B) will improve student academic
14	achievement;
15	"(C) are allowable under State law; and
16	"(D) focus on one or more projects from
17	the following two categories:
18	"(i) Supplemental student support ac-
19	tivities such as before, after, or summer
20	school activities, tutoring, and expanded
21	learning time, but not including athletics
22	or in-school learning activities.
23	"(ii) Activities designed to support
24	students, such as academic subject specific

2	mathematics programs, civic education, ad-
3	junct teacher, extended-learning-time, and
4	dual enrollment programs, and parent en-
5	gagement, but not including activities to—

9	benefits to teachers, school leaders,
10	other school officials, or local edu-
11	cational agency staff.
12	"(2) Participation of Children enrolled
13	IN PRIVATE SCHOOLS.—An eligible entity that re-
14	ceives an award under this part shall ensure compli-
15	ance with section 6501 (relating to participation of
16	children enrolled in private schools).
17	"(c) Application.—
18	"(1) In general.—To be eligible to receive an
19	award under this part, an eligible entity shall submit
20	an application to the State educational agency at
21	such time, in such manner, and including such infor-
22	mation as the State educational agency may reason-
23	ably require, including the contents required by
24	paragraph (2).

1	"(2) Contents.—Each application submitted
2	under paragraph (1) shall include—
3	"(A) a description of the activities to be
4	funded and how they are consistent with sub-
5	section (b), including any activities that will in-
6	crease student safety;
7	"(B) an assurance that funds under this
8	part will be used to increase the level of State,
9	local, and other non-Federal funds that would,
10	in the absence of funds under this part, be
11	made available for programs and activities au-
12	thorized under this part, and in no case sup-
13	plant State, local, or non-Federal funds;
14	"(C) an assurance that the community will
15	be given notice of an intent to submit an appli-
16	cation with an opportunity for comment, and
17	that the application will be available for public
18	review after submission of the application; and
19	"(D) an assurance that students who ben-
20	efit from any activity funded under this part
21	shall continue to maintain enrollment in a pub-
22	lic elementary or secondary school.
23	"(d) Review.—In reviewing local applications under
24	this section, a State educational agency shall use a peer
25	review process or other methods of assuring the quality

4	"(e) Geographic Diversity.—A State educational
5	agency shall distribute funds under this part equitably

9	entities that submit an application that meets the require
10	ments of this section in an amount that is not less than
11	\$10,000, but there shall be only one annual award granted
12	to any one local educational agency, but such award may

15	"(g) Duration of Awards.—Grants under this
16	part may be awarded for a period of not more than 5
17	years.
18	"(h) Eligible Entity Defined.—In this section

14	award grants to nongovernmental entities, including pub-
15	lic or private organizations, community-based or faith-

24	work to share evidence-based and other effective
25	strategies from the program or project with local

1	educational agencies and other entities working with
2	students to increase academic achievement.
3	"(8) An assurance that students who benefit
4	from any program or project funded under this sec-
5	tion shall continue to maintain enrollment in a pub-
6	lic elementary or secondary school.
7	"(c) Matching Contribution.—An eligible appli-
8	cant receiving a grant under this section shall provide, ei-
9	ther directly or through private contributions, non-Federal
10	matching funds equal to not less than 50 percent of the
11	amount of the grant.
12	"(d) Review.—The State educational agency shall
13	review the application to ensure that—
14	"(1) the applicant is an eligible applicant;
15	"(2) the application clearly describes the re-
16	quired elements in subsection (b);
17	"(3) the entity meets the matching requirement
18	described in subsection (c); and
19	"(4) the program is allowable and complies with
20	Federal, State, and local laws.
21	"(e) Distribution of Funds.—If the application
22	requests exceed the funds available, the State educational
23	agency shall prioritize projects that support students in
24	high-need local educational agencies and ensure geo-

1	graphic diversity, including serving rural, suburban, and

3	"(f) Administrative Costs.—Not more than 1 per-
4	cent of a grant awarded under this section may be used
5	for administrative costs.
6	"SEC. 3206. REPORT.
7	"Each recipient of a grant under section 3204 or
8	3205 shall report to the State educational agency on—
9	"(1) the success of the program in reaching the
10	goals of the program;
11	"(2) a description of the students served by the
12	program and how the students' academic achieve-
13	ment improved; and
14	"(3) the results of any evaluation conducted on
15	the success of the program.".

16	(2) in subsection (b)(1)(B), by striking "section

19	lows:
20	"(f) Special Rule.—Beginning with fiscal year
21	2014, a local educational agency shall be deemed to meet
22	the requirements of subsection $(a)(1)(C)$ if records to de-
23	termine eligibility under such subsection were destroyed

7	SEC. 501. THE FEDERAL GOVERNMENT'S TRUST RESPONSI-
8	BILITY TO AMERICAN INDIAN, ALASKA NA-

17	"SEC. 5101. STATEMENT OF POLICY.
18	"It is the policy of the United States to fulfill the
19	Federal Government's unique and continuing trust rela-
20	tionship with, and responsibility to, the Indian people for
21	the education of Indian children. The Federal Government
22	will continue to work with local educational agencies, In-
23	dian tribes and organizations, postsecondary institutions,
24	and other entities toward the goal of ensuring that pro-
25	grams that serve Indian children are of the highest quality

1	and provide for not only the basic elementary and sec-
2	ondary educational needs, but also the unique educational
3	and culturally related academic needs of these children.
4	"SEC. 5102. PURPOSE.
5	"It is the purpose of this part to support the efforts
6	of local educational agencies, Indian tribes and organiza-
7	tions, postsecondary institutions, and other entities—
8	"(1) to meet the unique educational and cul-
9	turally related academic needs of American Indian
10	and Alaska Native students, so that such students
11	can meet State student academic achievement stand-
12	ards;
13	"(2) to ensure that Indian and Alaskan Native
14	students gain knowledge and understanding of Na-
15	tive communities, languages, tribal histories, tradi-
16	tions, and cultures; and
17	"(3) to ensure that school leaders, teachers, and
18	other staff who serve Indian and Alaska Native stu-
19	dents have the ability to provide culturally appro-
20	priate and effective instruction to such students.
21	"Subpart 1—Formula Grants to Local
22	EDUCATIONAL AGENCIES
23	"SEC. 5111. PURPOSE.
24	"It is the purpose of this subpart to support the ef-
25	forts of local educational agencies, Indian tribes and orga-

1	nizations, and other entities to improve the academic
2	achievement of American Indian and Alaska Native stu-
3	dents by providing for their unique cultural, language, and
4	educational needs and ensuring that they are prepared to
5	meet State academic standards.
6	"SEC. 5112. GRANTS TO LOCAL EDUCATIONAL AGENCIES
7	AND TRIBES.
8	"(a) In General.—In accordance with this section
9	and section 5113, the Secretary may make grants from
10	allocations made under section 5113, to—
11	"(1) local educational agencies;
12	"(2) Indian tribes;
13	"(3) Indian organizations; and
14	"(4) Alaska Native Organizations
15	"(b) Local Educational Agencies.—
16	"(1) Enrollment requirements.—A local
17	educational agency shall be eligible for a grant under
18	this subpart for any fiscal year if the number of In-
19	dian children eligible under section 5117 who were
20	enrolled in the schools of the agency, and to whom
21	the agency provided free public education, during
22	the preceding fiscal year—
23	"(A) was at least 10; or

1	"(B) constituted not less than 25 percent
2	of the total number of individuals enrolled in
3	the schools of such agency.
4	"(2) Exclusion.—The requirement of para-
5	graph (1) shall not apply in Alaska, California, or
6	Oklahoma, or with respect to any local educational
7	agency located on, or in proximity to, an Indian res-
8	ervation.
9	"(c) Indian Tribes, Indian Organizations, Alas-
10	KA NATIVE ORGANIZATIONS, AND CONSORTIA.—
11	"(1) IN GENERAL.—If a local educational agen-
12	cy that is otherwise eligible for a grant under this
13	subpart does not establish a committee under section
14	5114(c)(4) for such grant, an Indian tribe, Indian
15	organization, Alaska Native Organization, or consor-
16	tium of such entities that represents not less than
17	one-third of the eligible Indian or Alaska Native
18	children who are served by such local educational
19	agency may apply for such grant.
20	"(2) Special rule.—
21	"(A) IN GENERAL.—The Secretary shall
22	treat each Indian tribe, Indian organization,
23	Alaska Native Organization, or consortium of
24	such entities applying for a grant pursuant to

1	paragraph (1) as if such applicant were a local
2	educational agency for purposes of this subpart.
3	"(B) Exceptions.—Notwithstanding sub-
4	paragraph (A), such Indian tribe, Indian orga-
5	nization, Alaska Native Organization, or con-
6	sortium of such entities shall not be subject to
7	the requirements of section $5114(c)(5)$ or 5119 .
8	"(3) Eligibility.—If more than 1 applicant
9	qualifies to apply for a grant under paragraph (1),
10	the entity that represents the most eligible Indian
11	and Alaska Native children who are served by the
12	local educational agency shall be eligible to receive
13	the grant or the applicants may apply in consortium
14	and jointly operate a program.
15	"(d) Indian and Alaska Native Community-
16	Based Organizations.—
17	"(1) In general.—If no local educational
18	agency pursuant to subsection (b), and no Indian
19	tribe, tribal organization, Alaska Native Organiza-
20	tion, or consortium pursuant to subsection (c), ap-
21	plies for a grant under this subpart, Indian and
22	Alaska Native community-based organizations serv-
23	ing the community of the local educational agency
24	may apply for the grant.

1	"(2) APPLICABILITY OF SPECIAL RULE.—The
2	Secretary shall apply the special rule in subsection
3	(c)(2) to a community-based organization applying
4	or receiving a grant under paragraph (1) in the
5	same manner as such rule applies to an Indian tribe,
6	Indian organization, Alaska Native Organization, or
7	consortium.
8	"(3) Definition of Indian and Alaska Na-
9	TIVE COMMUNITY-BASED ORGANIZATIONS.—In this
10	subsection, the term 'Indian and Alaska Native com-
11	munity-based organizations' means any organiza-
12	tions that—
13	"(A) are composed primarily of the family
14	members of Indian or Alaska Native students,
15	Indian or Alaska Native community members,
16	tribal government education officials, and tribal
17	members from a specific community;
18	"(B) assist in the social, cultural, and edu-
19	cational development of Indians or Alaska Na-
20	tives in such community;
21	"(C) meet the unique cultural, language,
22	and academic needs of Indian or Alaska Native
23	students; and

1	"(D) demonstrate organizational and ad-
2	ministrative capacity to effectively manage the
3	grant.
4	"SEC. 5113. AMOUNT OF GRANTS.
5	"(a) Amount of Grant Awards.—
6	"(1) In general.—Except as provided in sub-
7	section (b) and paragraph (2), the Secretary shall
8	allocate to each local educational agency that has an
9	approved application under this subpart an amount
10	equal to the product of—
11	"(A) the number of Indian children who
12	are eligible under section 5117 and served by
13	such agency; and
14	"(B) the greater of—
15	"(i) the average per pupil expenditure
16	of the State in which such agency is lo-
17	cated; or
18	"(ii) 80 percent of the average per
19	pupil expenditure of all the States.
20	"(2) Reduction.—The Secretary shall reduce
21	the amount of each allocation otherwise determined
22	under this section in accordance with subsection (e).
23	"(b) Minimum Grant.—
24	"(1) In general.—Notwithstanding subsection
25	(e), an entity that is eligible for a grant under sec-

1	tion 5112, and a school that is operated or sup-
2	ported by the Bureau of Indian Education that is el-
3	igible for a grant under subsection (d), that submits
4	an application that is approved by the Secretary,
5	shall, subject to appropriations, receive a grant
6	under this subpart in an amount that is not less

8	"(2) Consortia.—Local educational agencies
9	may form a consortium for the purpose of obtaining
10	grants under this subpart.
11	"(3) Increase.—The Secretary may increase
12	the minimum grant under paragraph (1) to not
13	more than \$4,000 for all grantees if the Secretary
14	determines such increase is necessary to ensure the
15	quality of the programs provided.
16	"(c) Definition.—For the purpose of this section,
17	the term 'average per pupil expenditure', used with respect
18	to a State, means an amount equal to—
19	"(1) the sum of the aggregate current expendi-
20	tures of all the local educational agencies in the
21	State, plus any direct current expenditures by the
22	State for the operation of such agencies, without re-
23	gard to the sources of funds from which such local
24	or State expenditures were made, during the second

1	fiscal year preceding the fiscal year for which the
2	computation is made; divided by
3	"(2) the aggregate number of children who
4	were included in average daily attendance for whom
5	such agencies provided free public education during
6	such preceding fiscal year.
7	"(d) Schools Operated or Supported by the
8	BUREAU OF INDIAN EDUCATION.—
9	"(1) In general.—Subject to subsection (e),
10	in addition to the grants awarded under subsection
11	(a), the Secretary shall allocate to the Secretary of
12	the Interior an amount equal to the product of—
13	"(A) the total number of Indian children
14	enrolled in schools that are operated by—
15	"(i) the Bureau of Indian Education;
16	or
17	"(ii) an Indian tribe, or an organiza-
18	tion controlled or sanctioned by an Indian
19	tribal government, for the children of that
20	tribe under a contract with, or grant from,
21	the Department of the Interior under the
22	Indian Self-Determination Act or the Trib-
23	ally Controlled Schools Act of 1988; and
24	"(B) the greater of—

1	"(i) the average per pupil expenditure
2	of the State in which the school is located;

6	"(2) Special rule.—Any school described in
7	paragraph (1)(A) that wishes to receive an allocation
8	under this subpart shall submit an application in ac-
9	cordance with section 5114, and shall otherwise be
10	treated as a local educational agency for the purpose
11	of this subpart, except that such school shall not be
12	subject to section $5114(c)(5)$ or section 5119 .
13	"(e) Ratable Reductions.—If the sums appro-
14	priated for any fiscal year to carry out this subpart are
15	insufficient to pay in full the amounts determined for local
16	educational agencies under subsection (a)(1) and for the
17	Secretary of the Interior under subsection (d), each of
18	those amounts shall be ratably reduced.
19	"SEC. 5114. APPLICATIONS.
20	"(a) Application Required.—Each local edu-
21	cational agency that desires to receive a grant under this
22	subpart shall submit an application to the Secretary at
23	such time, in such manner, and containing such informa-
24	tion as the Secretary may reasonably require.

1	"(b) Comprehensive Program Required.—Each
2	application submitted under subsection (a) shall include
3	a description of a comprehensive program for meeting the
4	needs of Indian and Alaska Native children served by the
5	local educational agency, including the language and cul-
6	tural needs of the children, that—
7	"(1) describes how the comprehensive program
8	will offer programs and activities to meet the cul-
9	turally related academic needs of American Indian
10	and Alaska Native students;
11	"(2)(A) is consistent with the State, tribal, and
12	local plans submitted under other provisions of this
13	Act; and
14	"(B) includes academic content and stu-
15	dent academic achievement goals for such chil-
16	dren, and benchmarks for attaining such goals,
17	that are based on State academic content and
18	student academic achievement standards adopt-
19	ed under title I for all children;
20	"(3) explains how the local educational agency
21	will use the funds made available under this subpart
22	to supplement other Federal, State, and local pro-
23	grams that serve such students;

1	"(4) demonstrates how funds made available
2	under this subpart will be used for activities de-
3	scribed in section 5115;
4	"(5) describes the professional development op-
5	portunities that will be provided, as needed, to en-
6	sure that—
7	"(A) teachers and other school profes-
8	sionals who are new to the Indian or Alaska
9	Native community are prepared to work with
10	Indian and Alaska Native children;
11	"(B) all teachers who will be involved in
12	programs assisted under this subpart have been
13	properly trained to carry out such programs;
14	and
15	"(C) those family members of Indian and
16	Alaska Native children and representatives of
17	tribes who are on the committee described in
18	(c)(5) will participate in the planning of profes-
19	sional development materials;
20	"(6) describes how the local educational agen-
21	cy—
22	"(A) will periodically assess the progress of
23	all Indian children enrolled in the schools of the
24	local educational agency, including Indian chil-
25	dren who do not participate in programs as-

1	sisted under this subpart, in meeting the goals
2	described in paragraph (2);
3	"(B) will provide the results of each as-
4	sessment referred to in subparagraph (A) to—
5	"(i) the committee described in sub-
6	section $(c)(5)$;
7	"(ii) the community served by the
8	local educational agency; and
9	"(iii) the tribes whose children are
10	served by the local educational agency;
11	"(C) is responding to findings of any pre-
12	vious assessments that are similar to the as-
13	sessments described in subparagraph (A); and
14	"(7) explicitly delineates—
15	"(A) a formal, collaborative process that
16	the local educational agency used to directly in-
17	volve tribes, Indian organizations, or Alaska
18	Native Organizations in the development of the
19	comprehensive programs and the results of such
20	process; and
21	"(B) how the local educational agency
22	plans to ensure that tribes, Indian organiza-
23	tions, or Alaska Native Organizations will play
24	an active, meaningful, and ongoing role in the
25	functioning of the comprehensive programs.

1	"(c) Assurances.—Each application submitted
2	under subsection (a) shall include assurances that—
3	"(1) the local educational agency will use funds
4	received under this subpart only to supplement the
5	funds that, in the absence of the Federal funds
6	made available under this subpart, such agency
7	would make available for services described in this
8	subsection, and not to supplant such funds;
9	"(2) the local educational agency will use funds
10	received under this subpart only for activities de-
11	scribed and authorized under this subpart;
12	"(3) the local educational agency will prepare
13	and submit to the Secretary such reports, in such
14	form and containing such information, as the Sec-
15	retary may require to—
16	"(A) carry out the functions of the Sec-
17	retary under this subpart; and
18	"(B) determine the extent to which activi-
19	ties carried out with funds provided to the local
20	educational agency under this subpart are effec-
21	tive in improving the educational achievement
22	of Indian and Alaska Native students served by
23	such agency; and

1	"(C) determine the extent to which such
2	activities address the unique cultural, language,
3	and educational needs of Indian students;
4	"(4) the program for which assistance is
5	sought—
6	"(A) is based on a comprehensive local as-
7	sessment and prioritization of the unique edu-
8	cational and culturally related academic needs
9	of the American Indian and Alaska Native stu-
10	dents for whom the local educational agency is
11	providing an education;
12	"(B) will use the best available talents and
13	resources, including individuals from the Indian
14	or Alaska Native community; and
15	"(C) was developed by such agency in open
16	consultation with the families of Indian or Alas-
17	ka Native children, Indian or Alaska Native
18	teachers, Indian or Alaska Native students
19	from secondary schools, and representatives of
20	tribes, Indian organizations, or Alaska Native
21	Organizations in the community including
22	through public hearings held by such agency to
23	provide to the individuals described in this sub-
24	paragraph a full opportunity to understand the

1	program and to offer recommendations regard-
2	ing the program;
3	"(5) the local educational agency developed the
4	program with the participation and written approval
5	of a committee—
6	"(A) that is composed of, and selected
7	by—
8	"(i) family members of Indian and
9	Alaska Native children that are attending
10	the local educational agency's schools;
11	"(ii) teachers in the schools; and
12	"(iii) Indian and Alaska Native stu-
13	dents attending secondary schools of the
14	agency;
15	"(B) a majority of whose members are
16	family members of Indian and Alaska Native
17	children that are attending the local educational
18	agency's schools;
19	"(C) that has set forth such policies and
20	procedures, including policies and procedures
21	relating to the hiring of personnel, as will en-
22	sure that the program for which assistance is
23	sought will be operated and evaluated in con-
24	sultation with, and with the involvement of,

1	parents of the children, and representatives of
2	the area, to be served;
3	"(D) with respect to an application de-
4	scribing a schoolwide program in accordance
5	with section 5115(c), that has—
6	"(i) reviewed in a timely fashion the
7	program;
8	"(ii) determined that the program will
9	not diminish the availability of culturally
10	related activities for American Indian and
11	Alaska Native students; and
12	"(iii) will directly enhance the edu-
13	cational experience of American Indian and
14	Alaska Native students; and
15	"(E) that has adopted reasonable by laws
16	for the conduct of the activities of the com-
17	mittee and abides by such bylaws; and
18	"(6) the local educational agency conducted
19	adequate outreach to family members to meet the
20	requirements under subsection (c)(5).
21	"SEC. 5115. AUTHORIZED SERVICES AND ACTIVITIES.
22	"(a) General Requirements.—Each local edu-
23	cational agency that receives a grant under this subpart
24	shall use the grant funds, in a manner consistent with the

1	purpose specified in section 5111, for services and activi-
2	ties that—
3	"(1) are designed to carry out the comprehen-
4	sive program of the local educational agency for In-
5	dian students, and described in the application of
6	the local educational agency submitted to the Sec-
7	retary under section 5114(a) solely for the services
8	and activities described in such application;
9	"(2) are designed with special regard for the
10	language and cultural needs of the Indian students;
11	and
12	"(3) supplement and enrich the regular school
13	program of such agency.
14	"(b) Particular Activities.—The services and ac-
15	tivities referred to in subsection (a) may include—
16	"(1) activities that support Native American
17	language immersion programs and Native American
18	language restoration programs, which may be taught
19	by traditional leaders;
20	"(2) culturally related activities that support
21	the program described in the application submitted
22	by the local educational agency;
23	"(3) early childhood and family programs that
24	emphasize school readiness;

1	"(4) enrichment programs that focus on prob-
2	lem solving and cognitive skills development and di-
3	rectly support the attainment of challenging State
4	academic content and student academic achievement
5	standards;
6	"(5) integrated educational services in combina-
7	tion with other programs including programs that
8	enhance student achievement by promoting increased
9	involvement of parents and families in school activi-
10	ties;
11	"(6) career preparation activities to enable In-
12	dian students to participate in programs such as the
13	programs supported by the Carl D. Perkins Career
14	and Technical Education Improvement Act of 2006,
15	including programs for tech-prep education, men-
16	toring, and apprenticeship;
17	"(7) activities to educate individuals so as to
18	prevent violence, suicide, and substance abuse;
19	"(8) the acquisition of equipment, but only if
20	the acquisition of the equipment is essential to
21	achieve the purpose described in section 5111;
22	"(9) activities that promote the incorporation of
23	culturally responsive teaching and learning strategies
24	into the educational program of the local educational
25	agency;

1	"(10) activities that incorporate culturally and
2	linguistically relevant curriculum content into class-
3	room instruction that is responsive to the unique
4	learning styles of Indian and Alaska Native children
5	and ensures that children are better able to meet
6	State standards;
7	"(11) family literacy services;
8	"(12) activities that recognize and support the
9	unique cultural and educational needs of Indian chil-
10	dren, and incorporate appropriately qualified tribal
11	elders and seniors;
12	"(13) dropout prevention strategies for Indian
13	and Alaska Native students; and
14	"(14) strategies to meet the educational needs
15	of at-risk Indian students in correctional facilities,
16	including such strategies that support Indian and
17	Alaska Native students who are transitioning from
18	such facilities to schools served by local educational
19	agencies.
20	"(c) Schoolwide Programs.—Notwithstanding
21	any other provision of law, a local educational agency may

1	"(1) the committee established pursuant to sec-
2	tion 5114(c)(5) approves the use of the funds for

12	"(d) Limitation on Administrative Costs.—Not
13	more than 5 percent of the funds provided to a grantee
14	under this subpart for any fiscal year may be used for
15	administrative purposes.
16	"(e) Limitation on the Use of Funds.—Funds
17	provided to a grantee under this subpart may not be used
18	for long-distance travel expenses for training activities
19	available locally or regionally.
20	"SEC. 5116. INTEGRATION OF SERVICES AUTHORIZED.
21	"(a) Plan.—An entity receiving funds under this
22	subpart may submit a plan to the Secretary for the inte-
23	gration of education and related services provided to In-
24	dian students.

1	"(b) Consolidation of Programs.—Upon the re-
2	ceipt of an acceptable plan under subsection (a), the Sec-
3	retary, in cooperation with each Federal agency providing
4	grants for the provision of education and related services
5	to the entity, shall authorize the entity to consolidate, in
6	accordance with such plan, the federally funded education
7	and related services programs of the entity and the Fed-
8	eral programs, or portions of the programs, serving Indian
9	students in a manner that integrates the program services
10	involved into a single, coordinated, comprehensive pro-
11	gram and reduces administrative costs by consolidating
12	administrative functions.
13	"(c) Programs Affected.—The funds that may be
14	consolidated in a demonstration project under any such
15	plan referred to in subsection (a) shall include funds for
16	any Federal program exclusively serving Indian children,
17	or the funds reserved under any Federal program to exclu-
18	sively serve Indian children, under which the entity is eligi-
19	ble for receipt of funds under a statutory or administrative
20	formula for the purposes of providing education and re-
21	lated services that would be used to serve Indian students.
22	"(d) Plan Requirements.—For a plan to be ac-
23	ceptable pursuant to subsection (b), the plan shall—
24	"(1) identify the programs or funding sources
25	to be consolidated;

1	"(2) be consistent with the objectives of this
2	section concerning authorizing the services to be in-
3	tegrated in a demonstration project;
4	"(3) describe a comprehensive strategy that
5	identifies the full range of potential educational op-
6	portunities and related services to be provided to as-
7	sist Indian students to achieve the objectives set
8	forth in this subpart;
9	"(4) describe the way in which services are to
10	be integrated and delivered and the results expected
11	from the plan;
12	"(5) identify the projected expenditures under
13	the plan in a single budget;
14	"(6) identify the State, tribal, or local agency
15	or agencies to be involved in the delivery of the serv-
16	ices integrated under the plan;
17	"(7) identify any statutory provisions, regula-
18	tions, policies, or procedures that the entity believes
19	need to be waived in order to implement the plan;
20	"(8) set forth measures for academic content
21	and student academic achievement goals designed to
22	be met within a specific period of time; and
23	"(9) be approved by a committee formed in ac-
24	cordance with section $5114(c)(5)$, if such a com-
25	mittee exists.

1	"(e) Plan Review.—Upon receipt of the plan from
2	an eligible entity, the Secretary shall consult with the Sec-
3	retary of each Federal department providing funds to be
4	used to implement the plan, and with the entity submit-
5	ting the plan. The parties so consulting shall identify any
6	waivers of statutory requirements or of Federal depart-
7	mental regulations, policies, or procedures necessary to en-
8	able the entity to implement the plan. Notwithstanding
9	any other provision of law, the Secretary of the affected
10	department shall have the authority to waive any regula-
11	tion, policy, or procedure promulgated by that department
12	that has been so identified by the entity or department,
13	unless the Secretary of the affected department deter-
14	mines that such a waiver is inconsistent with the objectives
15	of this subpart or those provisions of the statute from
16	which the program involved derives authority that are spe-
17	cifically applicable to Indian students.
18	"(f) Plan Approval.—Within 90 days after the re-
19	ceipt of an entity's plan by the Secretary, the Secretary
20	shall inform the entity, in writing, of the Secretary's ap-
21	proval or disapproval of the plan. If the plan is dis-
22	approved, the entity shall be informed, in writing, of the
23	reasons for the disapproval and shall be given an oppor-
24	tunity to amend the plan or to petition the Secretary to
25	reconsider such disapproval.

1	"(g) Responsibilities of Department of Edu-
2	CATION.—Not later than 180 days after the date of enact-
3	ment of the Student Success Act, the Secretary of Edu-
4	cation, the Secretary of the Interior, the Secretary of the
5	Department of Health and Human Services, and the head
6	of any other Federal department or agency identified by
7	the Secretary of Education, shall enter into an inter-

1	"(2) the use of a single report format related
2	to the projected expenditures for the individual
3	project which shall be used by an eligible entity to
4	report on all project expenditures;
5	"(3) the development of a single system of Fed-
6	eral oversight for the project, which shall be imple-
7	mented by the lead agency; and
8	"(4) the provision of technical assistance to an
9	eligible entity appropriate to the project, except that
10	an eligible entity shall have the authority to accept
11	or reject the plan for providing such technical assist-
12	ance and the technical assistance provider.
13	"(i) Report Requirements.—A single report for-
14	mat shall be developed by the Secretary, consistent with
15	the requirements of this section. Such report format shall
16	require that reports described in subsection (h), together
17	with records maintained on the consolidated program at
18	the local level, shall contain such information as will allow
19	a determination that the eligible entity has complied with
20	the requirements incorporated in its approved plan, in-
21	cluding making a demonstration of student academic
22	achievement, and will provide assurances to each Sec-
23	retary that the eligible entity has complied with all directly
24	applicable statutory requirements and with those directly

1	applicable regulatory requirements that have not been
2	waived.
3	"(j) No Reduction in Amounts.—In no case shall
4	the amount of Federal funds available to an eligible entity
5	involved in any demonstration project be reduced as a re-
6	sult of the enactment of this section.
7	"(k) Interagency Fund Transfers Author-
8	IZED.—The Secretary is authorized to take such action
9	as may be necessary to provide for an interagency transfer
10	of funds otherwise available to an eligible entity in order
11	to further the objectives of this section.
12	"(l) Administration of Funds.—
13	"(1) IN GENERAL.—Program funds for the con-
14	solidated programs shall be administered in such a
15	manner as to allow for a determination that funds
16	from a specific program are spent on allowable ac-
17	tivities authorized under such program, except that
18	the eligible entity shall determine the proportion of
19	the funds granted that shall be allocated to such
20	program.
21	"(2) Separate records not required.—
22	Nothing in this section shall be construed as requir-
23	ing the eligible entity to maintain separate records
24	tracing any services or activities conducted under
25	the approved plan to the individual programs under

1	which funds were authorized for the services or ac-
2	tivities, nor shall the eligible entity be required to al-
3	locate expenditures among such individual programs.
4	"(m) Overage.—The eligible entity may commingle
5	all administrative funds from the consolidated programs
6	and shall be entitled to the full amount of such funds
7	(under each program's or agency's regulations). The over-
8	age (defined as the difference between the amount of the
9	commingled funds and the actual administrative cost of
10	the programs) shall be considered to be properly spent for
11	Federal audit purposes, if the overage is used for the pur-

13	"(n) FISCAL ACCOUNTABILITY.—Nothing in this
14	part shall be construed so as to interfere with the ability
15	of the Secretary or the lead agency to fulfill the respon-
16	sibilities for the safeguarding of Federal funds pursuant
17	to chapter 75 of title 31, United States Code.
18	"(o) Report on Statutory Obstacles to Pro-
19	GRAM INTEGRATION.—
20	"(1) Preliminary report.—Not later than 2
21	years after the date of enactment of the Student
22	Success Act, the Secretary of Education shall submit
23	a preliminary report to the Committee on Education
24	and the Workforce and the Committee on Natural
25	Resources of the House of Representatives and the

1	Committee on Health, Education, Labor, and Pen-
2	sions and the Committee on Indian Affairs of the
3	Senate on the status of the implementation of the
4	demonstration projects authorized under this sec-
5	tion.
6	"(2) Final Report.—Not later than 5 years
7	after the date of enactment of the Student Success
8	Act, the Secretary of Education shall submit a re-
9	port to the Committee on Education and the Work-
10	force and the Committee on Natural Resources of
11	the House of Representatives and the Committee on
12	Health, Education, Labor, and Pensions and the
13	Committee on Indian Affairs of the Senate on the
14	results of the implementation of the demonstration
15	projects authorized under this section. Such report
16	shall identify statutory barriers to the ability of par-
17	ticipants to integrate more effectively their education
18	and related services to Indian students in a manner
19	consistent with the objectives of this section.
20	"(p) Definitions.—For the purposes of this section,
21	the term 'Secretary' means—
22	"(1) the Secretary of the Interior, in the case
23	of an entity meeting the definition of a contract or
24	grant school under title XI of the Education Amend-
25	ments of 1978; or

1	"(2) the Secretary of Education, in the case of
2	any other entity.
3	"SEC. 5117. STUDENT ELIGIBILITY FORMS.
4	"(a) In General.—The Secretary shall require that,
5	as part of an application for a grant under this subpart,
6	each applicant shall maintain a file, with respect to each
7	Indian child for whom the local educational agency pro-
8	vides a free public education, that contains a form that
9	sets forth information establishing the status of the child
10	as an Indian child eligible for assistance under this sub-
11	part, and that otherwise meets the requirements of sub-
12	section (b).
13	"(b) Forms.—The form described in subsection (a)
14	shall include—
15	"(1) either—
16	"(A)(i) the name of the tribe or band of
17	Indians (as defined in section 5151) with re-
18	spect to which the child claims membership;
19	"(ii) the enrollment or membership number
20	establishing the membership of the child (if
21	readily available); and
22	"(iii) the name and address of the organi-
23	zation that maintains updated and accurate
24	membership data for such tribe or band of Indi-
25	ans; or

1	"(B) the name, the enrollment or member-
2	ship number (if readily available), and the name
3	and address of the organization responsible for
4	maintaining updated and accurate membership
5	data, of any parent or grandparent of the child
6	from whom the child claims eligibility under
7	this subpart, if the child is not a member of the
8	tribe or band of Indians (as so defined);
9	"(2) a statement of whether the tribe or band
10	of Indians (as so defined), with respect to which the
11	child, or parent or grandparent of the child, claims
12	membership, is federally recognized;
13	"(3) the name and address of the parent or
14	legal guardian of the child;
15	"(4) a signature of the parent or legal guardian
16	of the child that verifies the accuracy of the informa-
17	tion supplied; and
18	"(5) any other information that the Secretary
19	considers necessary to provide an accurate program
20	profile.
21	"(c) Statutory Construction.—Nothing in this
22	section shall be construed to affect a definition contained
23	in section 5151.
24	"(d) Documentation and Types of Proof.—

1	"(1) Types of proof.—For purposes of deter-
2	mining whether a child is eligible to be counted for
3	the purpose of computing the amount of a grant
4	award under section 5113, the membership of the
5	child, or any parent or grandparent of the child, in
6	a tribe or band of Indians (as so defined) may be
7	established by proof other than an enrollment num-
8	ber, notwithstanding the availability of an enroll-
9	ment number for a member of such tribe or band.
10	Nothing in subsection (b) shall be construed to re-
11	quire the furnishing of an enrollment number.
12	"(2) No new or duplicative determina-
13	TIONS.—Once a child is determined to be an Indian
14	eligible to be counted for such grant award, the local
15	education agency shall maintain a record of such de-
16	termination and shall not require a new or duplicate
17	determination to be made for such child for a subse-
18	quent application for a grant under this subpart.
19	"(3) Previously filed forms.—An Indian
20	student eligibility form that was on file as required
21	by this section on the day before the date of enact-
22	ment of the Student Success Act and that met the
23	requirements of this section, as this section was in
24	effect on the day before the date of enactment of

such Act, shall remain valid for such Indian student.

1	"(e) Monitoring and Evaluation Review.—
2	"(1) In general.—
3	"(A) Review.—For each fiscal year, in
4	order to provide such information as is nec-
5	essary to carry out the responsibility of the Sec-
6	retary to provide technical assistance under this
7	subpart, the Secretary shall conduct a moni-
8	toring and evaluation review of a sampling of
9	the recipients of grants under this subpart. The
10	sampling conducted under this subparagraph
11	shall take into account the size of and the geo-
12	graphic location of each local educational agen-

14	"(B) Exception.—A local educational
15	agency may not be held liable to the United
16	States or be subject to any penalty, by reason
17	of the findings of an audit that relates to the
18	date of completion, or the date of submission,
19	of any forms used to establish, before April 28,

21	ment under the Indian Elementary and Sec-
22	ondary School Assistance Act.
23	"(2) False information.—Any local edu-
24	cational agency that provides false information in an
25	application for a grant under this subpart shall—

3	"(B) be liable to the United States for any
4	funds from the grant that have not been ex-
5	pended.
6	"(3) EXCLUDED CHILDREN.—A student who
7	provides false information for the form required

9	purpose of computing the amount of a grant under
10	section 5113.
11	"(f) Tribal Grant and Contract Schools.—
12	Notwithstanding any other provision of this section, in cal-
13	culating the amount of a grant under this subpart to a
14	tribal school that receives a grant or contract from the
15	Bureau of Indian Education, the Secretary shall use only
16	one of the following, as selected by the school:
17	"(1) A count of the number of students in the
18	schools certified by the Bureau.
19	"(2) A count of the number of students for
20	whom the school has eligibility forms that comply
21	with this section.
22	"(g) Timing of Child Counts.—For purposes of
23	determining the number of children to be counted in calcu-
24	lating the amount of a local educational agency's grant

1	under this subpart (other than in the case described in
2	subsection $(f)(1)$, the local educational agency shall—
3	"(1) establish a date on, or a period not longer
4	than 31 consecutive days during, which the agency
5	counts those children, if that date or period occurs
6	before the deadline established by the Secretary for
7	submitting an application under section 5114; and
8	"(2) determine that each such child was en-
9	rolled, and receiving a free public education, in a
10	school of the agency on that date or during that pe-
11	riod, as the case may be.
12	"SEC. 5118. PAYMENTS.
13	"(a) In General.—Subject to subsection (b), the
14	Secretary shall pay to each local educational agency that
15	submits an application that is approved by the Secretary
16	under this subpart the amount determined under section
17	5113. The Secretary shall notify the local educational
18	agency of the amount of the payment not later than June
19	1 of the year for which the Secretary makes the payment.
20	"(b) Payments Taken Into Account by the
21	STATE.—The Secretary may not make a grant under this

bility of the local educational agency for State aid, or the amount of the State aid, with respect to the free public education of children during such fiscal year or the pre-3 4 ceding fiscal year. 5 "(c) Reallocations.—The Secretary may reallocate, in a manner that the Secretary determines will best 6 7 carry out the purpose of this subpart, any amounts that— 8 "(1) based on estimates made by local edu-9 cational agencies or other information, the Secretary 10 determines will not be needed by such agencies to 11 carry out approved programs under this subpart; or 12 "(2) otherwise become available for reallocation 13 under this subpart. 14 "SEC. 5119. STATE EDUCATIONAL AGENCY REVIEW. 15 "Before submitting an application to the Secretary under section 5114, a local educational agency shall sub-16 17 mit the application to the State educational agency, which may comment on such application. If the State educational 18 19 agency comments on the application, the agency shall com-20 ment on all applications submitted by local educational 21 agencies in the State and shall provide those comments to the respective local educational agencies, with an oppor-22

8	"(1) In general.—It is the purpose of this
9	section to support projects to develop, test, and dem-

11	to improve educational opportunities and achieve-
12	ment of Indian children and youth.
13	"(2) COORDINATION.—The Secretary shall take
14	the necessary actions to achieve the coordination of
15	activities assisted under this subpart with—
16	"(A) other programs funded under this
17	Act; and
18	"(B) other Federal programs operated for
19	the benefit of American Indian and Alaska Na-
20	tive children and youth.
21	"(b) Eligible Entities.—In this section, the term
22	'eligible entity' means a State educational agency, local
23	educational agency, Indian tribe, Indian organization, fed-
24	erally supported elementary school or secondary school for
25	Indian students, Indian institution (including an Indian

1	institution of higher education), Alaska Native Organiza-
2	tion, or a consortium of such entities.
3	"(c) Grants Authorized.—
4	"(1) In general.—The Secretary shall award
5	grants to eligible entities to enable such entities to
6	carry out activities that meet the purpose of this
7	section, including—
8	"(A) innovative programs related to the
9	educational needs of educationally disadvan-
10	taged children and youth;
11	"(B) educational services that are not
12	available to such children and youth in suffi-
13	cient quantity or quality, including remedial in-
14	struction, to raise the achievement of Indian
15	and Alaska Native children in one or more of
16	the core academic subjects of English, mathe-
17	matics, science, foreign languages, art, history,
18	and geography;
19	"(C) bilingual and bicultural programs and
20	projects;
21	"(D) special health and nutrition services,
22	and other related activities, that address the
23	special health, social, emotional, and psycho-
24	logical problems of Indian children;

1	"(E) special compensatory and other pro-
2	grams and projects designed to assist and en-
3	courage Indian children to enter, remain in, or
4	reenter school, and to increase the rate of high
5	school graduation for Indian children;
6	"(F) comprehensive guidance, counseling,
7	and testing services;
8	"(G) high quality early childhood education
9	programs that are effective in preparing young
10	children to make sufficient academic growth by
11	the end of grade 3, including kindergarten and
12	pre-kindergarten programs, family-based pre-
13	school programs that emphasize school readi-
14	ness, screening and referral, and the provision
15	of services to Indian children and youth with
16	disabilities;
17	"(H) partnership projects between local
18	educational agencies and institutions of higher
19	education that allow secondary school students
20	to enroll in courses at the postsecondary level to
21	aid such students in the transition from sec-
22	ondary to postsecondary education;
23	"(I) partnership projects between schools
24	and local businesses for career preparation pro-
25	grams designed to provide Indian youth with

1	the knowledge and skills such youth need to
2	make an effective transition from school to a
3	high-skill, high-wage career;
4	"(J) programs designed to encourage and
5	assist Indian students to work toward, and gain
6	entrance into, an institution of higher edu-
7	cation;
8	"(K) family literacy services;
9	"(L) activities that recognize and support
10	the unique cultural and educational needs of In-
11	dian children, and incorporate appropriately
12	qualified tribal elders and seniors;
13	"(M) high quality professional development
14	of teaching professionals and paraprofessionals;
15	or
16	"(N) other services that meet the purpose
17	described in this section.
18	"(d) Grant Requirements and Applications.—
19	"(1) Grant requirements.—
20	"(A) IN GENERAL.—The Secretary may
21	make multiyear grants under subsection (c) for
22	the planning, development, pilot operation, or
23	demonstration of any activity described in sub-
24	section (c) for a period not to exceed 5 years.

1	"(B) Priority.—In making multiyear
2	grants described in this paragraph, the Sec-
3	retary shall give priority to entities submitting
4	applications that present a plan for combining
5	two or more of the activities described in sub-
6	section (c) over a period of more than 1 year.
7	"(C) Progress.—The Secretary shall
8	make a grant payment for a grant described in
9	this paragraph to an eligible entity after the

1	in any national evaluation of activities as-

3	"(iii) information demonstrating that
4	the proposed program for the activities is
5	a scientifically based research program,
6	where applicable, which may include a pro-
7	gram that has been modified to be cul-
8	turally appropriate for students who will be
9	served;
10	"(iv) a description of how the appli-
11	cant will incorporate the proposed activities
12	into the ongoing school program involved
13	once the grant period is over; and
14	"(v) such other assurances and infor-
15	mation as the Secretary may reasonably
16	require.
17	"(e) Administrative Costs.—Not more than 5 per-
18	cent of the funds provided to a grantee under this subpart
19	for any fiscal year may be used for administrative pur-
20	poses.
21	"SEC. 5122. PROFESSIONAL DEVELOPMENT FOR TEACHERS
22	AND EDUCATION PROFESSIONALS.
23	"(a) Purposes.—The purposes of this section are—

1	"(1) to increase the number of qualified Indian
2	and Alaska Native teachers and administrators serv-
3	ing Indian and Alaska Native students;
4	"(2) to provide training to qualified Indian and
5	Alaska Native individuals to become educators and
6	education support service professionals; and
7	"(3) to improve the skills of qualified Indian in-
8	dividuals who serve in the capacities described in
9	paragraph (2).
10	"(b) Eligible Entities.—For the purpose of this
11	section, the term 'eligible entity' means—
12	"(1) an institution of higher education, includ-
13	ing an Indian institution of higher education;

17	"(3) an Indian tribe or organization, in consor-
18	tium with an institution of higher education; and

23	"(i) providing programs of study, both
24	on site and in local schools, to share the
25	rich and diverse cultures of Alaska Native

1	peoples among youth, elders, teachers, and
2	the larger community;
3	"(ii) instructing Alaska Native youth
4	in leadership, communication, Native cul-
5	ture, arts, and languages;
6	"(iii) increasing the high school grad-
7	uation rate of Alaska Native students who
8	are served;
9	"(iv) providing instruction in Alaska
10	Native history and ways of living to stu-
11	dents and teachers in the local school dis-
12	trict;
13	"(v) providing intergenerational learn-
14	ing and internship opportunities to Alaska
15	Native youth and young adults; and
16	"(vi) providing cultural immersion ac-
17	tivities aimed at Alaska Native cultural
18	preservation.
19	"(H) Statewide on-site exchange programs,
20	for both students and teachers, that work to fa-
21	cilitate cultural relationships between urban and
22	rural Alaskans to build mutual respect and un-
23	derstanding, and foster a statewide sense of
24	common identity through host family, school,
25	and community cross-cultural immersion.

1	"(I) Education programs for at-risk urban
2	Alaska Native students in kindergarten through
3	grade 12 that work to increase graduation rates
4	among such students and that—
5	"(i) include culturally-informed cur-
6	riculum intended to preserve and promote
7	Alaska Native culture;
8	"(ii) partner effectively with the local
9	school district by providing a school-within-
10	a school program model;
11	"(iii) provide high-quality academic
12	instruction, small classroom sizes, and so-
13	cial-emotional support for students from
14	elementary school through high school, in-
15	cluding residential support;
16	"(iv) work with parents to increase
17	parental involvement in their students'
18	education;
19	"(v) work to improve academic pro-
20	ficiency and increase graduation rates;
21	"(vi) provide college preparation and
22	career planning; and
23	"(vii) incorporate a strong data collec-
24	tion and continuous evaluation component
25	at all levels of the program.

1	"(J) Statewide programs that provide tech-
2	nical assistance and support to schools and
3	communities to engage adults in promoting the
4	academic progress and overall well-being of
5	Alaska Native people through child and youth
6	development, positive youth-adult relationships,
7	improved conditions for learning (school cli-
8	mate, student connection to school and commu-
9	nity), and increased connections between
10	schools and families.
11	"(K) Career preparation activities to en-
12	able Alaska Native children and adults to pre-
13	pare for meaningful employment, including pro-
14	grams providing tech-prep, mentoring, training,
15	and apprenticeship activities.
16	"(L) Support for the development and
17	operational activities of regional vocational
18	schools in rural areas of Alaska to provide stu-
19	dents with necessary resources to prepare for
20	skilled employment opportunities.
21	"(M) Other activities, consistent with the
22	purposes of this part, to meet the educational
23	needs of Alaska Native children and adults.
24	"(N) Regional leadership academies that
25	demonstrate effectiveness in building respect,

1	understanding, and fostering a sense of Alaska
2	Native identity to promote their pursuit of and
3	success in completing higher education or ca-
4	reer training.
5	"(b) Limitation on Administrative Costs.—Not
6	more than 5 percent of funds provided to an award recipi-
7	ent under this part for any fiscal year may be used for
8	administrative purposes.
9	"(c) Priorities.—In awarding grants or contracts
10	to carry out activities described in this subpart, the Sec-
11	retary shall give priority to applications from Alaska Na-
12	tive Organizations. Such priority shall be explicitly delin-
13	eated in the Secretary's process for evaluating applications
14	and applied consistently and transparently to all applica-
15	tions from Alaska Native Organizations.
16	"(d) Authorization of Appropriations.—There
17	are authorized to be appropriated to carry out this part
18	\$33,185,000 for each of fiscal years 2016 through 2021.
19	"SEC. 5205. ADMINISTRATIVE PROVISIONS.
20	"(a) Application Required.—
21	"(1) In General.—No grant may be made
22	under this part, and no contract may be entered into
23	under this part, unless the Alaska Native organiza-
24	tion or entity seeking the grant or contract submits
25	an application to the Secretary in such form, in such

1	manner, and containing such information as the Sec-
2	retary may determine necessary to carry out the pro-
3	visions of this part.
4	"(2) Requirement for certain appli-
5	CANTS.—An applicant described in section
6	5204(a)(2) shall, in the application submitted under
7	this paragraph—
8	"(A) demonstrate that an Alaska Native
9	organization was directly involved in the devel-
10	opment of the program for which the applica-
11	tion seeks funds and explicitly delineate the
12	meaningful role that the Alaska Native organi-
13	zation will play in the implementation and eval-
14	uation of the program for which funding is
15	sought; and
16	"(B) provide a copy of the Alaska Native
17	organization's governing document.
18	"(b) Consultation Required.—Each applicant for
19	an award under this part shall provide for ongoing advice
20	from and consultation with representatives of the Alaska
21	Native community.
22	"(c) Local Educational Agency Coordina-
23	TION.—Each applicant for an award under this part shall
24	inform each local educational agency serving students who

1	would participate in the program to be carried out under
2	the grant or contract about the application.
3	"(d) Continuation Awards.—An applicant de-
4	scribed in section 5204(a)(2) that receives funding under
5	this part shall periodically demonstrate to the Secretary,
6	during the term of the award, that the applicant is con-
7	tinuing to meet the requirements of subsection (a)(2)(A).
8	"SEC. 5206. DEFINITIONS.
9	"In this part:
10	"(1) Alaska native.—The term 'Alaska Na-
11	tive' has the same meaning as the term 'Native' has
12	in section 3(b) of the Alaska Native Claims Settle-
13	ment Act and their descendants.
14	"(2) Alaska native organization.—The
15	term 'Alaska Native organization' means a federally
16	recognized tribe, consortium of tribes, regional non-
17	profit Native association, and an organization,
18	that—
19	"(A) has or commits to acquire expertise
20	in the education of Alaska Natives; and
21	"(B) has Alaska Natives in substantive
22	and policymaking positions within the organiza-
23	tion.

1	"PART C—NATIVE HAWAHAN EDUCATION
2	"SEC. 5301. FINDINGS.
3	"Congress finds the following:
4	"(1) Native Hawaiians are a distinct and
5	unique indigenous people with a historical continuity
6	to the original inhabitants of the Hawaiian archi-
7	pelago, whose society was organized as a nation and
8	internationally recognized as a nation by the United
9	States, and many other countries.
10	"(2) Native Hawaiians have a cultural, historic,
11	and land-based link to the indigenous people who ex-
12	ercised sovereignty over the Hawaiian Islands.
13	"(3) The political status of Native Hawaiians is
14	comparable to that of American Indians and Alaska
15	Natives.
16	"(4) The political relationship between the
17	United States and the Native Hawaiian people has
18	been recognized and reaffirmed by the United
19	States, as evidenced by the inclusion of Native Ha-
20	waiians in many Federal statutes, including—
21	"(A) the Native American Programs Act of
22	1974 (42 U.S.C. 2991 et seq.);
23	"(B) Public Law 95–341 (commonly
24	known as the 'American Indian Religious Free-
25	dom Act' (42 U.S.C. 1996));

1	"(C) the National Museum of the Amer-
2	ican Indian Act (20 U.S.C. 80q et seq.);
3	"(D) the Native American Graves Protec-
4	tion and Repatriation Act (25 U.S.C. 3001 et
5	seq.);
6	"(E) the National Historic Preservation
7	Act (16 U.S.C. 470 et seq.);
8	"(F) the Native American Languages Act
9	(25 U.S.C. 2901 et seq.);
10	"(G) the American Indian, Alaska Native,
11	and Native Hawaiian Culture and Art Develop-
12	ment Act (20 U.S.C. 4401 et seq.);
13	"(H) the Workforce Investment Act of
14	1998 (29 U.S.C. 2801 et seq.); and
15	"(I) the Older Americans Act of 1965 (42
16	U.S.C. 3001 et seq.).
17	"(5) Many Native Hawaiian students lag be-
18	hind other students in terms of—
19	"(A) school readiness factors;
20	"(B) scoring below national norms on edu-
21	cation achievement tests at all grade levels;
22	"(C) underrepresentation in the uppermost
23	achievement levels and in gifted and talented
24	programs;

1	"(D) overrepresentation among students
2	qualifying for special education programs;
3	"(E) underrepresentation in institutions of
4	higher education and among adults who have
5	completed 4 or more years of college.
6	"(6) The percentage of Native Hawaiian stu-
7	dents served by the State of Hawaii Department of
8	Education rose 30 percent from 1980 to 2008, and
9	there are and will continue to be geographically
10	rural, isolated areas with a high Native Hawaiian
11	population density.
12	"(7) The Native Hawaiian people are deter-
13	mined to preserve, develop, and transmit to future
14	generations their ancestral territory and their cul-
15	tural identity in accordance with their own spiritual
16	and traditional beliefs, customs, practices, language,
17	and social institutions.
18	"SEC. 5302. PURPOSES.
19	"The purposes of this part are—
20	"(1) to authorize, develop, implement, assess,
21	and evaluate innovative educational programs, Na-
22	tive Hawaiian language medium programs, Native
23	Hawaiian culture-based education programs, and
24	other education programs to improve the academic
25	achievement of Native Hawaiian students by meet-

1	ing their unique cultural and language needs in
2	order to help such students meet challenging State
3	student academic achievement standards;
4	"(2) to provide guidance to appropriate Fed-
5	eral, State, and local agencies to more effectively
6	and efficiently focus resources, including resources
7	made available under this part, on the development
8	and implementation of—
9	"(A) innovative educational programs for
10	Native Hawaiians;
11	"(B) rigorous and substantive Native Ha-
12	waiian language programs; and
13	"(C) Native Hawaiian culture-based edu-
14	cational programs; and
15	"(3) to create a system by which information
16	from programs funded under this part will be col-
17	lected, analyzed, evaluated, reported, and used in de-
18	cisionmaking activities regarding the types of grants
19	awarded under this part.
20	"SEC. 5303. NATIVE HAWAIIAN EDUCATION COUNCIL
21	GRANT.
22	"(a) Grant Authorized.—In order to better effec-
23	tuate the purposes of this part through the coordination
24	of educational and related services and programs available
25	to Native Hawaiians, including those programs that re-

1	ceive funding under this part, the Secretary shall award
2	a grant to an education council, as described under sub-
3	section (b).
4	"(b) Education Council.—
5	"(1) Eligibility.—To be eligible to receive the
6	grant under subsection (a), the council shall be an
7	education council (referred to in this section as the
8	'Education Council') that meets the requirements of
9	this subsection.
10	"(2) Composition.—The Education Council
11	shall consist of 15 members of whom—
12	"(A) one shall be the President of the Uni-
13	versity of Hawaii (or a designee);
14	"(B) one shall be the Governor of the
15	State of Hawaii (or a designee);
16	"(C) one shall be the Superintendent of
17	the State of Hawaii Department of Education
18	(or a designee);
19	"(D) one shall be the chairperson of the
20	Office of Hawaiian Affairs (or a designee);
21	"(E) one shall be the executive director of
22	Hawaii's Charter School Network (or a des-
23	ignee);
24	"(F) one shall be the chief executive officer
25	of the Kamehameha Schools (or a designee):

1	"(G) one shall be the Chief Executive Offi-
2	cer of the Queen Liliuokalani Trust (or a des-
3	ignee);
4	"(H) one shall be a member, selected by
5	the other members of the Education Council,
6	who represents a private grant-making entity;
7	"(I) one shall be the Mayor of the County
8	of Hawaii (or a designee);
9	"(J) one shall be the Mayor of Maui Coun-
10	ty (or a designee from the Island of Maui);
11	"(K) one shall be the Mayor of the County
12	of Kauai (or a designee);
13	"(L) one shall be appointed by the Mayor
14	of Maui County from the Island of either
15	Molokai or Lanai;
16	"(M) one shall be the Mayor of the City
17	and County of Honolulu (or a designee);
18	"(N) one shall be the chairperson of the
19	Hawaiian Homes Commission (or a designee);
20	and
21	"(O) one shall be the chairperson of the
22	Hawaii Workforce Development Council (or a
23	designee representing the private sector).
24	"(3) Requirements.—Any designee serving on
25	the Education Council shall demonstrate, as deter-

1	mined by the individual who appointed such designee
2	with input from the Native Hawaiian community,
3	not less than 5 years of experience as a consumer
4	or provider of Native Hawaiian education or cultural
5	activities, with traditional cultural experience given
6	due consideration.
7	"(4) Limitation.—A member (including a des-
8	ignee), while serving on the Education Council, shall
9	not be a recipient of grant funds that are awarded
10	under this part.
11	"(5) Term of members.—A member who is a
12	designee shall serve for a term of not more than 4
13	years.
14	"(6) Chair, vice chair.—
15	"(A) Selection.—The Education Council
16	shall select a Chair and a Vice Chair from
17	among the members of the Education Council.
18	"(B) TERM LIMITS.—The Chair and Vice
19	Chair shall each serve for a 2-year term.
20	"(7) Administrative provisions relating
21	TO EDUCATION COUNCIL.—The Education Council
22	shall meet at the call of the Chair of the Council,
23	or upon request by a majority of the members of the
24	Education Council, but in any event not less often
25	than every 120 days.

1	"(8) NO COMPENSATION.—None of the funds
2	made available through the grant may be used to
3	provide compensation to any member of the Edu-
4	cation Council or member of a working group estab-
5	lished by the Education Council, for functions de-
6	scribed in this section.
7	"(c) Use of Funds for Coordination Activi-
8	TIES.—The Education Council shall use funds made avail-
9	able through the grant to carry out each of the following
10	activities:
11	"(1) Providing advice about the coordination,
12	and serving as a clearinghouse for, the educational
13	and related services and programs available to Na-
14	tive Hawaiians, including the programs assisted
15	under this part.
16	"(2) Assessing the extent to which such services
17	and programs meet the needs of Native Hawaiians,
18	and collecting data on the status of Native Hawaiian
19	education.
20	"(3) Providing direction and guidance, through
21	the issuance of reports and recommendations, to ap-
22	propriate Federal, State, and local agencies in order
23	to focus and improve the use of resources, including
24	resources made available under this part, relating to

1	Native Hawaiian education, and serving, where ap-
2	propriate, in an advisory capacity.
3	"(4) Awarding grants, if such grants enable the
4	Education Council to carry out the activities de-
5	scribed in paragraphs (1) through (3).
6	"(5) Hiring an executive director who shall as-
7	sist in executing the duties and powers of the Edu-
8	cation Council, as described in subsection (d).
9	"(d) Use of Funds for Technical Assist-
10	ANCE.—The Education Council shall use funds made
11	available through the grant to—
12	"(1) provide technical assistance to Native Ha-
13	waiian organizations that are grantees or potential
14	grantees under this part;
15	"(2) obtain from such grantees information and
16	data regarding grants awarded under this part, in-
17	cluding information and data about—
18	"(A) the effectiveness of such grantees in
19	meeting the educational priorities established by
20	the Education Council, as described in para-
21	graph (6)(D), using metrics related to these
22	priorities; and
23	"(B) the effectiveness of such grantees in
24	carrying out any of the activities described in
25	section 5304(c) that are related to the specific

1	goals and purposes of each grantee's grant
2	project, using metrics related to these priorities;
3	"(3) assess and define the educational needs of
4	Native Hawaiians;
5	"(4) assess the programs and services available
6	to address the educational needs of Native Hawai-
7	ians;
8	"(5) assess and evaluate the individual and ag-
9	gregate impact achieved by grantees under this part
10	in improving Native Hawaiian educational perform-
11	ance and meeting the goals of this part, using
12	metrics related to these goals; and
13	"(6) prepare and submit to the Secretary, at
14	the end of each calendar year, an annual report that
15	contains—
16	"(A) a description of the activities of the
17	Education Council during the calendar year;
18	"(B) a description of significant barriers to
19	achieving the goals of this part;
20	"(C) a summary of each community con-
21	sultation session described in subsection (e);
22	and
23	"(D) recommendations to establish prior-
24	ities for funding under this part, based on an
25	assessment of—

1	"(i) the educational needs of Native
2	Hawaiians;
3	"(ii) programs and services available
4	to address such needs;
5	"(iii) the effectiveness of programs in
6	improving the educational performance of
7	Native Hawaiian students to help such stu-
8	dents meet challenging State student aca-
9	demic achievement standards; and
10	"(iv) priorities for funding in specific
11	geographic communities.
12	"(e) Use of Funds for Community Consulta-
13	TIONS.—The Education Council shall use funds made
14	available though the grant under subsection (a) to hold
15	not less than one community consultation each year on
16	each of the islands of Hawaii, Maui, Molokai, Lanai,
17	Oahu, and Kauai, at which—
18	``(1) not less than three members of the Edu-
19	cation Council shall be in attendance;
20	"(2) the Education Council shall gather com-
21	munity input regarding—
22	"(A) current grantees under this part, as
23	of the date of the consultation;
24	"(B) priorities and needs of Native Hawai-
25	ians; and

1	"(C) other Native Hawaiian education
2	issues; and
3	"(3) the Education Council shall report to the
4	community on the outcomes of the activities sup-
5	ported by grants awarded under this part.
6	"(f) Funding.—For each fiscal year, the Secretary
7	shall use the amount described in section 5305(d)(2), to
8	make a payment under the grant. Funds made available
9	through the grant shall remain available until expended.
10	"(g) Report.—Beginning not later than 2 years
11	after the date of enactment of the Student Success Act,
12	and for each subsequent year, the Secretary shall prepare
13	and submit to the Committee on Education and the Work-
14	force of the House of Representatives, and the Committee
15	on Indian Affairs and the Committee on Health, Edu-
16	cation, Labor, and Pensions of the Senate, a report that—
17	"(1) summarizes the annual reports of the Edu-
18	cation Council;
19	"(2) describes the allocation and use of funds
20	under this part and the information gathered since
21	the first annual report submitted by the Education
22	Council to the Secretary under this section; and
23	"(3) contains recommendations for changes in
24	Federal, State, and local policy to advance the pur-
25	poses of this part.

1	"SEC. 5304. GRANT PROGRAM AUTHORIZED.
2	"(a) Grants and Contracts.—In order to carry
3	out programs that meet the purposes of this part, the Sec-
4	retary is authorized to award grants to, or enter into con-
5	tracts with—
6	"(1) Native Hawaiian educational organiza-
7	tions;
8	"(2) Native Hawaiian community-based organi-
9	zations;
10	"(3) public and private nonprofit organizations,
11	agencies, and institutions with experience in devel-
12	oping or operating Native Hawaiian education and
13	workforce development programs or programs of in-
14	struction in the Native Hawaiian language;
15	"(4) charter schools; and
16	"(5) consortia of the organizations, agencies,
17	and institutions described in paragraphs (1) through
18	(4).
19	"(b) Priority.—In awarding grants and entering
20	into contracts under this part, the Secretary shall give pri-
21	ority to—
22	"(1) programs that meet the educational pri-

ority recommendations of the Education Council, as

described under section 5303(d)(6)(D);

1	"(2) the repair and renovation of public schools
2	that serve high concentrations of Native Hawaiian
3	students;
4	"(3) programs designed to improve the aca-
5	demic achievement of Native Hawaiian students by
6	meeting their unique cultural and language needs in
7	order to help such students meet challenging State
8	student academic achievement standards, including
9	activities relating to—
10	"(A) achieving competence in reading, lit-
11	eracy, mathematics, and science for students in
12	preschool through grade 3;
13	"(B) the educational needs of at-risk chil-
14	dren and youth;
15	"(C) professional development for teachers
16	and administrators;
17	"(D) the use of Native Hawaiian language
18	and preservation or reclamation of Native Ha-
19	waiian culture-based educational practices; and
20	"(E) other programs relating to the activi-
21	ties described in this part; and
22	"(4) programs in which a local educational
23	agency, institution of higher education, or a State
24	educational agency in partnership with a nonprofit
25	entity serving underserved communities within the

1	Native Hawaiian population apply for a grant or
2	contract under this part as part of a partnership or
3	consortium.
4	"(c) Authorized Activities.—Activities provided
5	through programs carried out under this part may in-
6	clude—
7	"(1) the development and maintenance of a
8	statewide Native Hawaiian early education and care
9	system to provide a continuum of high-quality early
10	learning services for Native Hawaiian children from
11	the prenatal period through the age of kindergarten
12	entry;
13	"(2) the operation of family-based education
14	centers that provide such services as—
15	"(A) early care and education programs
16	for Native Hawaiians; and
17	"(B) research on, and development and as-
18	sessment of, family-based, early childhood, and
19	preschool programs for Native Hawaiians;
20	"(3) activities that enhance beginning reading
21	and literacy in either the Hawaiian or the English
22	language among Native Hawaiian students in kin-
23	dergarten through grade 3 and assistance in ad-
24	dressing the distinct features of combined English

1	and Hawaiian literacy for Hawaiian speakers in
2	grades 5 and 6;
3	"(4) activities to meet the special needs of Na-
4	tive Hawaiian students with disabilities, including—
5	"(A) the identification of such students
6	and their needs;
7	"(B) the provision of support services to
8	the families of such students; and
9	"(C) other activities consistent with the re-
10	quirements of the Individuals with Disabilities
11	Education Act;
12	"(5) activities that address the special needs of
13	Native Hawaiian students who are gifted and tal-
14	ented, including—
15	"(A) educational, psychological, and devel-
16	opmental activities designed to assist in the
17	educational progress of such students; and
18	"(B) activities that involve the parents of
19	such students in a manner designed to assist in
20	the educational progress of such students;
21	"(6) the development of academic and voca-
22	tional curricula to address the needs of Native Ha-
23	waiian students, including curricula materials in the
24	Hawaiian language and mathematics and science

1	curricula that incorporate Native Hawaiian tradition
2	and culture;
3	"(7) professional development activities for edu-
4	cators, including—
5	"(A) the development of programs to pre-
6	pare prospective teachers to address the unique
7	needs of Native Hawaiian students within the
8	context of Native Hawaiian culture, language,
9	and traditions;
10	"(B) in-service programs to improve the
11	ability of teachers who teach in schools with
12	high concentrations of Native Hawaiian stu-
13	dents to meet the unique needs of such stu-
14	dents; and
15	"(C) the recruitment and preparation of
16	Native Hawaiians, and other individuals who
17	live in communities with a high concentration of
18	Native Hawaiians, to become teachers;
19	"(8) the operation of community-based learning
20	centers that address the needs of Native Hawaiian
21	students, parents, families, and communities
22	through the coordination of public and private pro-
23	grams and services, including—
24	"(A) early education programs;

1	"(B) before, after, and Summer school
2	programs, expanded learning time, or weekend
3	academies;
4	"(C) career and technical education pro-
5	grams; and
6	"(D) programs that recognize and support
7	the unique cultural and educational needs of
8	Native Hawaiian children, and incorporate ap-
9	propriately qualified Native Hawaiian elders
10	and seniors;
11	"(9) activities, including program co-location,
12	that ensure Native Hawaiian students graduate col-
13	lege and career ready including—
14	"(A) family literacy services;
15	"(B) counseling, guidance, and support
16	services for students; and
17	"(C) professional development activities de-
18	signed to help educators improve the college
19	and career readiness of Native Hawaiian stu-
20	dents;
21	"(10) research and data collection activities to
22	determine the educational status and needs of Na-
23	tive Hawaiian children and adults;
24	"(11) other research and evaluation activities
25	related to programs carried out under this part; and

1	"(12) other activities, consistent with the pur-
2	poses of this part, to meet the educational needs of
3	Native Hawaiian children and adults.
4	"(d) Additional Activities.—Notwithstanding
5	any other provision of this part, funds made available to
6	carry out this section as of the day before the date of en-
7	actment of the Student Success Act shall remain available
8	until expended. The Secretary shall use such funds to sup-
9	port the following:
10	"(1) The repair and renovation of public
11	schools that serve high concentrations of Native Ha-
12	waiian students.
13	"(2) The perpetuation of, and expansion of ac-
14	cess to, Hawaiian culture and history through digital
15	archives.
16	"(3) Informal education programs that connect
17	traditional Hawaiian knowledge, science, astronomy,
18	and the environment through State museums or
19	learning centers.
20	"(4) Public charter schools serving high con-
21	centrations of Native Hawaiian students.
22	"(e) Administrative Costs.—
23	"(1) IN GENERAL.—Except as provided in para-
24	graph (2), not more than 5 percent of funds pro-
25	vided to a recipient of a grant or contract under this

1	section for any fiscal year may be used for adminis-
2	trative purposes.
3	"(2) Exception.—The Secretary may waive
4	the requirement of paragraph (1) for a nonprofit en-
5	tity that receives funding under this section and
6	allow not more than 10 percent of funds provided to
7	such nonprofit entity under this section for any fis-
8	cal year to be used for administrative purposes.

22	"(C) Special rule.—If the local edu-
23	cational agency in which a child resides makes
24	a tuition or other payment for the free public
25	education of the child in a school located in an-

1	other school district, the Secretary shall, for the
2	purpose of this Act—
3	"(i) consider the child to be in attend-
4	ance at a school of the agency making the
5	payment; and
6	"(ii) not consider the child to be in at-
7	tendance at a school of the agency receiv-

17	"(3) Charter school.—The term 'charter
18	school' means a public school that—
19	"(A) in accordance with a specific State
20	statute authorizing the granting of charters to
21	schools, is exempt from significant State or
22	local rules that inhibit the flexible operation
23	and management of public schools, but not
24	from any rules relating to the other require-
25	ments of this paragraph;

1	"(B) is created by a developer as a public
2	school, or is adapted by a developer from an ex-
3	isting public school, and is operated under pub-
4	lic supervision and direction;
5	"(C) operates in pursuit of a specific set of
6	educational objectives determined by the
7	school's developer and agreed to by the author-
8	ized public chartering agency;
9	"(D) provides a program of elementary or
10	secondary education, or both;
11	"(E) is nonsectarian in its programs, ad-
12	missions policies, employment practices, and all
13	other operations, and is not affiliated with a
14	sectarian school or religious institution;
15	"(F) does not charge tuition;
16	"(G) complies with the Age Discrimination
17	Act of 1975, title VI of the Civil Rights Act of
18	1964, title IX of the Education Amendments of
19	1972, section 504 of the Rehabilitation Act of

22	abilities Act of 1990 (42 U.S.C. 12101 et seq.),
23	and section 444 of the General Education Pro-

3	"(H) is a school to which parents choose to
4	send their children, and admits students on the
5	basis of a lottery if more students apply for ad-
6	mission than can be accommodated, except that
7	in cases in which students who are enrolled in
8	a charter school affiliated (such as by sharing
9	a network) with another charter school, those
10	students may be automatically enrolled in the
11	next grade level at such other charter school, so
12	long as a lottery is used to fill seats created
13	through regular attrition in student enrollment;
14	"(I) agrees to comply with the same Fed-
15	eral and State audit requirements as do other
16	elementary schools and secondary schools in the
17	State, unless such State audit requirements are
18	waived by the State;
19	"(J) meets all applicable Federal, State,
20	and local health and safety requirements;
21	"(K) operates in accordance with State

16	"(6) Community-based organization.—The
17	term 'community-based organization' means a public
18	or private nonprofit organization of demonstrated ef-
19	fectiveness that—
20	"(A) is representative of a community or
21	significant segments of a community; and
22	"(B) provides educational or related serv-
23	ices to individuals in the community.
24	"(7) Consolidated local application.—
25	The term 'consolidated local application' means an

1	application submitted by a local educational agency

3	"(8) CONSOLIDATED LOCAL PLAN.—The term
4	'consolidated local plan' means a plan submitted by

8	application submitted by a State educational agency
9	pursuant to section 6302.
10	"(10) CONSOLIDATED STATE PLAN.—The term
11	'consolidated State plan' means a plan submitted by
12	a State educational agency pursuant to section
13	6302.
14	"(11) Core academic subjects.—The term
15	'core academic subjects' means English, reading or
16	language arts, mathematics, science, foreign lan-
17	guages, civics and government, economics, arts, his-
18	tory, and geography.
19	"(12) County.—The term 'county' means one
20	of the divisions of a State used by the Secretary of
21	Commerce in compiling and reporting data regard-
22	ing counties.
23	"(13) COVERED PROGRAM.—The term 'covered
24	program' means each of the programs authorized
25	by—

24	tance education' means the use of one or more tech-

5	cational agency' means a public board of edu-
6	cation or other public authority legally con-
7	stituted within a State for either administrative
8	control or direction of, or to perform a service
9	function for, public elementary schools or sec-
10	ondary schools in a city, county, township,
11	school district, or other political subdivision of
12	a State, or of or for a combination of school
13	districts or counties that is recognized in a
14	State as an administrative agency for its public

24	means specialized instructional support personnel, li-
25	brarians, career guidance and counseling personnel,

1	education aides, and other instructional and admin-
2	istrative personnel.
3	"(32) Outlying Area.—The term 'outlying
4	area'—
5	"(A) means American Samoa, the Com-
6	monwealth of the Northern Mariana Islands,
7	Guam, and the United States Virgin Islands;
8	"(B) means the Republic of Palau, to the
9	extent permitted under section $105(f)(1)(B)(ix)$
10	of the Compact of Free Association Amend-
11	ments Act of 2003 (Public Law 99–658; 117
12	Stat. 2751) and until an agreement for the ex-
13	tension of United States education assistance
14	under the Compact of Free Association becomes
15	effective for the Republic of Palau; and
16	"(C) for the purpose of any discretionary
17	grant program under this Act, includes the Re-
18	public of the Marshall Islands and the Fed-
19	erated States of Micronesia, to the extent per-
20	mitted under section $105(f)(1)(B)(viii)$ of the
21	Compact of Free Association Amendments Act
22	of 2003 (Public Law 108–188; 117 Stat.
23	2751).
24	"(33) Parent.—The term 'parent' includes a
25	legal guardian or other person standing in loco

1	parentis (such as a grandparent, stepparent, or fos-
2	ter parent with whom the child lives, or a person
3	who is legally responsible for the child's welfare).
4	"(34) Parental involvement.—The term
5	'parental involvement' means the participation of
6	parents in regular, two-way, and meaningful commu-
7	nication involving student academic learning and
8	other school activities, including ensuring—
9	"(A) that parents play an integral role in
10	assisting in their child's learning;
11	"(B) that parents are encouraged to be ac-
12	tively involved in their child's education at
13	school;
14	"(C) that parents are full partners in their
15	child's education and are included, as appro-
16	priate, in decisionmaking and on advisory com-
17	mittees to assist in the education of their child;
18	and
19	"(D) the carrying out of other activities,
20	such as those described in section 1118.
21	"(35) POVERTY LINE.—The term 'poverty line'
22	means the poverty line (as defined by the Office of
23	Management and Budget and revised annually in ac-

2	the size involved.
3	"(36) Professional Development.—The
4	term 'professional development'—
5	"(A) includes evidence-based, job-embed-
6	ded, continuous activities that—
7	"(i) improve and increase teachers"
8	knowledge of the academic subjects the
9	teachers teach, and enable teachers to be-
10	come effective educators;
11	"(ii) are an integral part of broad
12	schoolwide and districtwide educational im-
13	provement plans;
14	"(iii) give teachers, school leaders,
15	other staff, and administrators the knowl-
16	edge and skills to provide students with
17	the opportunity to meet State academic
18	standards;
19	"(iv) improve classroom management
20	skills;
21	"(v)(I) have a positive and lasting im-
22	pact on classroom instruction and the
23	teacher's performance in the classroom;
24	and

1	"(II) are not 1-day or short-term
2	workshops or conferences;
3	"(vi) support the recruiting, hiring,

5	teachers who became certified or licensed

10	"(xi) to the extent appropriate, pro-
11	vide training for teachers, other staff, and
12	school leaders in the use of technology so
13	that technology and technology applica-
14	tions are effectively used to improve teach-
15	ing and learning in the curricula and core
16	academic subjects in which the students re-
17	ceive instruction;
18	"(xii) as a whole, are regularly evalu-
19	ated for their impact on increased teacher
20	effectiveness and improved student aca-
21	demic achievement, with the findings of
22	the evaluations used to improve the quality
23	of the professional development;
24	"(xiii) provide instruction in methods
25	of teaching children with special needs;

1	"(xiv) include instruction in the use of
2	data and assessments to inform and in-
3	struct classroom practice; and
4	"(xv) include instruction in ways that
5	teachers, school leaders, specialized in-
6	structional support personnel, other staff,
7	and school administrators may work more
8	effectively with parents; and
9	"(B) may include evidence-based, job-em-
10	bedded, continuous activities that—
11	"(i) involve the forming of partner-
12	ships with institutions of higher education
13	to establish school-based teacher training
14	programs that provide prospective teachers
15	and new teachers with an opportunity to
16	work under the guidance of experienced
17	teachers and college faculty;
18	"(ii) create programs to enable para-
19	professionals (assisting teachers employed
20	by a local educational agency receiving as-
21	sistance under subpart 1 of part A of title
22	I) to obtain the education necessary for
23	those paraprofessionals to become certified
24	and licensed teachers; and

1	"(iii) provide follow-up training to in-
2	dividuals who have participated in activi-
3	ties described in subparagraph (A) or an-
4	other clause of this subparagraph that are
5	designed to ensure that the knowledge and
6	skills learned by the teachers are imple-
7	mented in the classroom.
8	"(37) Regular high school diploma.—
9	"(A) IN GENERAL.—The term 'regular
10	high school diploma' means the standard high
11	school diploma awarded to the preponderance of
12	students in the State that is fully aligned with
13	State standards, or a higher diploma. Such
14	term shall not include a GED or other recog-
15	nized equivalent of a diploma, a certificate of
16	attendance, or any lesser diploma award.
17	"(B) Exception for students with
18	SIGNIFICANT COGNITIVE DISABILITIES.—For a
19	student who is assessed using an alternate as-
20	sessment aligned to alternate academic stand-
21	ards under section 1111(b)(1)(D), receipt of a
22	regular high school diploma as defined under

7	leader' means a principal, assistant principal, or

10	local educational agency, or other entity oper-
11	ating the school; and
12	"(B) responsible for—
13	"(i) the daily instructional leadership
14	and managerial operations of the school;
15	and
16	"(ii) creating the optimum conditions
17	for student learning.
18	"(39) Secondary school.—The term 'sec-
19	ondary school' means a nonprofit institutional day or
20	residential school, including a public secondary char-
21	ter school, that provides secondary education, as de-
22	termined under State law, except that the term does
23	not include any education beyond grade 12.
24	"(40) Secretary.—The term 'Secretary'
25	means the Secretary of Education.

1	"(41) Specialized instructional support
2	PERSONNEL; SPECIALIZED INSTRUCTIONAL SUPPORT
3	SERVICES.—
4	"(A) SPECIALIZED INSTRUCTIONAL SUP-
5	PORT PERSONNEL.—The term 'specialized in-
6	structional support personnel' means school
7	counselors, school social workers, school psy-
8	chologists, and other qualified professional per-
9	sonnel involved in providing assessment, diag-
10	nosis, counseling, educational, therapeutic, and
11	other necessary services (including related serv-
12	ices as that term is defined in section 602 of
13	the Individuals with Disabilities Education Act)
14	as part of a comprehensive program to meet
15	student needs.
16	"(B) Specialized instructional sup-
17	PORT SERVICES.—The term 'specialized instruc-
18	tional support services' means the services pro-
19	vided by specialized instructional support per-
20	sonnel.
21	"(42) State.—The term 'State' means each of
22	the 50 States, the District of Columbia, the Com-
23	monwealth of Puerto Rico, and each of the outlying
24	areas.

1	"(43) State Educational Agency.—The
2	term 'State educational agency' means the agency
3	primarily responsible for the State supervision of
4	public elementary schools and secondary schools.
5	"(44) Technology.—The term 'technology'
6	means modern information, computer and commu-
7	nication technology products, services, or tools, in-
8	cluding, but not limited to, the Internet and other
9	communications networks, computer devices and
10	other computer and communications hardware, soft-
11	ware applications, data systems, and other electronic
12	content and data storage.
13	"SEC. 6102. APPLICABILITY OF TITLE.
14	"Parts B, C, D, and E of this title do not apply to
15	title IV of this Act.
16	"SEC. 6103. APPLICABILITY TO BUREAU OF INDIAN EDU-
17	CATION OPERATED SCHOOLS.
18	"For the purpose of any competitive program under
19	this Act—
20	"(1) a consortium of schools operated by the
21	Bureau of Indian Education;
22	"(2) a school operated under a contract or
23	grant with the Bureau of Indian Education in con-
24	sortium with another contract or grant school or a

22	Department.
23	"(c) Records.—A State educational agency that
24	consolidates administrative funds under this section shall
25	not be required to keep separate records, by individual

- 1 program, to account for costs relating to the administra-
- 2 tion of programs included in the consolidation under sub-
- 3 section (a).
- 4 "(d) Review.—To determine the effectiveness of
- 5 State administration under this section, the Secretary may
- 6 periodically review the performance of State educational
- 7 agencies in using consolidated administrative funds under
- 8 this section and take such steps as the Secretary finds
- 9 appropriate to ensure the effectiveness of that administra-
- 10 tion.
- 11 "(e) Unused Administrative Funds.—If a State

- 17 "(f) Consolidation of Funds for Standards
- 18 AND ASSESSMENT DEVELOPMENT.—In order to develop
- 19 State academic standards and assessments, a State edu-
- 20 cational agency may consolidate the amounts described in
- 21 subsection (a) for those purposes under title I.
- 22 "SEC. 6202. SINGLE LOCAL EDUCATIONAL AGENCY STATES.
- "A State educational agency that also serves as a
- 24 local educational agency shall, in its applications or plans

- 1 under this Act, describe how the agency will eliminate du-
- 2 plication in conducting administrative functions.
- 3 "SEC. 6203. CONSOLIDATION OF FUNDS FOR LOCAL ADMIN-
- 4 **ISTRATION.**
- 5 "(a) GENERAL AUTHORITY.— In accordance with
- 6 regulations of the Secretary and for any fiscal year, a local

14	"SEC. 6204. CONSOLIDATED SET-ASIDE FOR DEPARTMENT
15	OF THE INTERIOR FUNDS.
16	"(a) General Authority.—
17	"(1) Transfer.—The Secretary shall transfer
18	to the Department of the Interior, as a consolidated

1	"(1) to improve teaching and learning by en-
2	couraging greater cross-program coordination, plan-
3	ning, and service delivery;
4	"(2) to provide greater flexibility to State and
5	local authorities through consolidated plans, applica-
6	tions, and reporting; and
7	"(3) to enhance the integration of programs
8	under this Act with State and local programs.
9	"SEC. 6302. OPTIONAL CONSOLIDATED STATE PLANS OR
10	APPLICATIONS.

12	"(1) SIMPLIFICATION.—In order to simplify ap-
13	plication requirements and reduce the burden for
14	State educational agencies under this Act, the Sec-

10	"(b) Collaboration.—
11	"(1) In general.—In establishing criteria and
12	procedures under this section, the Secretary shall
13	collaborate with State educational agencies and, as
14	appropriate, with other State agencies, local edu-
15	cational agencies, public and private agencies, orga-
16	nizations, and institutions, private schools, and par-
17	ents, students, and teachers.
18	"(2) Contents.—Through the collaborative
19	process described in paragraph (1), the Secretary
20	shall establish, for each program under this Act to
21	which this section applies, the descriptions, informa-
22	tion, assurances, and other material required to be
23	included in a consolidated State plan or consolidated
24	State application.

1	"(3) Necessary materials.—The Secretary
2	shall require only descriptions, information, assur-
3	ances (including assurances of compliance with ap-
4	plicable provisions regarding participation by private
5	school children and teachers), and other materials
6	that are absolutely necessary for the consideration of
7	the consolidated State plan or consolidated State ap-
8	plication.
9	"SEC. 6303. CONSOLIDATED REPORTING.
10	"(a) In General.—In order to simplify reporting re-
11	quirements and reduce reporting burdens, the Secretary
12	shall establish procedures and criteria under which a State
13	educational agency, in consultation with the Governor of
14	the State, may submit a consolidated State annual report
15	"(b) Contents.—The report shall contain informa-
16	tion about the programs included in the report, including
17	the performance of the State under those programs, and
18	other matters as the Secretary determines are necessary,
19	such as monitoring activities.
20	"(c) Replacement.—The report shall replace sepa-
21	rate individual annual reports for the programs included
22	in the consolidated State annual report.

1	"SEC. 6304. GENERAL APPLICABILITY OF STATE EDU-
2	CATIONAL AGENCY ASSURANCES.
3	"(a) Assurances.—A State educational agency, in
4	consultation with the Governor of the State, that submits
5	a consolidated State plan or consolidated State application

24	ods of administering each such program, including—
25	"(A) the enforcement of any obligations
26	imposed by law on agencies, institutions, orga-

1	nizations, and other recipients responsible for
2	carrying out each program;
3	"(B) the correction of deficiencies in pro-
4	gram operations that are identified through au-
5	dits, monitoring, or evaluation; and
6	"(C) the adoption of written procedures for
7	the receipt and resolution of complaints alleging
8	violations of law in the administration of the
9	programs;
10	"(4) the State will cooperate in carrying out
11	any evaluation of each such program conducted by
12	or for the Secretary or other Federal officials;
13	"(5) the State will use such fiscal control and
14	fund accounting procedures that will ensure proper
15	disbursement of, and accounting for, Federal funds
16	paid to the State under each such program;
17	"(6) the State will—
18	"(A) make reports to the Secretary as may
19	be necessary to enable the Secretary to perform
20	the Secretary's duties under each such pro-
21	gram; and
22	"(B) maintain such records, provide such
23	information to the Secretary, and afford such
24	access to the records as the Secretary may find

1	necessary to carry out the Secretary's duties;
2	and
3	"(7) before the plan or application was sub-
4	mitted to the Secretary, the State afforded a reason-
5	able opportunity for public comment on the plan or
6	application and considered such comment.
7	"(b) GEPA Provision.—Section 441 of the General
8	Education Provisions Act shall not apply to programs
9	under this Act.
10	"SEC. 6305. CONSOLIDATED LOCAL PLANS OR APPLICA-
11	TIONS.
12	"(a) General Authority.—
13	"(1) CONSOLIDATED PLAN.—A local edu-
14	cational agency receiving funds under more than one
15	covered program may submit plans or applications
16	to the State educational agency under those pro-
17	grams on a consolidated basis.
18	"(2) AVAILABILITY TO GOVERNOR.—The State
19	educational agency shall make any consolidated local
20	plans and applications available to the Governor.
21	"(b) Required Consolidated Plans or Applica-
22	TIONS.—A State educational agency that has an approved
23	consolidated State plan or application under section 6302
24	may require local educational agencies in the State receiv-
25	ing funds under more than one program included in the

- 1 consolidated State plan or consolidated State application
- 2 to submit consolidated local plans or applications under
- 3 those programs, but may not require those agencies to
- 4 submit separate plans.
- 5 "(c) Collaboration.—A State educational agency,
- 6 in consultation with the Governor, shall collaborate with
- 7 local educational agencies in the State in establishing pro-
- 8 cedures for the submission of the consolidated State plans
- 9 or consolidated State applications under this section.
- 10 "(d) Necessary Materials.—The State edu-
- 11 cational agency shall require only descriptions, informa-
- 12 tion, assurances, and other material that are absolutely
- 13 necessary for the consideration of the local educational
- 14 agency plan or application.
- 15 "SEC. 6306. OTHER GENERAL ASSURANCES.
- 16 "(a) Assurances.—Any applicant, other than a
- 17 State educational agency that submits a plan or applica-
- 18 tion under this Act, shall have on file with the State edu-
- 19 cational agency a single set of assurances, applicable to
- 20 each program for which a plan or application is submitted,
- 21 that provides that—
- "(1) each such program will be administered in
- accordance with all applicable statutes, regulations,
- program plans, and applications;

1	"(2)(A) the control of funds provided under
2	each such program and title to property acquired
3	with program funds will be in a public agency or in
4	an eligible private agency, institution, organization,
5	or Indian tribe, if the law authorizing the program
6	provides for assistance to those entities; and
7	"(B) the public agency, eligible private agency,
8	institution, or organization, or Indian tribe will ad-
9	minister the funds and property to the extent re-
10	quired by the authorizing statutes;
11	"(3) the applicant will adopt and use proper
12	methods of administering each such program, in-
13	cluding—
14	"(A) the enforcement of any obligations
15	imposed by law on agencies, institutions, orga-
16	nizations, and other recipients responsible for
17	carrying out each program; and
18	"(B) the correction of deficiencies in pro-
19	gram operations that are identified through au-
20	dits, monitoring, or evaluation;
21	"(4) the applicant will cooperate in carrying out
22	any evaluation of each such program conducted by
23	or for the State educational agency, the Secretary,
24	or other Federal officials;

1	"(5) the applicant will use such fiscal control
2	and fund accounting procedures as will ensure prop-
3	er disbursement of, and accounting for, Federal
4	funds paid to the applicant under each such pro-
5	gram;
6	"(6) the applicant will—
7	"(A) submit such reports to the State edu-
8	cational agency (which shall make the reports
9	available to the Governor) and the Secretary as
10	the State educational agency and Secretary may
11	require to enable the State educational agency
12	and the Secretary to perform their duties under
13	each such program; and
14	"(B) maintain such records, provide such
15	information, and afford such access to the
16	records as the State educational agency (after
17	consultation with the Governor) or the Sec-
18	retary may reasonably require to carry out the
19	State educational agency's or the Secretary's
20	duties; and
21	"(7) before the application was submitted, the
22	applicant afforded a reasonable opportunity for pub-
23	lic comment on the application and considered such
24	comment.

1	"(b) GEPA Provision.—Section 442 of the General
2	Education Provisions Act shall not apply to programs
3	under this Act.
4	"PART D—WAIVERS
5	"SEC. 6401. WAIVERS OF STATUTORY AND REGULATORY RE-
6	QUIREMENTS.
7	"(a) In General.—
8	"(1) Request for Waiver.—A State edu-
9	cational agency, local educational agency, or Indian
10	tribe that receives funds under a program authorized
11	under this Act may submit a request to the Sec-
12	retary to waive any statutory or regulatory require-
13	ment of this Act.
14	"(2) Receipt of Waiver.—Except as provided
15	in subsection (c) and subject to the limits in sub-
16	section (b)(5)(A), the Secretary shall waive any stat-
17	utory or regulatory requirement of this Act for a
18	State educational agency, local educational agency,
19	Indian tribe, or school (through a local educational
20	agency), that submits a waiver request pursuant to
21	this subsection.
22	"(b) Plan.—
23	"(1) In general.—A State educational agen-
24	cy, local educational agency, or Indian tribe that de-
25	sires a waiver under this section shall submit a waiv-

1	er request to the Secretary, which shall include a
2	plan that—
3	"(A) identifies the Federal programs af-
4	fected by the requested waiver;
5	"(B) describes which Federal statutory or
6	regulatory requirements are to be waived;
7	"(C) reasonably demonstrates that the
8	waiver will improve instruction for students and
9	advance student academic achievement;
10	"(D) describes the methods the State edu-
11	cational agency, local educational agency, or In-
12	dian tribe will use to monitor the effectiveness
13	of the implementation of the plan; and
14	"(E) describes how schools will continue to
15	provide assistance to the same populations
16	served by programs for which the waiver is re-
17	quested.
18	"(2) Additional information.—A waiver re-
19	quest under this section—
20	"(A) may provide for waivers of require-
21	ments applicable to State educational agencies,
22	local educational agencies, Indian tribes, and
23	schools; and
24	"(B) shall be developed and submitted—

1	"(i)(I) by local educational agencies
2	(on behalf of those agencies and schools)
3	to State educational agencies; and
4	"(II) by State educational agencies
5	(on their own behalf, or on behalf of, and
6	based on the requests of, local educational
7	agencies in the State) to the Secretary; or
8	"(ii) by Indian tribes (on behalf of
9	schools operated by the tribes) to the Sec-
10	retary.
11	"(3) General requirements.—
12	"(A) STATE EDUCATIONAL AGENCIES.—In
13	the case of a waiver request submitted by a
14	State educational agency acting on its own be-
15	half, or on behalf of local educational agencies
16	in the State, the State educational agency
17	shall—
18	"(i) provide the public and local edu-
19	cational agencies in the State with notice
20	and a reasonable opportunity to comment
21	and provide input on the request;
22	"(ii) submit the comments and input
23	to the Secretary, with a description of how
24	the State addressed the comments and
25	input; and

1	"(iii) provide notice and a reasonable
2	time to comment to the public and local
3	educational agencies in the manner in
4	which the applying agency customarily pro-
5	vides similar notice and opportunity to
6	comment to the public.
7	"(B) Local educational agencies.—In
8	the case of a waiver request submitted by a
9	local educational agency that receives funds
10	under this Act—
11	"(i) the request shall be reviewed by
12	the State educational agency and be ac-
13	companied by the comments, if any, of the
14	State educational agency and the public;
15	and
16	"(ii) notice and a reasonable oppor-
17	tunity to comment regarding the waiver re-
18	quest shall be provided to the State edu-
19	cational agency and the public by the agen-

8	TITLE VIII—MISCELLANEOUS
9	PROVISIONS
10	SEC. 801. FINDINGS; SENSE OF THE CONGRESS.
11	(a) FINDINGS.—The Congress finds as follows:
12	(1) To avoid negative attention and litigation,
13	some local educational agencies have entered into
14	agreements with employees who are suspected of
15	abusing or are known to have abused students.
16	(2) Instead of reporting sexual misconduct with
17	minors to the proper authorities such as the police
18	or child welfare services, under such agreements the
19	local educational agencies, schools, and employees
20	keep the information private and facilitate the em-
21	ployee's transfer to another local educational agency.
22	(b) Sense of the Congress.—It is the sense of
23	the Congress that—
24	(1) confidentiality agreements between local
25	educational agencies or schools and suspected child
26	sex abusers should be prohibited;

1	(2) the practice of employee transfers after sus-
2	pected or proven sexual misconduct should be
3	stopped, and States should require local educational
4	agencies and schools to provide law enforcement
5	with all information regarding sexual conduct be-
6	tween an employee and a minor; and
7	(3) Congress should help protect children and
8	help stop this unacceptable practice in our schools.
